# ACTON, William, of Chevening, yeoman

1804 Bought Stonelake Farm from Frances Hodsden of Bradford. The farm included the outlying Crutchfield.

c.1810 Sold Stonelake Farm to Elizabeth and Edward Leigh and Crutchfield to Henry Streatfeild.

# **ACTON**, William, junior

1809-1821 Occupied Piggotts Farm with Lower Winkhurst Farm in Sundridge and Chiddingstone, tenant of James Hodsoll. He was not junior after 1815.

1818 He was paid £5-13s-6d for the rent of James Saunders together with supplying some wood.

1819 He was paid £1-2s for James Saunders's rent and for carriage of his goods.

1821 Unable to pay his rates £1-18s-10d.

1821 Sale of the stock and equipment of William Acton of Winkhurst Green Farm, bankrupt. (Maidstone Journal).

# ADAMS, widow

On relief from at least 1783 with her family, particularly daughter Mary. She died in November 1789 but was not buried in Chiddingstone.

1814 Examination. Born in East Grinstead. In 1806-1808 hired herself to Mr Anscomb of Tandridge, farmer. Now pregnant with a bastard. Chargeable to Chiddingstone. Ordered to Tandridge.

1815 Further examination. At age 15 hired herself to Mr Richard Burden of Lingfield, farmer. Then to Mr Richard Doubell of the Moor in Lingfield. Then to Mr Upton, farmer, in Edenbridge. Then to Mr John Chapman, farmer, in Hartfield. Then to Mr Robert Bristow, butcher, of Lingfield. Ordered to Lingfield. 1818 3s relief paid to her child.

#### **ALEXANDER, Mr**

1821 The parish paid him £3-6s as half year's rent for William Smeed junior.

#### **ALLIN, Mary**

1798 A traveller belonging to Marshfield, Gloucestershire. Base son John.

# ALLNUT, Richard, esq.

1782-1794 Owned a small property (15s) in Chiddingstone South, occupied by James Jenner.

# **ALLNUT, James**

1813 Witnessed marriage of John Hartrup West of Tonbridge widower and Maria Woodgate.

# **ALLOTT, Thomas**

1802 Married Rebecca Skilton. Witnesses: William Carpenter, John Fuller.

#### ANDERSON, Abraham, labourer

1785 Employed by Mr Russell of Vexore and lived in a cottage nearby. Dishonestly obtained flour without paying from the mill of Richard Keeys. Sentenced to imprisonment (Quarter Sessions).

# ANDREWS, John, farmer. Wife Amy. Also ANDERS

1814 Son John.

1815-1818 Occupied Bore Place North, tenant of Hyde.

1815 Employed Richard King for a year.

1816 Son Israel (ANDERS).

1818 Supplied turnips to the workhouse £1-18s-7d. Sent in a bill to the overseers for £5-17s.

1819 Barley for the workhouse 7s.

1818 He was paid £3-18s for keeping a boy and a girl. 1819 He was paid £2-10s for keeping two boys for 28 weeks.

1818 In arrears with his rates £9-10s.

# APPZOLD, Hannah, traveller

1798 Base daughter Harriet by her partner Thomas Hunt.

# ARNOLD, James, of Horley, travelling chair mender. Wife Mary. See Hever and Edenbridge

1816 Son Francis.

1818 Described as a traveller, 10s relief for him and 1s for his child.

### ARNOLD, Harriot

1817 Married William Hook. Witnesses: James Denton, Ann Longley.

1778 (of Lewsom). For certain lands late John Hollamby's and for other lands late Hollamby's (Sundridge Weald 1s). For the Kiln Farm occupied by Thomas Hollamby (3d). 1780-1806 Owned Kiln House Farm (sometimes Mrs Attwood).

1804 Will of Richard Atwood gent of St James, Bath (PCC). Is this him?

1806 Heirs of Richard Attwood for certain lands (as above) and for the Kiln Farm, occupied by Thomas Hollamby.

#### **AUSTEN, Elizabeth**

1791 (pauper) Base daughter Ann.

1793 (pauper) Base son William.

1793 Imprisoned for being a loose, idle and disorderly person and refusing to declare the name of the father of her youngest child born a bastard and chargeable to Chiddingstone (Quarter Sessions).

#### **AUSTEN, Ann**

1803 Death.

#### **AUSTEN, Susanna, widow**

1813 Removal from Speldhurst to Childdingstone quashed (Quarter Sessions).

# AUSTEN, John, labourer, bricklayer. Also known as John Mills. Wife Elizabeth. He was born in 1784, his wife in 1783

1807 Adjudged to be the father of a male bastard son born to Elizabeth Maynard.

1808 Son William, not baptized in Chiddingstone.

1810 Son George, not baptized in Chiddingstone.

1810 Charged with not supporting his wife and child and with spending his money in alehouses so that they are chargeable to the parish of Edenbridge. Sentenced to a fortnight in prison.

1810 John Austen, Elizabeth and two children William (2) and a male not yet baptized removed from Cowden to Chiddingstone. (Quarter Sessions). As Elizabeth was ill she was not to be moved until recovered.

1812 Daughter Eliza, not baptized in Chiddingstone.

1815 Stole timber from a house being rebuilt in Cowden occupied by Obediah Woodhams [Bassett's Mil]). Stole two oak posts from John Woodgate. They were thrown over the hedge dividing his premises from those of Thomas Scott. Other pieces of sawed timber were found concealed in his house. Sentenced to 16 months imprisonment. (Quarter Sessions)

1815 He lived at TA 152, described as cottage and garden, Hoath.

1818-19 Substantial relief, described as out of work. Supplied with faggots. Paid for labouring on the roads. Some relief in 1821.

1818 Mrs Barnett was paid 6s for laying his wife. Baptism of his daughter Harriet. Widow West was paid 5s for nursing John Austen's wife. (continued)

# AUSTEN, Francis Motley, solicitor See Edenbridge

1806 Owned a messuage and several parcels of land thereto belonging called Theobalds als Slaiters at the Ivyhouse, late the heirs of Savile Hyde, gent (Sundridge Upland 11s 11½d). [This seems to have been a temporary measure].

1818 He was paid one year's rent for William Jenner £5-4s.

1812 Examination. Residing in Chiddingstone. Born in Withyham. In 1805 hired himself to Thomas Ovenden of Withyham farmer. Married Sarah in 1812. Ordered to Withyham.

### AVIS, John, yeoman Wife Ann. He was born in 1757, she in 1755

1780-1836 Owned Blackbaldrock Farm and also occupied it from 1797. He also owned Roses Farm from 1780 to 1805 and occupied it in 1788. In Roses he was followed by Thomas and then Peter Avis.

1818, 1819 He failed to pay his rates £3-10s. 1821 ditto £4-2s-6d. (*continued*)

Succeeded by his four sons subject to the dower of his widow Jane. 1794 Death of Jane Aynscombe, widow, aged 71. She owned Haycroft and Little Millbrook which descended to her four sons William, David, John and James. 1814 William, John and James had surrendered their shares to their brother David. The land was occupied by James Aynscomb (Tyhurst manor).
