BISHOP, Hilary

1796 Accused of carrying two casks of spirits on a footpath near Bow Beech. Beat up John Chandler, Excise Officer, when he attempted to arrest him.

BLACKWELL, James, bricklayer. Wife Elizabeth (Leigh)

1782-1794 Occupied Hill Hoath House, tenant of Henry Streatfeild.

1785 Death of wife Elizabeth (11th June) and baptism of daughter Elizabeth (1st June).

1785 He was paid £5-3s-4d for work done at the workhouse, and £1-14s-19d for work done at the almshouse at the Causeway.

1786 Work done at the workhouse £2-18s-6d.

1786-96 Various similar bills paid by the parish.

1793 Parish paid James Blackwell his borsholder's fee for Frienden borough.

1797 Death. 1798 Will (PS). Left his estate to his daughter Elizabeth.

Brothers-in-law John Leigh, Edward Leigh and Edward Mitchell to act as trustees. Witness William Taylor, Benjamin Humphrey.

BLACKWELL, Susanna

1800 Death.

BLAKE, Kit

1788 Of Wallingham, aged 20. Employed at Hoath Farm by John Kingsmore, but discharged. Accused of stealing a horse (Maidstone Journal)

BLUNDELL, Thomas

1820-21 Occupied Chittenden, tenant of Cator.

1821 Unable to pay his rates £11-12s-6d.

1821 Parish paid him the rent for Joseph Warren £5 a year.

BOAKES, Widow

1786 Death.

BOAKES, John, farmer. Wife Elizabeth See Hever

1745 -1809 Occupied Sharpes Place.

1787 Received £7 from the will of his relative Mary Boakes, widow.

1787 Supplied two bushels of peas to Oliver (pauper).

1788-90 Churchwarden. He was paid 7s 6d for a journey to Tonbridge.

1789 Supplied 50 faggots to John Hills (pauper)

1793 Parish paid him for keeping Edward Billings.

1802 Had sold wheat to Richard Shoebridge.

1802-03 Supplied 867 faggots to the workhouse.

1806 Death of Elizabeth, aged 70.

1808 Supplied 25 faggots to Thomas Smither 14s.

1809. Death, aged 87 (monument). Will (PCC) Succeeded as the tenant of Sharpes Place by Richard Boakes.

To daughter Rachel, wife of William Geal, £4W

To the children of his daughter [Mary], late wife of Richard Wood, namely Elizabeth Wood, William Wood, Sarah Wood, Jesse Wood and Martha Wood (?£20 each) at age 21.

To the children of his son Benjamin Boakes namely Benjamin and James £20 each at age 21.

To grandson John Woodhams son of his daughter Jane £80.

To son John £300.

To son Richard the residue of his effects, farming utensils, horses, cows, money, household goods, etc.

- 1788 Relief 4s 6d.
- 1789 Witnessed will of Thomas Bellingham of Little Brownings.
- 1796 Death.

BOAKES, Benjamin, born 1757, son of John and Elizabeth Boakes Wife Mary (see Hever)

- 1787 Married Mary Gibb in Hever.
- 1791 Death.
- 1809 John Boakes left Benjamin's children, Benjamin and James, £20 each.

BOAKES, Richard, born 1761, son of John and Elizabeth Boakes, above.

- 1808 His father left him the residue of his estate, including farming stock.
- 1809-17 Occupied Sharpes Place in succession to his father.
- 1812 Overseer of Chiddingstone parish
- 1813 Surveyor of Chiddingstone North. Also 1814 but replaced by George Wood of Hever.
- 1817 Fell behind with his rates £14.
- 1818 Sold wood and faggots to the workhouse £5-7s

BOAKES, Richard. Wife Elizabeth

- 1812 (junior) Married Elizabeth Brooker. Witness: Thomas Boakes.
- 1812 (junior) Son Thomas.
- 1818-21 (junior) Substantial relief. Parish paid his rent. Mr Cook supplied him with faggots.
- 1819-21 Chiddingstone paid his poor assessment for property in Sevenoaks parish £1-6s-6d, 9s.

BOAKES, Jane, born 1768, daughter of John and Elizabeth Boakes (above)

- 1787 Witnessed marriage of Thomas Driver and Beedy Boakes.
- 1788 Base son John Woodhams. Presumably the father was John Woodhams.
- 1789 Death of a Jane Boakes. [Let us assume that this is a different Jane Boakes]

Residue to son Thomas whom she had not heard of for a considerable time.

BOAKES, James, labourer. Wife Frances See Hever

1816 Examination. Now resident in Hever. Born in Hever. In 1811-1813 employed by Mr Edward Leigh of Chiddingstone, butcher and farmer at £11.a year, until Mr Leigh moved to Leigh(!) and moved with him. In 1813 married Frances. Child Maria aged 2. Ordered to Leigh.
