BOSTOCK, Ellis, of Lingfield (1722-1788), son of Robert Bostock. Wife Sarah

Born and buried in Otford. Will 1788 (PCC). Children Stileman and Robert. Owned three manors: Otford New Park, West Hoathly and in right of his wife Apley Town in Lingfield. 1782 Owned lands at Finch Green in Penshurst and Chiddingstone. Also Little Frienden.1788

1788 Death, not in Chiddingstone. Will (PCC). He left his property to his wife Sarah for life, remainder to son Stileman.

BOSTOCK, Robert (1758-1821), second son of Ellis Bostock (above)
