He was Lord of the Manor of Beckenham from 1773 and devoted much of his energies to transforming the village into a significant suburban town, with opulent houses situated along wide tree lined avenues.

1807 Joseph Langridge was paid £1-19s for keeping her 26 weeks.

CHAPMAN, William, born 1793, son of George (above). Wife Elizabeth

1808 John Burfield was paid £3 for keeping him 49 weeks.

1814 (of Penshurst, labourer) Licence to marry Elizabeth Corke of Withyham, spinster. He was the son of George Chapman of Chiddingstone, labourer.

1818 Examination. Born in Chiddingstone. In 1810-1811 hired himself to Mr Paris of Withyham, farmer. In 1812 hired himself to Mr Robert Burfield of Chiddingstone. Married Elizabeth in 1814. Son George, aged 1. Now residing in Penshurst. Ordered to Withyham. (continued)

# CHAPMAN, Joseph, soldier. Wife Elizabeth (Bates)

1799 Elizabeth Bates was delivered of a bastard child named Mary Ann in Hastings, Joseph Chapman was the father. [This was stated in the examination of 1812]

1800 Joseph married Elizabeth Bates at Hellingly. (Jill Duncan).

1800 To the relief and expenses of Joseph Chapman 10s-6d. Expenses on account of his wife 2s 5d. To relieve his wife £3-1s.

1801 Daughter Charlotte (qv). The parish paid for churching Elizabeth and registering her child. Relief for her and her child.

1801 Parish reimbursed her expenses going to Hastings 9s.

1802 Relief for Joseph Chapman's girl. To John Larking for lodging and boarding Joseph Chapman and his wife 13s 11d.

1803 Daughter Harriet (qv).

1803-1824 Served in the army. His wife had two base daughters while he was away. (*Jill Duncan*).

1804 Parish paid his rent and 7s to relieve his wife. 1805-07 Parish paid the rent for his wife.

1805 The parish relieved his daughter Mary Ann Bates.

1806 Son Francis (qv). Registering dame Chapman's child 1s. 1807 To dame Barnett for laying her 5s. For churching her 2s.

1808 To Richard Snashall for keeping Elizabeth Chapman 62 weeks £3-18s.

1809 Son George (qv).

1810-13 Dame Chapman's family received substantial relief.

1811 Elizabeth Chapman had a base daughter Elizabeth (qv). Dame Chapman was given relief for the latest child separately1811-13.

1812 Examination of Elizabeth Bates. She was now living in Chiddingstone and was unable to support her daughter Mary Ann. Mary Ann was ordered to Hastings.

1812 Elizabeth Chapman occupied a cottage in Chiddingstone North.

1812 Mr Woollett was paid £2-4s for keeping Elizabeth's family, £9-7s in 1813, £4-19s in 1814.

1813 The parish received £10-10s from William Marchant on account of her.

1814 Base daughter Sarah Jane to Elizabeth Chapman (pauper). The overseers took Elizabeth to the magistrates at Maidstone. James Gardner was adjudged the father of her latest bastard female child.

1815 William Marchant paid £5-4s to the parish and £5-4s in 1817.

1817 Witnessed marriage of William Dorton and Sarah Jenner.

1817 James Gardiner paid £2 to the parish on account of Elisabeth's child.

1817 Arranged for her daughter Harriet to work for Thomas Seal of Tonbridge, yeoman.

1818 Parish received from William Marchant £5-4s for Elizabeth Chapman's child. Also in 1819.

1818 Parish received from James Gardner £2-4s for Elizabeth Chapman's child. (continued)

## CHAPMAN, Charlotte, singlewoman, born 1801, daughter of Joseph (above)

1816 John Potter was paid £2-15s-6d for keeping her.

1816 Expenses at Sevenoaks concerning Charlotte Chapman and John Smith.10s 6d. Order of removal for both 15s. [They were not necessarily together]

1819 Base daughter Mary. John Langley, labourer, found to be the father.

1819 John Longley paid £2 on account of "Harriet's" child. [This is presumably an error in the records]

1821 Relief 10s.

1805 The parish paid him 10s 6d to settle his bill. 1806 Bill £1-8s-5d.1808 Bill £1-4s-3d.

1810 Bill 9s 11d. 1811 Bills 8s 9d. 1812 Bill 2s 6d.

1806-1845 Occupied Butt House and Smiths Forge, tenant of Henry Streatfeild.

1811 Son Thomas.

1811 He was paid £3-18s for keeping Mary Johnson a year.

1812 He was paid £3-18s for keeping Sarah Steer a year.

1813 Son Henry.

1814 Bill £1-14s-6d. For keeping Harriet Kent 6s.
