At least 1785-1811 William Crouch and his wife received regular relief. Often described as William Crouch "senior" or "old master Crouch".

1791 Received a sack of peas.

1799 Received 100 faggots. For making a gown for dame Crouch

1800 Received faggots. Also 1806, 1807.

1802 For bringing William and his wife and goods to Chiddingstone Relief and faggots.

1803 To relieve "old man Crouch".

1804 Relief. To dame Crouch for spinning and for looking after Betty Best.

1806 Richard Best paid 4s for carrying faggots to William Crouch.

1809 To dame Best for nursing dame Crouch. For laying her forth 2s. Burial of dame Crouch 4s 6d.

1809 Death of Elizabeth Crouch.

1811 Relief.

1811 Death. Laying forth old master Crouch and carrying him to church 6s. Burial fees 4s 6d.

CROUCH. widow

1808 Two payments of relief to "widow Crouch". The second to the widow of William. William Crouch senior had a son William, born in 1764

CROUCHER, Thomas

1821 III. Relief £1-15s.

CROWHURST. Hannah

1785 Married William Shoebridge. Witnesses: George Dulake, Ann West

CROWHURST, Richard. Wife Ann, Sarah

1790 Married Ann Wheeler. Witnesses: William Brown, Mercy Constable.

1792 Daughter Lucy (qv)

1795 Relief 4s.

1797 Death of Ann.

1797 To Elizabeth Smith and a nurse for nursing dame Crowhurst. To Mr Pullin for his wife.

1797 Occupied Truggers Cottages (TA293) with Stephen Wickenden.

1797 Occupied part of a messuage with ¾ acre sold by Knight to Hoare (Truggers Cottages).

1797 -1800 Relief and payment of part of his rent.

1804 (widower) Married Sarah Jenner. Witness Mary Ann Piggott, John. Larkin.

1806 Crowhurst occupied a messuage at the Hoath, tenant of Joseph Potter.

1809-1824 Occupied a cottage in Chiddingstone South.

1810 Daughter Lydia (qv).

CROWHURST, Alice, of Withyham, born 1754

1794 Married John Head. Witnesses: Richard Bromley, Sarah Turner.

CROWHURST, Lucy, born 1792, daughter of Richard (above)

1811 Hired herself to the wife of George Holmden of Edenbridge.

1814 (Servant girl, workhouse) Base daughter Mary born in Edenbridge.

1814 Singlewoman. Examination. Born in Chiddingstone, now residing in Chiddingstone. In 1811 hired herself to Mr George Holmden of Edenbridge. Ordered to Edenbridge. This order was later quashed.

1814 Her daughter Mary died, aged 8 months. Burial costs 10s 6d. Relief 2s.

1819 Base daughter Sarah. Thomas Marly (Murley) the reputed father.

1819-21 Lucy received substantial relief for her child. (continued)

CROWHURST, Ann (see below)

1796 David Freeman was adjudged to be the father of a female bastard child born to Ann Crowhurst.

1801 Delivered of a female bastard child. William Frost of Penshurst adjudged the father. Later Ann and William Frost married.

CROWHURST, Maria, daughter of Ann Crowhurst

1801 Base born daughter of William Frost of Penshurst and Ann Crowhurst who later got married.

1816 Examination. Resident in Penshurst. Born in Chiddingstone 16 years ago as above. Resided with her father until the present and has never done anything to gain a settlement. Ordered to Chiddingstone.

1816-17 Substantial relief.

1819 Parish contributed £1-3s towards her burial. [not recorded in Chiddingstone]

CROWHURST. William

1805 He paid the parish £2-2s on account of the child born to Mary Burrage. 1811 £10-8s. 1814 £7-16s. 1815 £5-4s. 1818 £10-8s. 1819 £5-4s.

1814 He was paid 2s 6d for one day visit to Edenbridge with his daughter.
