CURREY, Edward, gent, of Deptford.

1784-1795 Owned Hale Farm which he had been left by Ann Torkington.

1795 Death. Will (PCC). He left his lands in Kent to several people jointly, and after the death of the last survivor, to Samuel Farar junior, son of Samuel Farar, surgeon, of Deptford.

CUTCHER, Henry. Wife Sarah (qv). See Hever.

1786 Henry Cutcher of Chiddingstone married Sarah, daughter of Thomas Ware of Chiddingstone at Hever. Witness: Thomas Biggs.

1788 Daughter Ann.

1793 Daughter Sophia.

1795 Son Thomas (qv).

(continued)

CUTCHER, Anne, born 1788, daughter of Henry Cutcher (above) usually SCUTCHER

1808 Witnessed marriage of William and Sarah Snashall.

1810 Substantial relief payment being ill.

1811-14 Regular relief.

1814 Death. Burial expense £1-1s. She was buried in Hever.

SCUTCHER, Thomas

1818-19 Small amounts of relief.

DALE See **Dell**

DALTON, William. Wife Ann

1804 Death of Ann, aged 56. She was the daughter of Joseph Langridge.

DAMOUR, Charlotte

1802 Death.

DAMPER, Edward see Hever

1791 Witnessed marriage of John Cooper of Chiddingstone and Mercy Ingram of Hever.

DAMPER, Richard

?1809 (of Sundridge). Married Elizabeth Baldwin of Stanmore, Sussex, in Sundridge.

Witnesses: John Damper, Susanna Lawrence.

1809-1851 Owned a messuage and orchard at Coopers Corner (TA 50-51). *[This may be a lease as the ultimate owners appear to be the Trustees of the Poor of Chiddingstone].*

DAMPER, William, shoemaker, farmer

1796 Parish paid him 4s 6d for shoes.

1799 Made shoes for Henry Collins £1-3s.

1815-1851 Occupied Kiln Farm, tenant of Marter.

1819 Nonconformist.

DANIEL, Margaret

1785 Death.

DANIEL, James

1782-1795 Occupied half of Withers house and garden in Chiddingstone, tenant of Henry Streatfeild.

1786 Witnessed marriage of Stephen Young and Ann Hammon.
1796 Death

DANIEL, George, living at Wandsworth

1790 Parish paid his rent £4-10s.
1818 Parish paid relief to his widow at Wandsworth £8.

DANIELS, John

1785 Parish paid his rent to Mary Hoar £3, £5-7s-6d
1789 Parish paid his rent for a property in Croydon. Two years £7-10s. Relief 11s 6d.
1791 Expense of going to Croydon about John Daniels 8s 6d. Expenses of John Daniels as per bill £14s-11s-3d.
1793 Death, in Chiddingstone. Expense of carrying him to Chiddingstone church 4s, burial fees 4s 6d, affidavit 1s.

DANIELS, Joseph, son of John Daniels (above). Wife Sarah, Mary

1794 Chiddingstone overseers travelled to Croydon to relieve Joseph Daniels and his wife £4-10s-6d. Expenses 14s. For a horse 2s 6d. for a letter from Croydon 4d.
1795 Expenses at Croydon as per bill £6-1s-4d.
1800 -04 Several payments to relieve Joseph Daniels and his wife Sarah.
1802 To relieve Joseph Daniels at London £1-1s.
1805 To relieve Joseph Daniel's's wife £2.
1807 The expense to the parish of going to London and all the expenses concerning Joseph's wife etc £4-2s-10d. Expended at Sevenoaks 9s 1d.
1813 Examination. Living in Croydon. After the death of his father, who was legally settled in Chiddingstone, he and his family received relief from Chiddingstone. He had married Mary at Edmonton in Middlesex in 1811. Children John (9) and Martha (4).
1813-14 Received relief. Expense of the parish officers going to Croydon on account of his family £13-4s.
1817 John Daniel received relief £1. Jane Daniel received relief 4s. 1818 John received 8s relief.

DANIELS, Jane

1819 Received £4-11s relief. *[Probably not living in Chiddingstone]*

DARTNOLL, John

1789 Witnessed marriage of William Young and Ann Ingram.
1811 Death.

DARTNALL, James. Wife Hannah

1792 Married Hannah Still of Odiham. Witnesses: Edward Mitchell, Esther Wood.

DARTNALL, Elizabeth

1815 (of Penshurst) Death, aged 83.

DAUGHTON – see DORTON

DAVIS, Ann, a travelling woman

1800 Death. For laying her forth and for carrying her to be buried etc 9s.

DAVIS, John

1788 Occupied a cottage at Coopers Corner (TA50).

**DAVEY, Stephen, of Sevenoaks, shoemaker, born at Chaley in Sussex. Wife Martha
See Edenbridge**

1808-1813 A footman or groom in the service of Henry Streatfeild.
1813-1818 Learned shoemaking from William Nicholson of Edenbridge.
1818 Married Martha at Southwark.
1829 Death. His widow married William Warren in 1830.
1822 and 1831 Examination. Martha was unable to support her three children by Stephen Davey. Living at Sevenoaks. The eldest child removed to Chiddingstone.

DAVY, Henry (or Henry LONG?)

1809 Witnessed marriage of Samuel Shoemith and Sarah Constable.

DAYKIN, William, gent, distiller of Sevenoaks.

1791-1801 Owned Brownings, occupied by Shoebridge. He died in 1826.

DEADMAN, William

1791 To him for making four bed mats 6s.

DEADMAN, John

1791 Parish spent 10s 6d in going after John Deadman. Warrant for his arrest.

DEADMAN, Lucy

1808 Death (infant).

.DEADMAN, widow

1797-1804 Substantial relief for her and her boy living in Tonbridge.
1804 Expenses on her account £1-0s-8d. For and indemnifying note for widow Deadman 7s.
1805 Parish paid £2 for her lying in.
1807-13 Parish paid her rent. 1809 Rent paid to James Fawkes for a year £2-13s. 1810 £1-1s. 1809 She was ill.

DEADMAN, David Wife Mary

1796-1808 Relief for David Deadman senior, including some barley in 1799. His rent paid £2.
1797 Death of Mary Deadman.
1797 Towards the burial of his wife £1-1s. [*This could be Mary Deadman.*]
1804 To Mr Haynes for keeping David Deadman for 26 weeks £1-19s. His rent paid £1-19s.
1805 Supplied with 50 faggots
1806 To John Legg for keeping him a year £3-15s.
1808 Death. Towards his burial £1-1s.

DEADMAN, Elizabeth, daughter of David and Mary Deadman, born 1768.

1793 Witnessed marriage of Richard Pritchett and Jane Osborne.
1795 Witnessed marriage of David Deadman and Susan Winter.

DEADMAN, David, labourer, born 1772. Son of David and Mary Deadman (above) Wife Susan, born 1768

1795 Married Susan Winter. Witnesses: James Deadman, Elizabeth Deadman.
1797 Daughter Sarah (qv).
1800-21 Substantial relief for David Deadman junior. His rent paid.
1800 Daughter Mary (qv).
1802 Daughter Susan (qv).
1804 Daughter Jane (qv).
1807 Daughter Mercy (qv).
1808 Thomas Smith paid 3s for nailing and specking a pair of his shoes.
1809-1818 Occupied a cottage in Chiddingstone South (£1-10s).

1810 Son Thomas.
1811 Mrs Leigh was paid £2-12s for keeping Sarah Deadman a year.
1813 Daughter Anne.
1813 Mr Brook was paid £3-15s for keeping Mary Deadman a year.
1817-18 William Hubble paid £7-10s for keeping Susan Deadman for 112 weeks. 1819 He kept Jane Deadman for a year £4-3s-4d.
1816 Daughter Harriet. To Mrs Barnett 6s for laying his wife.

DEADMAN, James, born 1775, son of David and Mary Deadman (above).. Wife Grace, born 1780

1795 Witnessed marriage of David Deadman and Susan Winter.
1795 (of Chiddingstone) Married Grace Marter at Penshurst.
1796 Daughter Mary.
1797 Son James
1800 Daughter Elizabeth (qv).
1800-01 Occasional relief.
1803 Son Philip (qv).
1805 Son David
1806-11 His rent paid by the parish and some relief.
1808 The midwife paid for attending his wife 5s.
1808 To Mrs Leigh for keeping James Deadman a year £2-12s. *[This must be James junior]*
1809 Occupied a cottage in Chiddingstone South (£2).
1814 14s relief. Mary Deadman (child) also received relief for one year £2-12s.

DEADMAN, Elizabeth

1796 Death (infant).

DEADMAN, Philadelphia

1804 Expected to give birth to a bastard child, John Piggott the reputed father. However the case was respited. *[Perhaps a still birth]*

DELL, Mrs Mary or DALE

1805 As Mary Barton she was left Bartons Farm by her uncle George Kidder.
1814-1845 Owned Bartons Farm, occupied by John Gasson, and the house and garden at Boughbeeche (TA192).

DELVES, Richard

1782-1801 Occupied Gillridge, tenant of Rev Francis Woodgate.

DELVES, Michael

1804 Occupied Gillridge Farm, for sale.

DENNETT, John Wife Ann.

1798-1800 Regular payments to relieve the wife (Ann) and child of John Dennett, He was a substitute for Francis Staples in the Supplementary Militia. In September 1798 recorded as Elizabeth Dennet and her child (*mistake?*)

DENNETT, James

1798 To relieve his wife and child

DENNIS, Henry

1809 Expenses when taking Henry Dennis. 7s 8d. 1810 For his bond £1-1s.

DENTON, Thomas Wife Mary (Hurrian)

1781-94 Paid for working on the roads, in 1781 with two boys.

1786 He burned two kilns of lime for Mr Streatfeild for £4-10s.

1794 Death of Mary

1799-1804 Received regular relief.

1804 Death. Parish paid £2-2s towards his burial.

DENTON, Margaret, born 1764, daughter of Thomas Denton (above)

1786 Death.

DENTON, Martha

1789 Married James Winter. Witnesses: John Finch, Mary Jones.

DENTON, James, born 1772, son of Thomas Denton (above) Wife Elizabeth

1792 Married Elizabeth Hood. Witnesses: Thomas Smither, Mary Jones.

1792 Witnessed marriage of Samuel Hood and Ann Hills.

1812 Death of his daughter, Margaret Fenner, aged 20.

1817 Witnessed marriage of William Dorton and Sarah Jenner.

1817 Witnessed marriage of John Smith and Sarah Gibbs.

1817 Witnessed marriage of William Hook and Harriott Arnold.

1817-21 Manager of the workhouse for £20 a year salary. Numerous bills for expenses eg for necessary journeys and expenses paid on the parish account as per bill £5-9s-10d. 1817 Provided with a copybook 8d. To buy leather for the workhouse £2-0s-6d. He provided the workhouse with yeast, as apparently did all workhouse managers!

1817 Journey to Godstone on parish business with William Taylor 12s. Expenses about George Edwards at Tonbridge 12s 2d.

1818 Witnessed marriage of Jesse Virgo and Elizabeth Walldraper. Journey to Maidstone with Elizabeth moor £3. Journeys to Sevenoaks on three different occasions on parish business. Provided with writing paper 6s.

1819 To James Denton a bill for acorns, relieving the poor, seven journeys and other expenses on the parish account £5-17s-6d..

1820 Overseer of Chiddingstone workhouse. Gave evidence concerning the children of William Fenner, late of Hever, blacksmith, who were his grandchildren.

1820 Overseer. Gave evidence concerning George Edwards. In 1821 his wages were £25 a year.

DENTON, Amelia, born 1778, daughter of Thomas (above)

1792 Death.

DENTON, William, labourer, born 1773, son of Thomas (above). Wife Mary

1796 Married Mary Emsley in Chiddingstone

1797 Daughter Millea.

1800-1813 Parish relieved him by paying his rent or by reducing his assessment. 1814-18 Rent paid and some relief

1811 William Nightingale paid £3-10s for keeping Elizabet Denton a year.
1814 Thomas Healey paid £5-15s-6d for keeping her for 73 weeks.
1815 Richard Keeyes paid £2-12s for keeping her a year.

DENTON, Mercy, daughter of William Denton (above) born 1801

1814 John Hoadley paid £2-15s-6d for keeping her 37 weeks.

DENTON, Charlotte, daughter of William Denton (above). Born 1803

1814 William Potter paid £2-2s for keeping her 28 weeks.
1817 William Smithers paid 7s for keeping her 7 weeks.

DENTON, Elizabeth, daughter of William Denton (above)

1817 Mr Brook paid £3-18s for keeping her 52 weeks. 1819 £2-12s for 52 weeks.

DENTON, Thomas, son of William Denton (above)

1821 Edward Paige paid £1-6s for keeping Thomas Denton 50 weeks.

DENTON, Samuel, born 1770, son of Thomas Denton (above)

1804-1805 Hired himself to James Canfield of Sundridge, blacksmith.
1819 Examination. Born in Chiddingstone, now of Sundridge.

DEWTHWAITE, Dr

1817 For attending William Battlemer's family £4-14s-6d.

DIPLOCK, John

1818 He was paid £6-9s for relieving William Marsh and £3-18s for relieving William Marsh's children. Probably of Westerham.

DIVALL, William, labourer, born 1787. Wife Ann (born 1793)

1810 Witnessed marriage of John Baldwin of Hartfield and Amelia Farmer.
1812 Married Ann Gower.
1812 Daughter Mary. She died in 1825, aged 12.
1815 Daughter Ann.
1818 Daughter Sophia (qv).
1818-21 Parish paid his rent and some relief when he was ill in 1821.

DIVALL, Thomas, living at Hartfield.

1808 For his part being drawn in the militia 15s.
1812-13 Substantial relief, being lame. 1812 To the doctor £1.
1815-21 Substantial relief and his rent paid. Dr Wallace paid many times for attending him.
His wife also relieved. Chiddingstone paid his poor rates for Hartfield.

DIVES, John and James, sons of Thomas Dives of Lingfield, yeoman.

1819-21 Tenants of Jane Medley for Hever Castle Farm

DOOR, Mary
1799 Death.

DORTON, William, ag lab. Wife Sarah. Born in Withyham or DOLTON

1817 Hired himself to Mr William Camfield of Speldhurst, farmer, but slept in first Withyham and then Ashurst.

1817 To Henry Leigh expenses towards William Dolton £2-8s-1d.

1817 Married Sarah Jenner. Witnesses: James Denton, Elizabeth Chapman. This was clearly a forced marriage.

1817 Expense to parish of licence, ring, marriage fees, attending the sitting, order of removal and carrying him home to Ashurst £9-19s-10d.

1817 Examination. Residing in Chiddingstone. Ordered to Ashurst.

DOUGLAS, Jane **see Hever**

1782-1797 With her sister Susan, wife of Charles Pain, owner of Buckhurst Farm in Cowden which included Scale Fields and Truggers Fields in Chiddingstone.

1794 She was dead (Chiddingstone-Burgherst).

DRAPPER, George. Wife Ann See WALLDRAPPER

1808 Daughter Sarah.

1808 Witnessed marriage of George Langridge and Sarah Drapper.

1815 To relieve him and pay for an order of removal and carrying him away and other expenses 17s 4d.

1816 Expenses attending sittings concerning George Drapper and John Smith etc £2-4s=9d.

1816 Relief 15s

DRAPPER, Sarah, born 1784

1808 Married George Langridge. Witnesses: George Drapper, Sarah Aynscomb.

DRAPPER, Elizabeth

1812-13 Relief.

1813 For churching her and registering her child 2s. [*Not baptised in Chiddingstone*]

1815 John Copper paid £2-6s to the parish on account of her child.

DREWETT, William, late of Penshurst, labourer

1814 Convicted of having stolen a pointer dog from Henry Streatfeild, esq. Fined £30, mitigated in 1815 to £20 (Quarter Sessions)

DRIVER, Martin, carpenter of Dartford.

1776 Death. Will (PCC). He left his share of Little Brownings to his wife Sarah for life, and after her to his nephew William Pack of Brenchley, yeoman. Samuel Martin, his brother, owned another share.

DRIVER, Samuel

1780-1794 Part owner of Little Brownings. He was the brother or nephew of Martin Driver. Thomas Bellingham occupied the property and was presumably also a part owner.

DRIVER, Thomas. Wife Beedy

1782-1794 Owned Great Batts Farm, in conjunction with his brother John Driver. There was a succession of mortgages.

1785 Petty Jury. Also 1787. 1791 Grand Jury. Also 1792, 1794.

1787 Married Beedy Boakes. Witnes: William Taylor.

1787 Son John who died the same year (infant).

1787 Parish paid to T Driver for Adams's rent 6 years £13.

1790 Death of Beedy Driver.

1791 A travelling man fell ill at Thomas Driver's. He was carried to the workhouse.

(1794) Sarah Piggott was dead. Her lands called Ryes, 18 acres (1s 9d), and Longcroft with Tare Grattan (1s 3d) had descended to Thomas and John Driver, who had alienated to Henry Streatfeild (Chiddingstone-Burgherst).

1794 1½ acres of flax grown on Batts Farm, occupied by Thomas Driver. (Quarter Sessions)

1791 Henry Streatfeild had bought Batts Farm from Thomas and John Driver. (Deed)

1800 Parish paid him £1-9s-1d for flour for William Smeed. 1801 ditto £3-11s-7d.

1813-18 Received substantial relief. 1817 A pair of shoes 13s.

1818 Chiddingstone paid his burial fees £2 .*[Not recorded in Chiddingstone]*

DRIVER, Sarah

1791 Witnessed marriage of Thomas Budgen and Elizabeth Corke.

DRIVER, Elizabeth

1793 Witnessed marriage of John Young and Ann Cork.

DRIVER, Bishop, living at Gillingham.

1805-21 Relief £2 a year and rent £2 a year regularly sent to him and his family living in Gillingham. Some correspondence by post.

DUDENEY, Philip, bailiff. Wife Ann

1814 Son Thomas.

1817 (of Sevenoaks) Son Philip.

DUDNALL, Elizabeth ?DUTNALL

1786 Witnessed marriage of Stephen Young and Ann Hammon.

DUKE, John

1780-96 occupied the House at the Church Gate for which he paid nominal rent of 2d a year for which the parish recompensed **him!**

DUKE, Timothy

1797-1803 occupied the above house on the same terms.

DUKE, William

1809-1815 Occupied Doubleton Farm tenant of Wells.

1815 Unable to pay his rates £1-19s.

DULAKE, George, tailor

1783-86 George sold goods to the workhouse. His wife acted as mistress of the workhouse and was also paid for spinning.

1785 Witnessed marriage of William Shoebridge and Hannah Crowhurst.

1817 Relief 12s.

DULY, Thomas

1810 Death.

DULY, Charlotte

1813 Married Thomas Eagleton. Witnesses: Jane Duly, Stephen Duly.

DULY, Stephen, Officer of Excise, born 1766. Wife Jane, born 1764

1813 Witnessed marriage of Thomas Eagleton and Charlotte Duly. His wife Jane also witnessed the marriage.

DULY, James

1815 Servant of John Woodgate. Watched his master's barn during the night and saw two men steal some wheat. He suspected that one of the men was David Roots (Quarter Sessions).

DUNCAN, Mr

1803 The parish paid him £5-4s-6d for a new pump for the workhouse., with deductions for the old lead.

DUPLOCK, Abraham

1814 Witnessed marriage of Luke Eade of Penshurst and Elizabeth Poole.

DURTNALL, John, yeoman.

1784-1796 Gamekeeper for Henry Streatfeild.

DURTNALL, James

1814 A local volunteer who was paid £2-2s by the parish.

1818 Parish received £3-5s from John Fry on account of James Durtnall's child.

DUTNALL, Joseph or DURTNALL?

1790 Death

DYER, Peter

1791-1793 Occupied a house in the village, tenant of Henry Streatfeild. Probably the eastern house in Chiddingstone Street

1793 Death (pauper).

EADE, Luke, turner. Wife Elizabeth. or EADES

1814 (of Penshurst) Married Elizabeth Poole. Witnesses: Abraham Duplock, Sarah White, Ann Hands.

1816 Son William (qv).

1818 Son George.

1818-1824 Occupied a cottage at Rendsey Hoath, TA 163. Rates £2.

1819 Son John (qv).

(continued)

EAGLETON, Henry, tailor. Wife Mary

1783-1794 Owned and occupied a house at Hill Hoath (?TA533).

This is probably the same as the cottage in Chiddingstone South occupied 1809-1815 (£2), which was later occupied by Thomas Eagleton. In 1765 William Winter had surrendered to the use of Henry Eagleton a copyhold cottage and garden at Hill Hoath (Penshurst and Halemote manor). In 1816 Henry Eagleton, one of the sons of the above Henry, admitted the use of the common well.

1785 Henry Eagleton was paid 4s 4d for work done for the poor. In 1788 ditto 13s 4d.

1786 Made gowns for dame Pollard and Hurrior's girl 2s 6d paid by parish.

1790 Daughter Susanna (qv).

1791 Son Edward (qv)

1797-1815 Mrs Eagles sent in a number of bills for making gowns for the poor. 1808 Priscilla Hider 3s 6d. 1809 Sarah Mason 2s 9d. 1813 Charlotte Nye 3s.

1813 Henry and Mary witnessed the marriage of Thomas Eagleton and Charlotte Duly.

1816 Death. Aged 90(?). Will (PS). Household goods to wife for life, remainder to daughters Mary Eagleton and Susanna Nightingale. To his sons; Henry, Thomas and Edward his messuage at Hill Hoath.

EAGLETON, Mary, born 1782, daughter of Henry (above)

1816 Provision for her in her father's will.

EAGLETON, Susanna, born 1790, daughter of Henry (above)

1813 Witnessed marriage of Thomas Eagleton and Charlotte Duly.

1812 Married Thomas Nightingale, shoemaker, at Little Peckham.

1816 Provision for her in her father's will. [See will of Henry Eagleton 1852 and of Mary Eagleton 1854].

EAGLETON, Henry, tailor, born 1780, son of Henry (above)

1816 His father left him a share of his messuage at Hill Hoath.

1813 Married Charlotte Duly. Witnesses: Henry Eagleton, Mary Eagleton, Susan Eagleton.

1814 Son Thomas (qv).

1815 Daughter Charlotte (qv).

1816 His father left him a share of his messuage at Hill Hoath.

1818 Son William (qv).

1818-1824 Succeeded Henry Eagleton as owner and occupier of a house at Hill Hoath (TA533) (£2).

EAGLETON, Edward, tailor, born 1791, son of Henry (above)

1816 His father left him a share of his messuage at Hill Hoath. He was not named an executor and therefore probably lived elsewhere.
