1799 Base daughter Elizabeth

**HALFIELD, William**

1811 Death (infant).

**HALL, Benjamin Edward, of Paddington Green, formerly of Chelsea.**

1808-1820 Owned Great Brownings, occupied by George Fitch.

**HALL, Mrs**

1791 Parish hired her post chaise for a journey to Town Malling, plus expenses £1-9s-5d.

**HALL, Thomas**

1795-1801 Parish paid him Richard Collins's rent. £2-12s -6d annually. He supplied Richard Collins with wood several times.

**HALL, Sophia**

1818 She received 6s relief.

**HALL, John**

1818 Received a small amount of relief.

**HALLWOOD, Elizabeth, widow**

1812 To relieve her and child £2-6s.

**HAMBLETON, Thomas, of Sundridge, collar maker.**

1778 The devisees of William Blundell deceased have alienated a messuage and 20 acres at Coopers Corner to Thomas Hambleton (Sundridge Upland 1s).

1780-1794 Owned Piggotts Farm, occupied by William Wickenden

1780-1794 Owned Bartons Farm, occupied by John Barton.

1785 William and John Day who held a tenement and certain lands 13 acres at Coopers Corner (Sundridge Upland 1s 4d) have alienated the same to Thomas Hambleton. This is Woodsgrove or Day's Castle

1789 He was paid £2-17s-6d as rent for widow Smith.

1791 Witnessed the marriage of William Marchant of Chiddingstone and Dennis Hoskins of Sundridge at Sundridge,

1794 Death in Sundridge. Will (PCC). To granddaughter Ann, daughter of his son Richard, the messuage and farm called Days situated in Sundridge and Chiddingstone occupied by William Gasson, plus £100. Richard and Mary Hambleton to occupy the premises for their lives.

1796 Thomas Hambleton had alienated Piggotts Farm (a messuage and 20 acres at Coopers Corner) to Thomas Hodsoll esq (Sundridge Upland 1s). *[I do not know what happened to Bartons Farm].*

**HAMBLETON, Richard, son of Thomas Hambleton (above). Wife Mary.**

1796 Thomas Hambleton who held a tenement and certain lands at Coopers Corner 13 acres (Sundridge Upland 1s 4d) died and bequeathed the land to his son Richard for life.

This is Woodsgrove or Day's Castle. The will of Thomas Hambleton (above) has Richard as the tenant rather than the actual owner.

1794-1811 Owned Days Castle (alias Woodsgrove)

1805 A Richard Hambleton died in Sundridge.

**HAMMON, Ann**

1786 Married Stephen Young, widower. Witnesses: James Daniel, Elizabeth Dudnall.

**HAMMEN, Mary**

1801 Death.

**HAMMOND, John**

1804 Witnessed marriage of John Levett and Ann Box.

**HANDS, Ann, born 1764**

1804 Witnessed marriage of William Nightingale and Mercy Taylor.

1814 Witnessed marriage of Luke Eade of Penshurst and Elizabeth Poole.

**HANKINS, Doctor**

1798 For attending the Collins family £2-12s. For Carter as per bill £4-9s-2d.

**HARBROW, James, of Hall Place, Leigh**

1796 He had married Sarah Burgess, widow, and by her acquired Clouts Farm which is sold to John Legg. He also through his wife acquired Polebrooks which he sold to Mr John Edmunds.

**HARBOROUGH, Thomas**

1764 Thomas Harborough for a tenement and lands called Great Sholefield or Sheffield, Bowlands and Beechenwood near Bowbeeche, occupied by John Nightingale.

1794 Thomas Harborough is dead. The lands descended to Miss Lynn, spinster who married Thomas Pine, late of Southwark, oil and colour man of Islington, chemist. Thomas Pine had it in 1794, before that it was held by the heirs of Geary and Limus, from 1780.

[Harborough Farm].

**HARGREAVES, Dr**

1821 Applied cowpox to William Jenner's family £1-1s.

**HARLOTT, Rebecca**

1805-10 Regular relief.

1807 Chiddingstone received from the Pembury officers £5-4s on account of Rebecca Harlotte.

1809 Expenses concerning her to Sevenoaks and Bromley about Rebecca Harlotte 11s.

1810 the expense of Rebecca going to Luddesdown, the Sevenoaks sitting, and all other expenses concerning that business £2-2s.

1810-11 Relief, including for her laying in.

1811 Letter from Luddesdown 11d. Chiddingstone received from the Luddesdown officers £5-6s.

1818 Death, aged 35

**HARLOTT, Thomas**

1808 Letter and certificate from him 2s. To relieve his wife 10s. For a certificate from him 1s.

1810 Paid to him for two certificates. Also for postage of two letters 7s.

**HARMON, Dame**

1806-07 For nursing dame Virgo £1-6s

1807 For nursing John Jenner's wife 15s.

1814 Hannah Harmon nursed Isaac Havilden's children 8s.

**HARMON, Mr**

1814 Paid 15s for setting new parish marks between Chiddingstone and Sevenoaks parishes.

**HARRIS, Sarah**

1808 (of Chiddingstone) Witnessed will of William Carrett.

**HARRIS, Timothy, gamekeeper, labourer See Edenbridge.**

1792-1807 (of Edenbridge) Gamekeeper for Henry Streatfeild.

**HARRIS,, Richard, sawyer**

1815 Saw John Austen remove two oak posts from his premises and throw them over a hedge into the premises of his neighbour Thomas Scot. The posts belonged to John Woodgate. (Quarter Sessions)

**HARROD, Mrs**

1785 Death.

**HARTRIDGE, Francis. Wife Sarah**

1802 (of Chevening) Son Francis.

**HARVEY, Thomas, esq of Tonbridge**

1767-79 Owner of Cowlarads.

1794 Being seized of a parcel of land called Cutbrooks containing 9 acres in Penshurst formerly occupied by Thomas Bassett and now by Thomas Russell (Chiddingstone Burghurst 9d) and also of 4 acres of land in West Chested Mead occupied by the same Thomas Russell (9d) and also of other lands called Brooke Street 4 acres occupied by Thomas Russell (6d) is dead. By his will he devised them to his son the Rev Thomas Harvey clerk who is now seized.

1779 Death. Will (PCC).

**HARVEY, Rev Thomas, son of Thomas (above) of Redleaf, Penshurst**

1780-1805 Owned Doubletons in Penshurst. In 1790 Henry Streatfeild acquired from him a parcel of land lying in Marshope Mead in Chiddingstone and Penshurst part of Doubleton Farm, 12 acres in exchange for land part of Brook Street.

1779-1808 Owned Vexour, Cowlarads and Breaches, occupied by Sturt.

1779 On the death of his father inherited Cutbrooks, 4 acres of land in West Chested Mead and Brooke Street, occupied by Thomas Russell.

1795 (or 1791) Held lands called Breeches from the manor of Hever Brocas (1s 4d), occupied by Russell.

1791 Deed of exchange between Thomas Streatfeild of Sevenoaks and Henry Streatfeild of Chiddingstone. Reference to French Mead, 3 acres, occupied by William Wicking, part of Larkins and Penshurst Lands, to river Eden or Medway east, Rev Thomas Harvey north, west and south. *[The location is not clear but Rev Thomas Harvey was the owner of Vexour].*

1808 He was living in that year.

**HATFIELD, William, labourer. Wife Sarah**

1808 Witnessed marriage of William Brotherhood and Ann Tilman.

1811 Son William.

1814 Mrs Hatfield kept Ann Carter 26 weeks £1-6s.

1815-1818 Occupied a cottage in Chiddingstone North (3s).

1816 Daughter Sarah who died aged 15 weeks.

1818 Son Abel.

1820 Death of William Hatfield, aged 7 weeks.

1821 Uncollected rates 5s.

1821 Had occupied a cottage (3s) but replaced by Henry Gale.

**HATWELL, dame**

1806 She was paid 17s 6d for nursing dame Carter.

**HAVELDEN, Joseph**

1793 Parish bore the expense of taking Joseph Havelden to Uckfield and getting him married £6-3s-11d. Also £6-3s-11d

**HAVILDEN, James**

1806 To Mr Cork at Tonbridge a bill for James Havilden £3-4s-6d.

**HAVILDEN, Isaac**

1810-17 Substantial relief. He was ill in 1813 and his family were ill in 1814. In 1814 his children were nursed by Hannah Hurrior 8s.

1816 His rent paid by the parish £5-5s. Also 1818 and 1821.

1818 The parish paid Mr Brook for supplying him with drugs. £7-5s-11d. Received relief.

**HAWES, James. Wife Mary**

1810 Married Mary Farmer. Witness George Piper, Ann Piper.

**HAWKE, Abraham, of Brasted, servant**

1817 Warrant and signing for Abraham Hawk 4s. To Mr Allnutt on account of Abraham Hawke's bond 3s. To Henry Leigh the expense on account of Abraham Hawk 18s 6d. Expenses to the parish and several journeys on account of Abraham Hawk.

1818 Filiation order as the reputed father of a male bastard born to Elizabeth Moore. (Quarter Sessions)

1818 He paid £4 to the parish for Elizabeth Moore's child.

**HAYES, William**

1796 Death.

**HAYNES, Elizabeth, widow of Francis Haynes gent**

1788 Death, aged 68. Will (PCC)

Children: William, Elizabeth Moor, Marget, Thomas Francis.

Grandsons: Edward, Josiah Bayley, Francis, the sons of William.

She bequeathed large sums of money and her personal estate.

**HAYNES, William, born c. 1740, son of Francis Haynes (above). Wife Amelia**

1777-1813 Owned and occupied Little Hale Farm and Little Seedcombes.

1785 Witnessed marriage of Joseph Brown of Camberwell and Frances Lucas.

1785 Petty Jury.

1787 Grand Jury. Also 1791, 1793, 1797, 1804, 1807.

1788-1791 Owned Funks in succession to Thomas Haynes. In 1791 he sold it to Sir Nelson Rycroft but continued to occupy it until 1805.

1788 Executor and part heir of his mother Elizabeth (above).

1793-1802 Parish paid Edward Collins's rent 2-2s a year.

1795-96 Overseer.

1797 For keeping Henry Collins 52 weeks £3-18s.

1798 Juror in trial of several Irishmen at Maidstone for High Treason.

1800 For keeping John Avis 6 months paid £1-6s.

1800-02 For keeping Thomas Smith for several years £8-18s.

1804 For keeping David Deadman for a year £4-2s.

1810 For keeping Moor's boy 57 weeks £2-12s. For 3 bushels of potts for the workhouse £1.

1813 Death, aged 73. Will (PCC). Citizen and draper.

To his wife Amelia for life his capital messuage situated at Sunbury, Middlesex with 2 acres of land; his farm called Little Hale Farm, 30 acres; his estate called Little Sidcups with 8 acres of meadow; his messuage in Broad Street, Westminster.

Remainder to Little Hale Farm to Edward his eldest son.

Remainder to Little Sidcups and the messuage in Broad Street to his son Francis.

Remainder of the estate at Sunbury to son Joseph Bayley Haynes.

Leasehold messuage in Little Newport Street, Soho to wife Amelia for life, remainder to son Edward, subject to the life interest therein of his sister Margaret.

1813-34 Widow Haynes owned Little Hale.

1834 Death of Amelia, aged 90.

**HAYNES, Thomas, son of Francis Haynes (above)**

1777 Bought Funks (Fowkes) from John Goodyer.

1780 Owned Funks, occupied himself.

1790 He had alienated lands called Fowkes 25 acres (7½d) and a messuage and 16 acres in Chiddingstone called Foukes (8½d) manor of Bowzell to the lord of the manor. However from 1788 to 1791 William Haynes owned the land.

**HAYNES, Edward, farmer, son of William (above). Wife Mary.**

1797 Served on Grand Jury.

1797-1800 High Constable of the Upper Half Hundred of Somerden. He charged the parish 11s for four day's work on account of Charles Virgo. Sent in a bill for Frienden Borough expense. 1790 He was indicted for not returning a list of persons residing the said half hundred liable for jury service. (Quarter Sessions).

1797-1842 Occupied Little Brownings Farm which was owned by Sir Nelson Rycroft..

1798 Son William Henry.

1802 Daughter Amelia.

1802 Paid £2-1s-3d for keeping Sarah Hurriion 33 weeks.

1804 Served on Petty Jury.

1805 Son John Webb.

1805-07 Parish paid him the rent for William Langridge. £2-2s a year. For keeping John King 49 weeks £2-9s.

1807 Daughter Ann Elizabeth Rayner.

1809-1842 Occupied Funks and Little Brownings, tenant of Sir Nelson Rycroft.

1810 Daughter Mary Ann.

1810 For keeping Joshua King 52 weeks £2-12s.

1813 On the death of his father he occupied Little Hale, now owned by his mother. By the will of his father he had the remainder to Little Hale and also to a leasehold messuage in Soho.

1814 Difficulty in paying his rates 13s 10d.

1815 Supplied a hog for the workhouse £9-4s-4d. He was paid £4-7s for keeping Harriott Chapman 58 weeks.

1816 Failed to pay his rates £11-10s. Paid in 1817.

1817 Failed to pay his rates £13-18s-9d.

1818 Supplied faggots for the poor £2-13s.

1819 Nonconformist.

1819 His rates uncollected £13-12s.

1821 Uncollected rates £27-9d. He was paid £4-1s for wood.

**HAYNES, Joseph or Josiah Bayley, son of William (above). Wife Mary, Rebecca**

1790 (of Chiddingstone) Married Mary Thompson of Sundridge at Sundridge. Witness: Robert Brown.

1796 Witnessed marriage of Francis Haynes and Harriet Collins at Brasted.

1813 On the death of his father he inherited the estate at Sunbury, Middlesex. His wife was now named as Rebecca.

**HAYNES, Francis, son of William (above). Wife Harriet**

1796 Married Harriet Collins of Brasted at Brasted. Witness Joseph Haynes, Henry Brown.  
1811-1820 Owner of Birchhurst Farm which he had bought from Edward Cole. Also Sheffield (Monks).

1813 His father left him the remainder of Little Sidcup or Seedcombs) in Chiddingstone and a messuage in St James, Westminster. He occupied Little Seedcombs until 1818, then put in a tenant.

1815 Failed to pay his rates £2-16s. 1817 Ditto £1-3s. 1819 £1-7s-6d.

**HAYSMAN, William**

1786 Witnessed marriage of James Odds of Sevenoaks and Elizabeth Waite.

**HEASMAN, Robert or HISMAN**

1785-86 To Robert Heasman for keeping Elizabeth Langridge 81 weeks £4-11s.

1793 Witnessed marriage of Robert Steer and Sarah Bellingham.

1798-1805 High Constable for King's Borough. Bill for expenses 6s 6d.

1802-03 Constable of Somerden together with Christopher Burfoot.

1805 His uncle George Kidder left him Henmans and Pile Gate Farm in Cowden.

**HIESMAN, James. Wife Sarah**

1809 Daughter Maria.

**HIESMAN ?, David**

1796 Parish expenditure on account of David Hiesman at the Quarter Sessions £1-13s-6d.

**HAYWARD, Widow**

1783 Paid 4s for keeping Earl's girl.

**HAYWARD, Widow**

1818 £1-19s relief for her child.

**HAZLEDEN, William**

1785 Married Elizabeth Waite. Witnesses: Thomas Hazleden,, Sarah Hazleden.

**HAZLEDEN, Thomas**

1785 Witnessed marriage of William Hazleden and Elizabeth Waite.

**HAZLEDEN, Sarah**

1785 Witnessed marriage of William Hazleden and Elizabeth Waite.

1793 (of Leigh) Married Henry Crandall. Witness: Mary Hazleden.

**HAZLEDEN, Mary**

1793 Witnessed marriage of Henry Crandall and Sarah Hazleden of Leigh.

**HAZLEDEN, James. Wife Ann**

1786 Married Ann Peerless. Witness: William Young.

1792 Death of Ann.

1812 Death.

**HEAD, Ann**

1785 Base daughter Harriet who died in 1787 (infant).  
1787 Witnessed marriage of Edward Hoare of Chiddingstone and Mary Banister at Hever.  
1788 Married John Baston junior. Witness Susanna Brooley, John Head.

**HEAD, John, publican and farmer, born 1748. Wife Alice, born 1754 See Hever.**

1787 Surveyor.  
1788 Witnessed marriage of John Baston junior and Ann Head.  
1788-1797 Occupied Frienden Farm, tenant of Woodgate.  
1789 Overseer of Chiddingstone South Side.  
1791-92 Parish paid him £1-0s-6d for keeping William Adams 69 weeks.  
1793 Parish hired his horse for a journey to Lewes lasting 5 days 7s 6d.  
1793 High Constable for Frienden Borough and of the upper half hundred of Somerden. He was indicted for not returning his list of freeholders for the latter. (Quarter Sessions)  
1794 Married Alice Crowhurst of Withyham. Witnesses: Richard Bromley, Sarah Turner.  
1795-96 Churchwarden.  
1796 For keeping Richard Burrage 45 weeks he was paid £1-2s-6d. More £2-12s.  
1796 Son John.  
1797 Son Robert.  
1797 For keeping William Nye 52 weeks he was paid £3-18s.  
1799 For keeping William King one year he was paid £3-19s. For keeping Susan Burrage 50 weeks he was paid £2-10s.  
1801 A quantity of rice delivered to the substitute for John Head. £3 including carriage.  
1808 Death.  
1810 Death of Alice (after giving birth to a base son Michael Woodhams).

1784 Son Joseph. The parish expended 1s 9d for his christening.

1786 Daughter Elizabeth (mother of John Barton Keays's daughter Maria).

1787 (pauper) Son Thomas (qv). Widow Moyce paid 5s for laying Hider's wife.

1789 (pauper) Daughter Philly (qv).

1789 Dame Wood paid 4s for nursing Hyder's wife. Widow Moyce paid 5s for laying Hider's wife.

1789 Relief 7s 6d and two bushels of peas 8s 6d.

1790 William Seal provided a sack of peas for Joseph Hider 16s.

1791 Daughter Priscilla (qv).

1791 Expenses to parish officers for going after Hider 5s 2d.

1791-2 Relief for Hider's wife including a sack of peas as well as for Joseph Hider. In 1792 his nurse was paid 6s.

1795 For laying out his child and affidavit 2s. Further relief and faggots.

1795 Expense to parish and time spent attending the sitting with Hider at Westerham £1-0s-4d.

 1809 The cost of a summons for her 2s.

**HIDER, Philly, born 1789, daughter of Joseph Hider (above)**

1803 To Thomas Scott for keeping Philly Hider for more than a year ££6-10s. For clothes for her £2-9s-1d. *[She was probably kitted out to enter the adult world]*  
 1807 Married George Huggett. Witnesses: Joseph Hyder, William Carpenter.

**HYDER, Priscilla, born 1791, daughter of Joseph Hider (above)**

1806 John Larking was paid 9s for keeping Priscilla Hider.  
 1808 Clothes made for young Hiders Hester and Priscilla 4s 2d. Mrs Eagleton made a gown for Priscilla 3s 6d.  
 1808 Expense of carrying Priscilla to the Bridewell (Maidstone) £1-15s-6d. To the churchwarden expenses on account of Priscilla. £1-15s.  
 Priscilla Hider's fees at the Bridewell prison 4s 6d.  
 1808 Married Thomas Baker. Witnesses: Joseph Hyder, Elizabeth Johnson.

**HIDER, James, born 1792, son of Joseph Hider (above)**
