Mrs Tilman paid 6s for laying his wife. 1818 Occupied a cottage in Chiddingstone North. 1818 Heirs of Thomas Gasson paid for providing him with faggots. 1821 Supplied with 100 faggots £1-12s. (continued)

INGRAM, James, cordwainer. Wife Mary

1783 Probably the son of John and Dorothy Ingram 1801 Hired himself to Mr Stephen Wigzell of Westerham, farmer. 1808 Married Mary. 1814 Relief 2s. For delivering him to Westerham 5s. 1814 Examination. Born in Chiddingstone. Children James (4½), Mary (3), Sarah (10 months). Now chargeable to Chiddingstone. 1815 Uncollected rates 14s 3d. 1815 Son John, who died in 1829, aged 14.

1818 Daughter Martha.1815-1824 Occupied a cottage in Chiddingstone North.1819 His rates unpaid 17s 6d.(*continued*)

INGRAM, Mercy

1791 (of Hever) Married John Cooper of Chiddingstone at Hever. Witness: Edward Damper.

INGRAMS, Sarah

1814 Examination. Born in Tandridge. In 1813 hired herself to William Cole of Chiddingstone, farmer, on the second day of Sevenoaks Fair. Now residing in Sundridge. Ordered to Chiddingstone. 1814 Relief £1-16s.

IZZARD, John

1815 Provided 2 cords of wood for John Jenner 12s.1818 For carrying wood for William Jenner for two years £2.1821 Supplied 100 faggots to William Jenner.
