1791 Witnessed marriage of William Marchant of Chiddingstone and Dennis Hoskins of Sundridge at Sundridge.

JEALE, Ann – see CHEALE

1799 Married Thomas Wicking of Chiddingstone at Hever. Witness: Mary Jeale.

JEALE, Mary

1799 Witnessed marriage of Thomas Wicking and Ann Jeale at Hever.

JEANE(?), John

1812 Married Susana Barton. Witnesses: Michael Sisley, John Head, Elizabeth Sisley.

JEFFERY, John See Edenbridge

1799-1800 Sold a quantity of wool to the overseers. In 1800 worth £3-18s 6d.

JENNER, James. Wife Ann, Creasy

1746 Born, son of William and Jane Jenner.

1770 Married Ann Hollamby.

1771 Son William.(qv)

1775 Daughter Sarah.

1777 Daughter Mary.(qv)

1779 Son James. Presumably it was he who died in 1799.

1782 Son Abraham.(qv)

1782-1794 Occupied a small property belonging to Richard Alnutt in Chiddingstone South for which the Land Tax was 15s.

1784-1812 Parish paid the Land Tax 3s a year for his house and garden. [*perhaps the landlord and tenant shared the Land Tax*]. Also his rent £3.

1784 Supplied with peas 9s 6d. A gown made for his girl 1s. George Kidder paid £2-3s for keeping James Jenner's boy and girl 17 weeks.

1786 100 faggots supplied by George Kidder. 14s.

1786 Daughter Ann.(qv)

1787 Death of wife Ann. Parish paid £1-1s towards the burial of dame Jenner.

1787-90 Parish paid his rent £2-10s a year to Mr Potter. 1794-96 Rent paid to Mr Alnutt £2-10s.

1787 50 faggots supplied by George Kidder. Bushel of wheat 5s.

1791 He was paid 1s for helping dame Care lay William Shoebridge forth.

1791 (widower) He married Creasy Smith. Witness: Philly Potter, Edward Potter.

1795 Parish supplied 50 faggots 8s.

1797 Parish provided 4 bushels of beans. 13s. 50 faggots 8s.

1798 He was paid 15s for hog fattening.

1800-01 (old James Jenner) Received relief intermittently. T1801 Ill. 1802 50 faggots 10s

1802 His rent of £3 paid to William Woodgate, esq.

1805-11 Intermittent relief. 1806 He was lame, and ill in 1807.

1807 He was paid 8s 9d by the parish for necessaries for some women going to Maidstone as per bill.

1809-1812 (senior) Occupied a cottage in Chiddingstone South. (£1-1s)).

1812 (senior) Death. Burial fees 4s 6d. To relieve him while he was ill £2-3s. Relief for his widow 10s.

1812-15 Supported by the parish. In 1814-15 living with widow Biggs and Charlotte Nye's child. Also connected to widow Smith who was looking after Ann Jenner's child.

1815 Widow Jenner occupied a cottage in Chiddingstone South.

1815 Death of Creasy Jenner, aged 73.

JENNER, William, born 1771, son of James and Ann Jenner

1797 Relief £1-1s.

1800 A number of relief payments. A nurse for his wife (9s) and costs of her burial (£1-1s). His rent paid £1-10s.

1800 Death of his wife not recorded in Chiddingstone burial register.

1801 Parish paid his rent £3.

1808-11 Substantial relief, also his rent paid by the parish.

1809-11 Thomas Gasson was paid £4-16s for keeping him 96 weeks.

1811 Payment for his nurse 4s.

1811-12 Relief while at Shipbourne £6-4s. Shoes 3s. To Mr Martin at Shipbourne £7-11s-9d for relieving him.

1812 To relieve William Jenner towards carting his goods from Shipbourne £1.

1813-21 Regular substantial relief in return for working on the roads. His rent paid £5 a year to Mr Austin. 1815 Supplied with two cords of wood by John Izzard 12s.

1815 Provided with a truss 12s. 1816 Payment for nurse 9s. 1817 Payment for nurse 12s.

1818 John Izzard was paid £2 for carrying wood to him for two years. 1821 Izzard supplied him with 100 faggots.

1821 Dr Hargreaves was paid £1-1s for cowpox for William Jenner's family.

JENNER, Mary, born 1777, daughter of James and Ann Jenner

1792 Richard Best paid for keeping her one year £1-6s.

1800 Married John Burfoot junior. Witnesses: Argile Richard Turner, Sarah Turner.

JENNER, Abraham, born 1782, son of James and Ann Jenner

1806-08 Some relief.

1808 Witnessed marriage of Thomas Browne and Sophia Guess.

1814-21 Some relief. Provided with a truss 19s. Work on the roads.

JENNER, Ann, born 1786, daughter of James and Ann Jenner

1806 Base son James Maynard Jenner..

1806 John Maynard adjudged the father of a male bastard son born to her. He was ordered to pay 2s a week to maintain the child. He paid £2-10s to the parish on account of the child.

1806-15 Regular support from the parish for her child.

1810 Married Jesse Holden of East Peckham, widower. Witness: Richard Best.

1812 Mr Brook paid £1-19s for keeping Ann Jenner's child.

1814 Parish provided Ann Jenner with a gown 1s 6d.

1815 John Mainard paid £2-6s to the parish on account of the child.

1815 To relieve widow Smith, Ann Jenner's child and Elizabeth Mainard's child £1-12s-6d.

1817 Relief 3s.

JENNER, James, born 1767, labourer. Wife Jane, Jane

c. 1788 Son Edward (qv).

1790 Son James (qv).

1793 Daughter Harriet baptised in Penshurst (qv). In 1813 Richard Best was paid £1-6s for keeping her one year.

1802 50 faggots for James Jenner junior 10s 6d.

1804 Death of Jane.

1807 Relief for his daughter Mary.

1805-15 George Pain was paid £3-18s a year to maintain James Jenner's daughter Mary.

1811 Mr Brook kept a daughter 48 weeks £2-5s.

1809 (widower) Married Jane Everest widow. Witness: John Miller.

1809 Son Benjamin (qv)

1809-11 (junior) Some relief. 1811 Relief for his wife. 1812 Substantial relief for his wife and two children. 1813 Regular relief.
1813 A bill for medical treatment for Jenner's wife to Mr Pickance £1-14s-2d. [*Which Jenner's wife?*]
1813 Daughter Rachel (qv).
1817 A summons on account of him 1s. Fetching his goods 7s. Considerable relief in return for work. To Mr Streatfeild towards James's rent 12s. For moving him £1. [*It is not always clear which James Jenner is under discussion*]
1818-21 Some relief. Abraham Collins supplied him with 100 faggots. Roots and faggots £1-12s.

1815 Summons for him 1s. Journey to Sevenoaks for parish clerk 5s. Court fee at Maidstone on account of him 10s.
1815 Adjudged the father of a female bastard child born to Lucy Longley. He paid Chiddingstone £5-2s-6d on account of Lucy Longley's child.
1816 He paid £6-10s on account of Lucy Longley's child. 1817 £3-5s.
1818 Married Lucy Longley (born 1791).

1794 Relief £1-8s-1d. 1796 16s. 1797 £2-7s-6d
1795 Occupied cottage at Turners at Rendleys Hoath, tenant of Joseph Langridge.
1797 Son James (qv).
1797 Cured of the King's Evil £5-5s.
1798-1805 Parish paid his rent £3-10s. In 1802 to William Woodgate esq.
1798 100 faggots for him and Adams 16s. Several large payments to support him and family.
1799 Faggots 9s.
1800 Death of wife Elizabeth. Her burial £1-1s paid by parish.
1801 (widower) Married Ann Pearch. Witnesses: William Fielder, Ann Fielder.
1801 Occasional relief.
1804 Son Robert (qv). To relieve him towards midwife 5s.
1805-15 Parish paid towards his rent about £4-10s a year. 1809 Rent paid to Mr Scott £5.
1806 Parish paid for a nurse 7s. To William Marchant senior 18s for keeping him 12 weeks.
1807 Dame Hurrion was paid 6s for nursing John Jenner's wife. For nursing 9s.
1808 Son William. Midwife for his wife 5s.
1812 Daughter Sophia (qv). Payment for a nurse 12s.
1815 Servant of Mr John Woodgate. One night watched his master's barn and saw two men steal wheat. He believed one of the men to be John Field. (Quarter Sessions)
1817 Expense of moving him to the "Holliwish" £1. Rent for him at the Holliwish 18s. To Mr Saxby and William Taylor two days fetching John Jenner's goods and wood £4. To William Ovenden for part of his rent £2-10s. Fetching John Jenner's goods from *Watlingham { name illegible}* 7s 6d. Moving them to the Horseshoe 5s. During 1816 to 1817 John Jenner also received some relief.
1818 Considerable relief, sometimes while ill. His rent paid to John Burfield £4.

1813-17 The child was supported by the parish.
1815 Expenses going to have Elizabeth Jenner sworn, examinations, warrant and taking up Thomas Rogers and all expenses attending Mr Allnutt £1-5s-6d.
1816 Base daughter Mary. Christening 1s. To Mrs Barnett for laying Elizabeth Jenner 6s. Expense at Maidstone 4s6d.
1817 Thomas Rogers prosecuted for Impregnating her. He paid £2 on account of Elizabeth laying in and £1-5s in 1817. £4-0s-6d in 1818 and £3 in 1819.
1820 George Scott the putative father of her bastard child.
1821 The parish received £6 from George Scott on account of her child.

1805 (widower) Married Elizabeth Smith, widow. Witnesses: William Marchant, Mercy Best.

1808 Elizabeth witnessed the marriage of Thomas Baker and Priscilla Hyder.

1809-1812 Occupied a cottage in Chiddingstone North.

1810 To Mr Parsons for writing to Dr Commons concerning John Jones 1s 6d. [*?doctors' commons ie lawyers*]

1810 Parish clerk travelled to Sevenoaks with John Jones to determine his parish 11s...Relief 7s.To Mr Morris for examination of John Jones and order of removal 7s 6d. For marrying John Jones and Betty Mellis 7s [*Compulsory?*]

1810 Married Betty Mellis. Witness: John Carter.

1810 To master Best the expense of carrying John Jones to Tyehurst £1-17s-6d

1811 (John Vavasour Jones) witnessed marriage of Edward Leigh widower and Anna Maria Jones.

JONES, Thomas A

1811 Witnessed marriage of James Smith of Fareham and Elizabeth Leigh.

JONES, Anna Maria

1811 Married Edward Leigh, widower. Witnesses: John Vavasour Jones, Sarah Augusta Jones.

JONES, Sarah Augusta, daughter of Rev John Jones of Kettleby, Leics

1811 Witnessed marriage of Edward Leigh widower and Anna Maria Jones.

1815 Witnessed marriage of Benjamin Humphrey widower and Sarah Johnson widow.

JORDAN, Charles

1801-1805 Occupied Bushes, ? undertenant to William Green.

JORDAN, William, of Edenbridge, bricklayer. See Hever, Edenbridge

1814 Parish paid him the rent for William Smeed senior (£1-11s-6d) and for William Smeed junior (£7).

1816 Mr Jordan at Edenbridge. Chiddingstone paid him £2-11s rent for William Smeed.

JOURDAN, MR

1818 The parish paid him £1-0s-6d as interest on £100 borrowed.

JOURDINE, Ann

1803 Base son Jourdine.

JUPP, Thomas

1804 Death.

JUPP, Robert

1793 Expense of his examination 1s 9d. Relief 1s 9d.

1794 Expenses of stagecoach going to hospital with Robert Jupp 13s 6d . Hospital charges £1-15s-6d. 1794 Parish reimbursed for overpriced

charges for Robert Jupp 9s.

1806 Expenses for Robert Jupp as per bill from Rochester £2-13s-10d.

1813 Mr Fitch, churchwarden, received £5-14s-2d for work done by Robert Jupp and William Carter.

1816 Death, aged 70. Carrying him to church 4s. Burial fees 6s.

JUPP, William

1816 He was paid £1-4s for keeping widow Aylward's child.

KEEYS, Richard, miller. Wife Mercy See Hever

1752 Employed George Wheeler for a year.

1783-88 Sent monthly bills to the overseers for flour supplied for the poor. In a specimen year amounted to £27.

1777-1788 Occupied Chiddingstone Mill, tenant of Streatfeild.

1785 His grinder Richard Nye gave evidence that Abraham Anderson had received flour but had not paid for it. (Quarter Sessions).

1788 (senior) Death, aged 66.

1810 Death of his wife Mercy, aged 79. She was the niece of Mary Boakes of Chiddingstone widow (will PS).

His daughter Mercy, born 1758, was married to William Taylor.

His son Richard was married to Hannah (monument).

KEEYS, Richard, born 1756, son of Richard (above). Wife Hannah See Hever

1786 Son John who died aged 6 weeks.

1787 Son John Barton Keeyes.

1788 Succeeded his father as tenant of Chiddingstone Mill and farm, also Lower Gravel Pits.

1788-1822 Sent monthly bills to the overseers for flour supplied for the poor eg 1805 £14-7s-1d, £17-0s 4d and for workhouse £6-17s-7d, £13-19s-7d, £10-10s-10d and for workhouse £6-4s-2d, etc.

1789 Son Robert.

1790 Daughter Maria.

1791 Paid for keeping Thomas Tippin one year £2-12s. ditto 1792.

1792 Son William who died in 1797 aged 3.

1792 Employed Henry Crundwell for a year as loader.

1793-94 Churchwarden of Chiddingstone. His expenses in going to Wandsworth and Mitcham. He was paid 5s for the use of his horse two days.

1794 Son Thomas.

1795 Witnessed will of John Woodhams.

1796 Witnessed will of William Seal.

1797 Reimbursed for his buying of wheat for the poor during the Great Snow of 1795. For thatching rods 2s.

1800 Overseers paid him 8s for his cart going twice to London.

1800 Supplied the workhouse with beef 16s. 1802 Hog meat 10s. Meat £1-6s-3d.

1802 For keeping James ? Warrin one year £2-10s. 1803 For keeping Edward Collins one year £2-12s and Sarah Shoebridge £3-12s.

1803 Surveyor of Chiddingstone.

1803 (yeoman) Gave certificate.

1804 Provided a fat hog for the workhouse £9-14s

1805 William Taylor acted as High Constable in his place.

1805 Paid £2-15s-6d for keeping Edward Hurrion and James Hider 37 weeks.

1806 Paid £2-12s for keeping James Hider one year and Elizabeth King one year £3-18s.

1807 Paid £2-12s for keeping Mary Steer one year. Ditto 1808. 1807 Paid £2-12s for keeping Henry Steer one year.

1809 Paid £3-18s for keeping Mary Gower one year.

1809-21 Richard Keeyes occupied Watlins Field, near Chiddingstone Mill.

1810 For fat hogs for the workhouse £13s-10d and ££11-18s-1d. for keeping Ann King 26 weeks £1-19s.

1812 Chiddingstone corn water mill belonging to Sandeforth Streatfeild for sale, occupied by Keys.

1812 For a fat hog for the workhouse £14-17s-9d. 1813 Two pigs for the workhouse £4-10s. 1814 Two pigs for the workhouse £3-6s.

1815 (senior) Overseer of Chiddingstone.

1815 Employed Sarah Virgo for a year. For keeping Mary Denton for a year £2-12s.

1816-18 Churchwarden.

1816 For a fat hog for the workhouse £8-16s. 1817 Ditto £12-0s-1d

1816 For removing James Saunders 10s.

1818 Surveyor (Chiddingstone South).

1818 For keeping Ann Roffey 52 weeks he was paid £3-18s.

1819 To overseers a bill from Richard Keys for John Adams. £1-18s-4d.

1821 Dame Wickenden was paid 11s 3d for nursing Richard Keys's wife.

1807 (junior) Witnessed marriage of William Nightingale and Mercy Taylor. Possibly occupied Crouchers Farm, Hever, tenant of Charles Brook, rather than his father.

KEEYS, Thomas, miller, born 1794, son of Richard (above. Wife Sarah See Hever

1816 Son Thomas.

1818 Daughter Mary Ann.

1819 Supplied 10 stone of beef to the workhouse £2-1s.

KEEYS, Robert

1817 He was paid £2-18s for keeping dame Everest's girl.

1819 For keeping Elizabeth Wood 52 weeks £3-18s.

1821 For keeping a boy £3-18s.

KELSON, Dr See Hever

1788 Parish paid him £24-4s for cutting off John Hoare's child's leg and cure.

KENLEY, Amey

1813 Relief 2s.

KENT, Charles esq (Sir Charles Kent)

1778 Charles Kent for a messuage and 50 acres of land called Chittenden in Hever and Chiddingstone, occupied by J Pearse. (Sundridge Upland £1-13s-8d).

1773-1788 Owner of Chittenden. Charles Kent became a baronet in 1782. Later he was MP for Thetford. Died 1811.

1790 Charles Kent esq being seized of Chittenden, occupied by Thomas Ware (Sundridge Upland £1-13s-8d) has alienated the same to John Cator esq.

KENT, Maria

1791 Witnessed marriage of Richard Gasson and Elizabeth Eastwood.

KENT, Harriot

1813 Thomas Hoadley was paid £2-8s for keeping her for 32 weeks.

1813 Mr Nightingale, shoemaker, was paid £-15s for keeping her and Ann Fossett for one year.

1814 Thomas Chapman was paid 6s for keeping her.

KIDDER, George, yeoman. Wife Elizabeth See Hever, Edenbridge

1773-1797 Occupied Stonewall Farm, tenant of Woodgate.

1784 William Piggott mortgaged Skipreed to him. Renewed in 1798.
 1785 Parish paid him Isaac Colchin's rent £2-10s. For keeping a boy one year £1-6s and a girl £2-12s. Provided faggots for the poor 17s.
 1786 Supplied 100 faggots for widow Pollard, 100 for James Jenner, 50 for George Longley, 50 for the workhouse £2-2s.
 1787 For keeping Jenner's girl £1-6s. Faggots for the poor 13s.
 1788 Overseer for the South Side of Chiddingstone.
 1786 Witnessed marriage of William Browne and Mercy Welfare.
 1789 Churchwarden.
 1790 For keeping Adams's girl one year £2-2s.
 1791 Served on Petty Jury. Also 1792.
 1792 Paid 7s for carrying David Turner's and dame Smith's goods to the workhouse.
 1793 Reimbursed for conveying army baggage by waggon and team from Broadwater camp to Ashdown camp.
 1793 Paid £4-17s for hog fattening for the poor.
 1794 Paid £1-7s. for supplying half a cord of wood to William Adams, ditto for dame Pollock, ditto for Richard Nye. Paid 18s for dame Pollock's rent.
 1795 Paid £2-12s for keeping James Ingram 12 weeks. Supplied 100 faggots for the poor £1-4s.
 1795 2½ acres of flax grown in Workhouse Field, Stonewall Farm, occupied by George Kidder.
 1796 5 acres of flax grown in Pond Field, part of Stonewall Farm.
 1796 Death of his wife Elizabeth, aged 61.
 1797-1805 Owned Bartons Farm, occupied by Edward Hoare.
