

**KINGATE, Anne**

1813 Death, aged 20.

**KINGATE, William**

1816 Death, aged 22.

**KINGSMORE, John, of Offham near West Malling**

1787-1794 Occupied Hoath Farm and Geers, Riddens and Bridge Fields at £64 per annum, together with Skinners or The Corner Farm, tenant of Henry Streatfeild. Quit in 1794. Also tenant of Batts Farm.

1788 Occupier of Hoath Farm from which a horse was lost.

1793 Reimbursed for conveying by waggon and team the army baggage from Broadwater camp to Ashdown camp.

**KINGSMORE, Robert**

1791 In a deed of exchange Henry Streatfeild gives part of Great Batts Farm called Beach Field, Wallhouse Hoath and the Swins Wood on the Hoath Bank in Chiddingstone, 13 acres, to Thomas Streatfeild. The land occupied by Robert Kingsmore.

**KINGSWOOD, Sarah**

1785 (widow) Married John Atherfold. Witnesses: Samuel Sutton, Samuel Bevan.

**KINGSWOOD, Thomas. Wife Ann**

1794 Married Ann Burchard. Witnesses: William Richardson, George Sakar, Ann Bowra.

1798 Daughter Elizabeth.

1800 Death of Elizabeth.

1802 Son Thomas.

1805 Daughters Frances and Ann.

**KINGSWOOD, John. Wife Elizabeth**

1796 (of Chiddingstone) Married Elizabeth Waters at Penshurst.

1796 (junior) Son Henry (qv).

1797-1801 Occupied a property in Chiddingstone North, possibly TA194 at Boughbeeche.

1806 Witnessed marriage of Richard Kingswood and Ann Fry.

**KINGSWOOD, Richard. Wife Ann**

1806 Married Ann Fry. Witness John Kingswood, Hannah Maria Copper.

1807 Daughter Elizabeth (baptized in Hever).

1808 Death of Elizabeth.

1809 Daughter Mary.

1809-1812 Occupied a cottage in Chiddingstone North.

1811 Son James who died in 1812.

**KINGSWOOD, William(?)**

1805 Witnessed marriage of William Smith and Anna Adams.

**KINGSWOOD, John**

1808 Death.

**KINGSWOOD, Mary**

1816 (of Chiddingstone) Aged 1. Causeway. Buried in Penshurst.

**KINGSWOOD, Henry, labourer. Wife Diana**

1812 Hired himself to Thomas Sales of Penshurst, farmer.

1816 Hired himself to Mr Michael Woodhams, farmer.

1818 Married Diana.

1818 Examination. Born in Chiddingstone. Living in Penshurst. No order made.

1819 John Barton said that Henry Kingswood had helped to steal a hive of bees and 10lb of honey from Joseph Potter, and also two ducks from Henry Mitchell's pond. Henry denied it. (Quarter Sessions).

1821 Paid 14s for work on roads.

**KINGSWOOD, widow**

1809-1812 Occupied a cottage in Chiddingstone North.

**KIRBY, John**

1809-10 Paid £2-17s-6d for keeping Sarah Mason 47 weeks.

**KIRKEY, William. Wife Ann**

1800 Son Henry.

**KNELLER, Mary or NELLER**

1785 Base son John.

1788 Base daughter Ann.

**KNELLER, John, bricklayer. Wife Ann**

1806 Some relief

1816 Daughter Elizabeth.

1818 Son George (qv).

(continued)

**KNIGHT, Hannah**

1789 (pauper) Death.

**KNIGHT, Richard**

1796 Death.

**KNIGHT, John, yeoman**

1773-1801 Occupied Little Truggers Farm...

1780-1801 Owned a cottage and garden opposite Truggers Farmhouse. (TA293)

1797 John Knight of Chiddingstone, yeoman, sold to Edward Hoare a messuage now in two with farm, garden to trackside or orchard  $\frac{3}{4}$  acre, to highway Chiddingstone to Cowden north, occupied by Stephen Wickenden and Richard Crowhurst. [Truggers Cottages].

1805 Death.

**KNIGHT, Edward, labourer. Wife Alice See Hever**

1811 Son John (qv).

1815 Daughter Hannah (qv).

1818 Son Richard who died aged 10 weeks.

1819 Daughter Fanny.

1818-1820 Occupied a cottage in Chiddingstone North.

**KNIGHT, Jane**

1811 Death (and infant).

**KNIGHT, Mary**

1816 Witnessed marriage of George Randall and Ann Virgo.

1817 Married William Ashdown.

**KNIGHT, Sophia**

1817 Witnessed marriage of William Ashdown and Mary Knight.

**KNIGHT, Amelia, born 1800**

1818 Married John Coulstick. Witnesses: Frances Thomas, John Welfare.

**KNIGHT, Ann**

1812 (of Chiddingstone) Owned a cottage and half an acre of land in Sundridge. She let the cottage to Thomas Quittenden.

**KNOTT, W**

1819 Nonconformist.

**LAMB, Henry, briter** [*whatever a briter is!*]

1806 He was paid £10 for the expense of James Hurrion's indenture.

**LAMBERT, Nimrod, servant. Wife Elizabeth**

1817 Licence to marry Elizabeth Osborne of Frankfield, spinster. Surety: George Weller of the Cliff, new Lewes.

1818 Daughter Sophia.

**LANGRIDGE, Ann**

1785 Death.

**LANGRIDGE, Susana**

1790 Married John Smith of Westerham. Witnesses: .... Waller, Ann Hooker.

**LANGRIDGE, Joseph. Wife Mary**

1785 Served on Petty Jury. Also 1787, 1791, 1792.

1787 Death of Mary, aged 66.

1794 Death, aged 72. Will (PCC).

To son Joseph messuages called Turners at Ranleys Heath.

To son William lands in Rotherfield.

Daughters Mary Pearles of Rotherfield, Ann Dalton of Hayes, Sarah Wallis of Cowden, Elizabeth Gainsford of Cowden, Susana.

His daughter Ann married William Dalton and died 1804, aged 56.

1782-1794 Owned several tenements and an apple orchard at Wellers Town.

**LANGRIDGE, Joseph, son of Joseph (above)**

1794 Inherited from his father messuage called Turners at Ranleys Heath, occupied himself, William Welfare, John Jenner, John Humphrey and George Langley.

1794-1823 Owned several tenements and an apple orchard at Wellers Town, occupied after 1801 by Thomas Scott.

1807-08 Parish paid him the rent for George Longley.

1807 He was paid £1-19s for keeping Sarah Chapman.

1808 (of Speldhurst, miller) His aunt Ann Langridge left him a quarter of her property.

**LANGRIDGE, William, of Leigh, farmer, son of Joseph Langridge senior (above)**

1808 His aunt Ann Langridge left him a quarter of her property.

**LANGRIDGE, Ann, must be the sister of Joseph Langridge senior**

1808 Death, aged 74. Singlewoman. Will (PCC).

Left her property to her nephews William Langridge of Leigh, farmer, Joseph Langridge of Speldhurst, miller, Susana, wife of John Smith of Brasted, Elizabeth, wife of Richard Gainsford of Cowden.

**LANGRIDGE, William**

1808 Death. For carrying him to church 8s.

1808-17 His widow received relief.

1816 She was listed for relief with widow Biggs and Sarah Elphick's child [*suggesting that they lived together*]

**LANGRIDGE, William. Wife Elizabeth**

1788-1791 Occupied a cottage at Cooper's Corner (TA50).

1805-06 Regular relief. 50 faggots 13s-6d. To Mr Haynes his rent paid £2 a year.

1812 Death, aged 62.

1814 Examination of his widow Elizabeth. She had been living in Chiddingstone with her adult son for about a year. Her husband had died in 1812. For the last four years of his life he had rented a small farm in Brasted from Mr Thomas Hollamby.

**LANGRIDGE, George, labourer, born 1775. Wife Elizabeth, Sarah**

1795 Married Elizabeth Rye, widow. Witness: James Jenner.

1799 Son William who died the same year (infant).

1805 Death of Elizabeth.

1805 Death of George, a child, presumably his.

1808 (widower) Married Sarah Drapper. Witness Sarah Aynscombe.

1810 Son David.

1812 Son James.

1812-19 Regular relief.

1812 Gower and Langridge occupied a cottage in Chiddingstone North.

1813 Supplied meat to dame Wickenden 8s.

1815 Son George.

1815-1824 Occupied a cottage in Chiddingstone North.

1818 Daughter Sarah. Mrs Barnett was paid 6s for laying her.

Sarah was born in 1784. Her children Harriott (1809), John (1811), James (1812), George (1815), Sarah (1817).

1821 George Langridge paid £3-12s-10 for relief and for working on the roads.

**LANGRIDGE, James. Wife Elizabeth**

1811 Daughter Sarah.

1811 Relief £1-3s. The parish paid Mr Brook £1-4s-8d on account of him. For an order of his removal and other expenses £1-0s-9d.

1812 Dr Creasy's bill on account of him £4-3s-9d.

**LANGRIDGE, Mary**

1819 Base son Richard Marchant.

**LANGRIDGE, Ann**

1796 Death (infant).

**LARKING, John, victualler. Wife Elizabeth, born 1775 See Hever**

1797 Sarah Paige left him £100 and all her property, remainder to sister Elizabeth Leigh.

1797-1821 Licenced at the Chequers.

1797-1821 Occupied the Chequers which he owned 1808-1822.

1797-1820 Occupied Stoneyfield which he owned 1808-1820.

1800 Daughter Mercy (qv).

1803 Daughter Lucy who died in 1806.

1804 Witnessed marriage of Argile Richard Turner and Mary Burfoot, widow.

1804 Witnessed marriage of Richard Crowhurst, widower, and Sarah Jenner.

1805 Furnace Farm, Hever was auctioned at the Chequers.  
1806 Daughter Elizabeth.  
1806 To John Larking for keeping Priscilla Hider and Elizabeth Gasson 18s.  
1808 A bill to the overseers on account of George Huggett 13s 6d. For keeping Sarah Johnson 6s. For expenses of Mary Standing 15s 6d.  
1810 Petty Jury. Also 1819.  
1812 Son Sidney (qv).  
1812-13 He was paid £6-11s for keeping Ann Hider for 93 weeks. For necessaries for Ann Hider 3s 7d. Making her a gown 1s.  
1812 He supplied necessaries for the wife of William Nicholas, a traveller, who laid in at Gravel Pit Barn. 11s-5d.  
1819 Served on Petty Jury.

**LATTER, Elizabeth**

1793 Married John Jessupp. Witnesses: William Welfare, Mercy Brown.

**LAWRENCE, David**

1806-07 Paid Chiddingstone £15-12s on account of Millea Maynard.

**LEGG, John, of Bletchingley. Wife Ann**

1796-1811 Owned and occupied Clouts Farm, bought at auction.  
1806 Rental of manor of Sundridge Weald.  
John Legg for six acres of land at Bowbeeche late John Piggott occupied by William Price (later occupied by John Legg) 3d. John Legg for a messuage and part of 6 acres of land at Bowbeeche sometime John Piggotts and since Thomas Taylor, occupied by William Price (later occupied by John Legg) 3d.  
1797 Petty Jury. Also 1804.  
1798 Witnessed will of Sarah Page.  
1806 He was paid £3-18s for keeping David Deadman for one year.  
1811 Sold Clouts Farm to Henry Streatfeild. He occupied Wickhurst farm, which from 1812 was occupied by Abraham Legg.  
1819 Death. Will (PCC) of Chiddingstone, yeoman.  
Provision for his wife Ann.  
£50 to son Stephen Legg. The residue to be divided:  
Quarter to son Abraham Legg.  
Quarter to son John Legg of Bletchingley, clocksmith.  
Quarter to daughter Catherine, wife of Benjamin Smith of Barnet.  
Quarter to the children of his daughter deceased late the wife of Mr Thomas Holden of Edenbridge, farmer.  
Executors Joseph Potter of Chiddingstone, farmer, and John Boaks the elder of Sevenoaks farmer.  
The terms of the will were altered in a codicil.  
1811 John Legg was the tenant of Wickhurst Farm in Chiddingstone and Leigh. He was succeeded in this by his son Abraham (1812-1851).

**LEGG, Abraham, farmer, son of John Legg (above)**

1802 Gave certificate. Also 1804.  
1812-1851 Occupied Wickhurst Farm. His father had briefly taken out a tenancy to which Abraham succeeded.  
1819 On this father's death Abraham inherited a quarter of the estate.

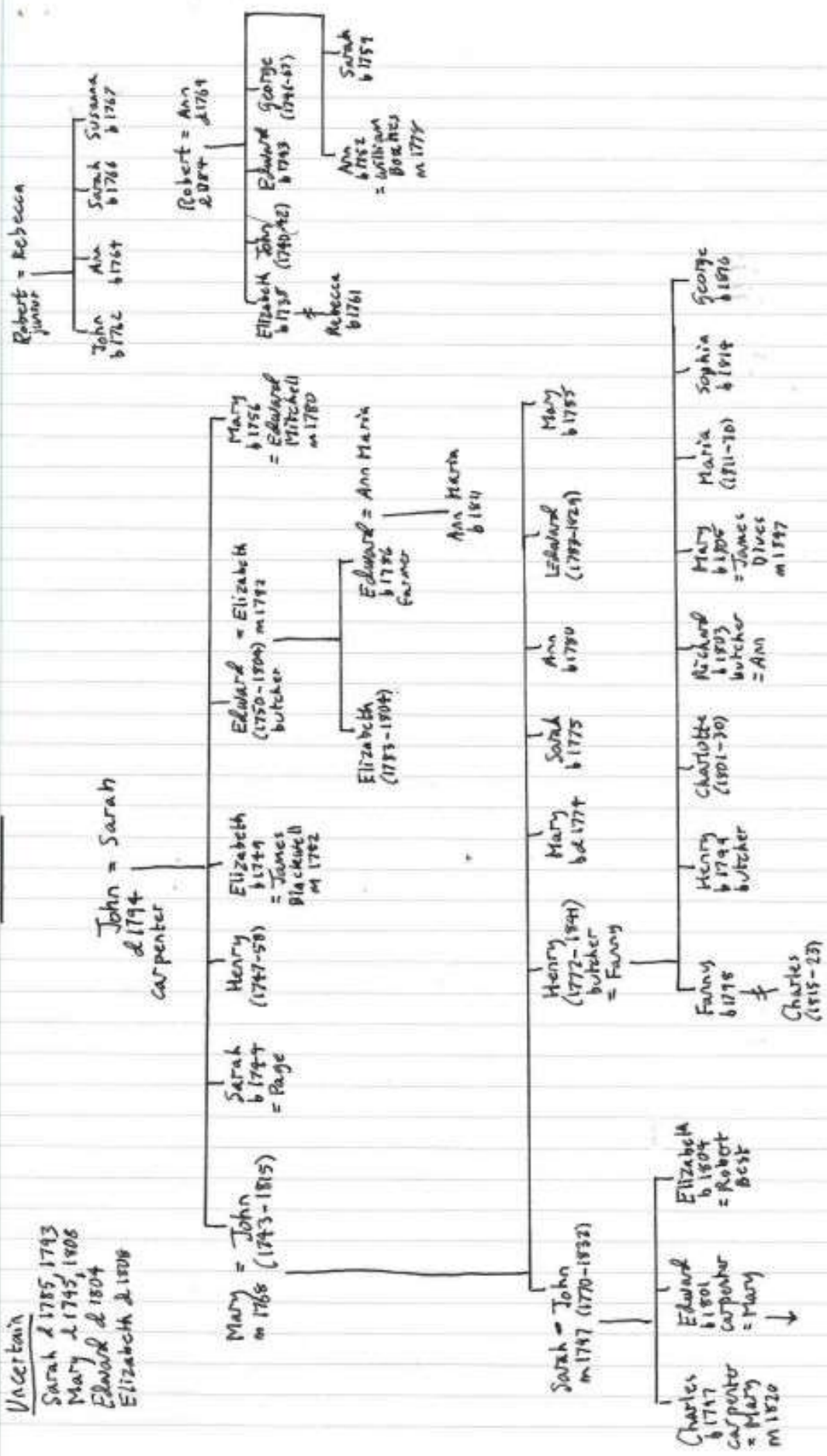
**LEGG, John, of Bletchingley, clocksmith, son of John (above)**

1804 (junior) (of Bletchingley) Gave certificate.  
1819 On this father's death John inherited a quarter of the estate.

**LEIGH John, carpenter Wife Sarah**

1782-1794 Occupied Tyehaw House, tenant of Henry Streatfeild

1793 Death of Sarah.

1794 (senior) Death.

**LEIGH, Sarah**

1785 Death.

**LEIGH, John, butcher, born 1743, son of John and Sarah Leigh. Wife Mary**

1772 Son Henry

1780 Daughter Ann

1783 Son Edward (qv)

1785 (junior) Daughter Mary.

1786 Witnessed marriage of Benjamin Humphrey and Ann Holman.

1787 A new house and garden were built by Henry Streatfield in Bengeland Field and half was let to John Leigh junior.

1790 Witnessed marriage of Thomas Woollett and Sarah Cornwall

1791 (junior) Occupied a cottage in Chiddingstone South (4s).

1794 He succeeded his father at Tyehaw House. Rent to be raised for Tyehaw House on John Leigh's coming to it from Bengeland House.

1795 Death of Mary (?daughter).

1796 Witnessed will of William Seal.

1798 Brother-in-law of James Blackwell (Will PS) who appointed him trustee and executor.

1809 Death of Mary (?wife).

1815 Death, aged 71, widower.

1815 He died intestate. Allegations by his son Henry Leigh, butcher, and by Edward Leigh of Leigh, farmer and William Thirby of Tonbridge, innkeeper.

**LEIGH, Edward, victualler, born 1750, son of John and Sarah Leigh (continued). Wife Elizabeth (Page) See Hever, Edenbridge**

1782-1804 Licenced at the Castle Inn, tenant of Henry Streatfeild.

1785 Dispute between Edenbridge and Chiddingstone over the place of settlement of Edward Leigh, labourer, and his wife Elizabeth who had intruded into Edenbridge from Chiddingstone. Agreed to arbitration. Leigh had lived and served with Mr John Avis of Edenbridge

1786 Son Edward (qv).

1790 Witnessed marriage of Thomas Woollett and Sarah Cornwall.

1793 Witnessed marriage of Jacob Chessell, widower, and Mary Brand.

1796 Witnessed will of William Brook.

1798 Sarah Page left £100 to her niece Elizabeth, daughter of Edward Leigh, and £100 to her nephew Edward. To Elizabeth Leigh her sister all her household goods and livestock after the death of John Larkin. When Edward Leigh died in 1804 administration of Sarah Page's estate was granted to her sister Elizabeth Leigh.

1798 Death of his brother-in-law James Blackwell who made him his executor and trustee (will PS). Edward had a brother John Leigh.

1801-1803 Employed James Geary as an ostler at the Castle Inn.

1802 Witnessed will of Richard Bevan.

1804 Death, aged 53.

1805 Mrs Leigh was paid £3-18s for keeping Edward Jenner 52 weeks.

1804-1812 Elizabeth was licenced at the Castle Inn, followed by Henry Leigh. 1805 For liquor expended in parish business 2s 3d.

1805-12 Supplied meat to the workhouse. Monthly bills eg 1805 £5-1s-9d, £5-14s-3d, £4-5s-9d, £5-3s-6d.

1807 For expenses of a particular meeting on account of Dr Stone £1-5s-1d.

1807 For keeping Edward Jenner a year £3-18s. ditto 46 weeks £3-5s.

1809 For keeping George Virgo a year £3-18s. 1810 ditto £2-14s.

1810 To Mrs Leigh the expenses of Mr White and Mr Moon during the time of valuing the parish £19-12s-4d.

1811 The parish officers spent 3s 10d at Mrs Leigh's on parish business. For keeping Sarah Deadman one year she was paid £2-2s and for keeping James Deadman one year she was paid £2-2s.

1811-1812 Elizabeth owned Stonelake Farm which by 1814 she had sold to William Wells of Redleaf. Elizabeth and her son Edward also occupied Great Moorden, tenant of William Wells, and she owned and occupied Oakenden until 1825, when they went bankrupt.

1816 Elizabeth Leigh was paid £3-18s for keeping John Roffey a year.

1821 Elizabeth and Edward unable to pay their rates £19-2s-3d.

**LEIGH, Elizabeth, born 1783, daughter of Edward and Elizabeth (above)**

1798 Her aunt Sarah Page left her £100.

1804 Witnessed marriage of John Hoadley and Elizabeth Potter.

1808 Death (monument), aged 24.

**LEIGH, Elizabeth**

1811 Married James Smith of Fareham. Witnesses: Thomas Jones, Edward Leigh.

**LEIGH, Edward, born 1786, son of Edward Leigh (above). Wife Anna Maria**

1798 His aunt Sarah Page left him £100.

1811 (widower) Married Anna Maria Jones.

1811 Daughter Anna Maria.

1811 Witnessed marriage of James Smith of Fareham and Elizabeth Leigh.

1811-1812 With his mother Elizabeth owned Stonelake Farm, which he occupied 1811-1826, together with Great Moorden. Also Oakenden from 1814.

1811-1813 Employed James Boakes, butcher and farmer, who moved with him to Leigh in 1813.

1813 He was paid £2-4s for keeping John Smither.

1814 Provided meat for the workhouse £1-10s

1815 (of Leigh, farmer) Gave evidence that John Leigh of Chiddingstone butcher had died intestate.

1818 Supplied 50 faggots to John Ingram 16s.

1821 Elizabeth and Edward Leigh were unable to pay their rates £19-2s-3d.

**LEIGH, Edward, of Edenbridge, glazier See Edenbridge Wife Maria**

1807-15 (glazier) Several bills to the overseers. £1-2s, £1-13s-7d, 5s 6d, etc.

1808 He mended a tea kettle for the workhouse 1s.

1817 (glazier) For mending windows at the workhouse and poorhouse 19s 11d.

1819 Bill to overseers for £2-1s-6d.

**LEIGH, Edward born 1783, son of John and Mary Leigh**

1815 Succeeded his father in the occupation of Tyehaw.

**LEIGH, Henry, butcher, son of John and Mary Leigh (above). Born 1772 Wife Fanny**

1808 "Paid £7-10s by the overseers on account of Samuel Coulstock's fine"

1812-21 Regular bills to the overseers for meat for the poor and the workhouse, following his mother.

1813 Messrs Leigh received £2-10s for half a year's rent for Isaac Roffey.

1814 Overseers expended at the Castle £1-6s-4d on parish business.

1817 He was paid £1 expenses on account of Abraham Hawk.

1821 Churchwarden.

**LEIGH, John, carpenter, presumably of Edenbridge. See Edenbridge, Hever**

1802 Sent in an estimate of the cost of repairing two bridges near Chiddingstone Mill £23-12s-11d. (Quarter Sessions 1804)

1806 Bill, and a fat hog for the workhouse £15-12s.

1810 Bill to overseers 13s-4d. 1811 £2-12s, £6-18s-4d.

1814 Carried out work at the workhouse.

1816 To the heirs of John Leigh, carpenter a bill £14-0s-2d. *[Problem!]*

1816 Bill to the overseers £8-8s-1d. 1817 £9-2s-7d. 1819 £8-16s-11d.

1818 For work done at Somerden Green £9-2s-7d.

**LEIGH, John**

1805-06 Expenses to overseers of attending the sitting at Sevenoaks with John Leigh 16s. Examination and two orders and expenses 19s-6d.

Relief 5s. Journey of overseer to Edenbridge with John Leigh 10s 6d. *[It is not clear which John Leigh]*
