1792 Married Richard Butler of Penshurst. Witnesses: John Staples, Mary Graham.

**MONK, Mercy, born 1774, daughter of Richard and Elizabeth Monk.**

1795 Married William Best. Witnesses: William Seale, Lyddy Monk.

**MONK, Lyddy**

1795 Witnessed marriage of William Best and Mercy Monk.

**MONK, Edward Wife Ann**

1793-97 Regular relief for himself and wife.

1802 Death of Edward Monk. Burial fees 4s 6d Affidavit 1s.

1804 Death of Ann. Carrying dame Monk to church 4s. Burial fees 4s 6d.

**MONK, Richard, born 1750, son of Edward and Ann Monk. Wife Elizabeth.**

1788 Relief 1s.

1791-1794 Occupied Gilwyns, tenant of Henry Streatfeild.

1799-1805 Regular relief including a contribution to his rent.

1798 Dame Monk paid 5s for laying a travelling woman (Mary Allin)

1801 Dame Monk paid 5s for laying Samuel Hood's wife and 5s for laying Betty Chapman.

1802 Mr Humphrey supplied 200 faggots.

1803 Dame Monk paid for delivering Mary Cook.

1803 Death of Elizabeth Monk. Parish contributed £1-1s to the burial of Dame Monk.

1805 Death of Richard Monk. Carrying him to church 4s. Burial fees 4s 6d.

**MOON, Mary**

1790 Witnessed marriage of John Rye and Elizabeth Gower.

**MOON, Maria**

1817 Witnessed marriage of William Hoadley and Mary Wells of Sundridge.

**MOON, John**

1809 Former occupant of Ivy House.

1810 To Mrs Leigh the expenses of Mr White and Mr Moon during the time of valuing the parish £19-12s-4d. Paid to John White and John Moon for valuing the parish of

Chiddingstone as per bill £103-1s-6d. To Richard Gasson for 6 days going with Mr White and Mr Moon valuing the parish 15s. To Richard Cole ditto 7 days 17s-6d.

**MOON, William**

1815 Supplied 47 stone 5 lb of pork to the workhouse £10-10s-3d. Received relief £3.

**MOORE, Mr Richard**

1810 To Mr Richard Moor for irons for Joshua Smith's child 7s 6d.

1809-11 High Constable and Bridgewarden of the upper half hundred of Somerden, succeeding William Taylor. In 1810. The Quarter Sessions ordered a rate of 3d in the pound on the hundred of Somerden to reimburse him and John Burfield for money spent on repairing Long Bridge.

**MOORE, George**

1812 High Constable

**MOOR, Richard. Wife Jane.**

1794 Married Jane Whale. Witnesses: William Piggott, Sarah Wheston.

1794 Son James.(qv)

1795 Son Richard (qv).  
1799 Paid 5s 9d for hog fattening.  
1800-04 Parish paid his rent, in 1803 to Mr Scott.  
1800-05 Substantial relief for Richard Moore and/or his boy. 1802 50 faggots. 1804 25 faggots.  
1801 Death of Jane. Parish paid £1-1s towards the burial of his wife.  
1803 To Mr Scott, shopkeeper, sent in bills amounting to £7-4s-9d on account of Richard Moore and his family, suggesting illness.  
1803 To dame Jenner who took care of his family 10s 6d.  
1804 An inventory was taken of his goods.  
1804 To George Piper £2 for lodging and boarding Richard Moore when ill.  
1805 With others he was paid by the overseers for work done.  
1805-07 Regular payments for the maintenance of Richard Moor's boy.  
1809 Relief 17s 7d.  
1809-1815 Occupied a cottage in Chiddingstone South.  
1812 Chiddingstone received £3 from Richard Moore  
1815 Death, aged 51.

**MOORE, James, born 1794, son of Richard Moor (above).**

1819 Relief 6s 10d.

**MOOR, Richard, born 1795, son of Richard Moor (above)**

1809 Clothes for him at service 19s-4d. Relief (boy) 8s.  
1810 To William Haynes for keeping Moor's boy a year £2-17s. To relieve him at service 8s 9d.

**MOORE, Ann**

1812 Ann Burfield paid 3s 9d for work done for Ann Moore.  
1812 Death.

**MOORE, Elizabeth, daughter of Richard Moore (above)**

1807-08 Edward Pearless was paid £4-2s-6d for keeping her 54 weeks.  
1811-12 John Burfield was paid £5-17s-6d for keeping her 47 weeks. Cost of making a gown for her 1s 6d. 1812 Two gowns 3s 6d. A bonnet 1s.  
1817 Examination. Born in Chiddingstone. Her father was from Chiddingstone; he died in 1815. Now living in Brasted. Pregnant. Ordered to Chiddingstone. Parish officers paid £3 for expenses two days journey to Maidstone with her. Court fees 18s.  
1817 (singlewoman) Removed from Brasted to Chiddingstone.  
1817 Base son Abraham who died in 1820, aged 2. Parish paid for her child's christening 1s.  
1818 Abraham Hawke of Brasted charged with impregnating her.  
1818-19 She received substantial relief for the child. 1819 Abraham Hawke paid £4 towards the maintenance of his son.  
1821 Parish contributed 18s towards the burial of her son.

**MOORE, John, labourer**

1816-17 Employed by Mr William Woods of Bushes Farm in Chevening.  
1818-1819 Employed by Mr Thomas Older of Sharpe's Place, Chiddingstone.  
1819 Employed by Mr John Poiles of Chiddingstone. Taken ill and removed to the poorhouse in Chiddingstone. Agreed to pay another man for completing his service.  
1820 Examination. Born in Rotherfield.

**MOORE, Dr**

1786 Medicines for Burnett's wife 4s. Medicines for Isaac Colchin 3s 6d.  
1792 Parish paid him his bill on the smallpox account £6-3s.

**MORETON, Mary**

1505 Relief for her child £1-6s.

**MORGAN, Thomas**

1791 (of Sevenoaks) Married Mary Marchant (minor). Witnesses: John Morgan, Mary(?) Morgan.

1812 Presented a bill for 4s 6d to the overseers.

**MORGAN, John**

1791 Witnessed marriage of Thomas Morgan of Sevenoaks and Mary Marchant.

1809 Occupied a cottage in Chiddingstone South.

**MORGAN, Samuel, shoemaker**

1812 Bill for Ridley's family 11s 11d. Also 1814 10s 2d. [*possibly Sevenoaks*]

**MORGAN, Mary (?)**

1791 Witnessed marriage of Thomas Morgan of Sevenoaks and Mary Marchant.

**MORRIS, R.W.G., attorney see Hever**

1801 For a mittimus for Simon Still to Bridewell 12s.

1806 He was paid 3s for attending to the Pembury bill and for signing the poor account 2s.

1806 Witnessed will of John Boakes.

1810 Paid 7s 6d for examination of John Jones, and order of removal.

1813 Sent in a bill for £18-12s-2d to the overseers.

1814 Witnessed will of Thomas Hoadley.

1818 He was paid £27-6s on account of Elizabeth Hollamby's child, for the use of the executors of the late John White of Tonbridge.

1819 Witnessed will of John Legg.

**MORTON, Dr See Hever, Edenbridge**

1783-85 He was paid £2-2s per quarter for medicines for the poor.

1783 He was paid £1-1s for medicines for Stephen Young and £3-3s for the cure of Elizabeth Moyce.

**MOYCE, Elizabeth**

1783 Cured by Dr Morton.

**MOYCE, Thomas**

1785 Death.

**MOYCE, Thomas, carpenter Wife Ann**

1739 Thomas Moyce and Ann his wife from Brasted acknowledged to be legally settled in Chiddingstone.

1782-1787 Occupied Somerden House, tenant of Henry Streatfeild. Also Somerden Green Farm. Apparently succeeded by John Moyce.

1784 For a coffin for Robert Leigh 9s, for widow Walker 9s, for a poor person 9s, for Smeed's child 2s 6d

1784 To dame Moyce for laying Thomas Hollamby's wife 5s.

1785 Coffin for a poor person 9s. for Ann Langridge 8s. Master Moyce paid 6s for laying forth, etc.

1785 Ringing the bell for Moyce's wife 1s. For laying Adams's wife 5s. For laying two women 10s. Master Moyce for laying forth etc 6s.

1786 To dame Moyce for laying John Hill's wife 5s. For laying Hider's wife 5s. For laying dame Billings 5s.

1786 Thomas Moyce presented a bill for 3s 6d. Coffin for Wood's child 2s 6d. For whetting a saw for the workhouse.  
1787 Dame Moyce for laying Sarah Avis 5s.  
1787 Thomas Moyce two coffins for the poor 14s.  
1787 Dame Moyce for laying a traveller 5s.  
1787 Death of Thomas Moyce  
1787 Widow Moyce for laying Hider's wife 5s.

**MOYCE, John, carpenter, wheelwright. born 1754, son of Thomas (above). Wife Ann – see Hever**

1787-1825 Occupied Somerden House and Somerden Green Farm, tenant of Henry Streatfeild.  
1787 Mended the pump at the workhouse 2s 4d  
1788 Made three coffins for the poor 27s. A bill to the overseers for 11s 11d.  
1789 Made a coffin for Knight's wife 9s. Two coffins for the poor £1-0s-6d. Bill to overseers for 8s 9d.  
1791 Bills for 14s 7d , 15s-1d, and 12s-8d.  
1791 Dame Moyce for laying Elizabeth Austen 5s. For laying a travelling woman lying at Edward Leigh's 5s.  
1792 Dame Moyce for laying Hider's wife 5s.  
1793 Dame Moyce for laying Elizabeth Austen in the workhouse 5s. For laying two women 10s.  
1793 Coffin for William Best 10s. For work done at the workhouse 11s.  
1794 For coffins and carpentry work done at the workhouse £3-3s-3d. Bill £1-19s-3d.  
1795 Work done at the workhouse £1-9s. 1797 Bills £3-10-6d, 10s 7d. 1798 Bills £1-11s-7d, 18s 2d. 1799 Bill 17s 10d.  
1797 He agreed to pay £4 per annum rent.  
1799 Witnessed marriage of Godfrey Stidolph and Sarah Hollamby.  
1800 Son William (qv).  
1800 Bills to overseers: 1800 £2-16s-6d. 1801 £2-1s-2d, 12s 9d, £1-4s-5d. 1802 coffins £2-8s. 1803 £1-2s-9d, 14s-1d.  
1802-11 Employed John Carpenter, initially as an apprentice. Informed Carpenter that he (Moyce) was certificated from the parish of Brasted.  
John's father, Thomas, had been certificated from Brasted in 1739.  
1802 Son Thomas.  
1803 Daughter Mary.  
1803 For keeping Mary Poplett a year £3-18s.  
1804 Bills to overseers: £1-12s, £1-4s-6d. 1805 19s 3d.  
1805 Bills for coffins £1-7s. Bills to overseers 19s 6d, £1-14s-5d. 1806 £1-2s-5d, £1-10s-1d.  
1808 £2-4s-2d. 1809 £3-12s. 1812 £2-15s-5d.  
1806 Daughter Ann (qv).  
1807 For keeping Jane Gasson for 22 weeks he was paid £3-18s.  
1808 He bought an apple tree from the workhouse for £1-14s. For keeping Hester Hider 47 weeks he was paid £3-10s-6d.  
1809 Son Samuel who died the same year.  
1810 Daughter Mille.  
1811 Witnessed marriage of Stephen Coomb and Sarah Loveland.  
1812 He was paid £3-18s for keeping Mary Wickenden a year.  
1812 Bill for coffin for John Carter 18s. 1812-21 Further large bills for coffins.  
1812 Daughter Philadelphia (qv).  
1814 Son John (qv).

1814-1816 Employed Harriet Wickenden for no wages.

1816 Daughter Harriet.

1817 He was paid £3-18s for keeping Ann Staples.

1821 Unable to pay his rates £2-19s.

1788 Witnessed marriage of Richard Wood widower and Elizabeth Welch.

1805 Parish received £1 from his arrears of last year's assessment.

1805-1818 Occupied a property in Chiddingstone North, possibly TA194.

1815 Rates uncollected 14s 3d. 1817 ditto 17s 3d.

1817 Married Hannah Hurrion.

1818 Unable to pay his rates 15s-7d.

1821 Parish paid him £1 for work on the roads.

**MOYCE, Mary**

1807 Death.

**MOYCE, William, wheelwright, born 1800, son of John Moyce (above)**

1820 Prosecuted by Chiddingstone for fathering a bastard on Charlotte Nye. Supported by John Moyce. Order of filiation made. (Quarter Sessions)

**MUGGRIDGE, Thomas**

1802 Witnessed marriage of James Gibb and Mary Muggeridge.

**MUGGRIDGE, Mary**

1802 Married James Gibb. Witnesses: Thomas Muggridge, William Taylor.

**MURLEY, Thomas**

1819 Filiation order as the reputed father of a male bastard born to Lucy Crowhurst of Chiddingstone, singlewoman.

**NASH, John, labourer. Wife Mary See Edenbridge**

1815 Examination. Born in Chiddingstone. In 1810-11 hired himself to William Head of Crowhurst. In 1812 hired himself to William Austen of Crowhurst. 1812 Married Mary.

Children: Jane (3), James (1). Now residing in Edenbridge. Ordered to Crowhurst.

**NATION, E.**

1812 warrant for him

**NEAL, John, miller**

1812-21 Sent monthly bills to the overseers for flour for the poor eg £33-15s-6d ,£19-5s-1d, £39-14s-4d, £19-9s, £16-1s.

1812-1820 Occupied Bassetts Mill, tenant of John Burgess.

1814 (senior) Witnessed will of Henry Eagleton.

1816 (miller, of Frienden Borough) Served on Petty Jury.

1818 Overseer of Chiddingstone

1818 His bill to the overseers was split £11-2s-4d for the parish and £21-9s-4d for the workhouse.

**NELLER See KNELLER**

**NEWMAN, James**

1803 Mr Newman was paid £3-18s for keeping Sarah Loveland a year.  
1814 James Newman was paid £6-7s for keeping widow Aylwood's child 44 weeks.

**NICHOLS, Ann**

1806 Married John Peckham. Witnesses: Michael Crank, Sarah Turner.

**NICHOLS, James. Wife Grace**

1810 Daughter Harriott.

1812 Received 9s relief (local). 1813 Received £1 for his child. To James Nichols wife and child 14s 3d relief.

**NICHOLAS, William or NICHOLLS. Wife Ann See Hever**

1812 A traveller. His wife laid in Gravel Pit Barn and received 11s 5d worth of necessities from John Larking. Relief £2-2s. For churching his wife and registering the child 2s.

1812 Son John who died the same year. Burial fees 2s. Relief 6s.

1812 Examination. He was born in Martinique and did not know where his parents were settled. Married Ann at Storrington in 1811. Legitimate son John born in an outhouse in Chiddingstone in 1812. His other children by Ann were bastards: Ann (10), born Robertsbridge; William (8), born Hadlow; Elizabeth (6), born Seal; Jane (4), born Hever.

They wandered about the country sleeping in tents and outhouses. Ann did not know where she was born. Her maiden name was Ashdown(?). Both her parents died when she was an infant. The bastard children were ordered to their respective parishes of baptism.

1812 Order of removal of the Nicholas family £2-9s. Jane was removed to Hever. For a register of Nicholas's child at Hever 1s. Another child was removed to Limpsfield which cost 5s and for the registration of the child 1s 6d. Ann was removed to Robertsbridge which cost £1-5s-10d including turnpike gate expense. Nicholas seems to have gone to Robertsbridge 10s. William was removed to Hadlow which cost 4s.

**NICHOLAS, Edward**

1816 He was paid £1-19s for keeping Ann Ellis for 9 months.

**NICHOLS, Thomas, farmer. 1749 gamekeeper for Rennesley or NICHALLS**

.About 1778 he was a farmer of Penshurst. and employed his nephew James for a year 1804 (of Penshurst). Appears to have bought Camphill Farm, 95 acres and died shortly afterwards.

1804 Death of Thomas Nickalls of Penshurst. Will (PCC). Succeeded at Camphill Farm by James Nickalls.

**NICHOLS, James, nephew of Thomas (above). Wife Catherine.**

1778 Employed by his uncle Mr Thomas Nicholls of Penshurst for a year.

C1780 He married Catherine. Children: Ann (40), Catherine (38), James (36), Thomas (33) in 1818.

1805 On the death of his uncle he inherited Camphill Farm where he lived until 1809 when he sold the farm to William Wells of Penshurst esq for £3000

1818 Examination. No order made. Chiddingstone was his parish.

1819 He paid the parish £3-9s for his wife.

**NICHOLS, Thomas, labourer, born 1785, son of James Nichols (above). Wife Elizabeth**

1818 Examination. Born in Penshurst. Had never done anything to gain a settlement. His father became entitled to a messuage and 95 acres of land in Chiddingstone and Leigh and he lived there for five years. Married Elizabeth in 1813. Children: James (3) and an unbaptized female infant. Now residing in Leigh. Ordered to Chiddingstone.

1818 Daughter Harriet. His wife received 3s relief.

In the Census of Poor 1825 he also has a son Amos born 1815.

**NIGHTINGALE, Sarah, possibly born 1778, daughter of Nicholas**  
1791 Death.

**NIGHTINGALE, John**  
1792 Death.

**NIGHTINGALE, Susanna, wife of Nicholas Nightingale (below)**  
1793 Death.

**NIGHTINGALE, Robert Wife Katharine**

1780-1786 Occupied Gravel Pit Farm.

1777-1786 Owned and occupied Slaters Farm.

1786 Death. Will (PS, 1787)

To son Nicholas his messuage near Bow Beech (ie Slaters).

Other sons Robert, William and Thomas.

Witnesses: Edward Hoare, John Barton, William Barnes.

1794 Four parcels of land in Chiddingstone (Tyhurst 1s 9½d). Robert Nightingale devised it to his son Nicholas. Nicholas has since alienated three parts to his brothers Robert, William and Thomas who are all now seized in coparcenary.

**NIGHTINGALE, Robert, shoemaker, son of Robert Nightingale (above), born 1743.**

**Wife Mary**

1784-1813 Numerous monthly bills to the overseers for shoes for the poor. In 1785 the total was £2-1s-6d. In 1805 £1-10s-10d, £1-10s-7d, £1-8s-3d, £1-12s-6d etc. The bills cease in 1813 and immediately afterwards Thomas Nightingale starts sending bills for shoes.

1775 (junior) Son Thomas

1777 (junior) Son Robert

1779 (junior) Daughter Mary

1781 (junior) Daughter Sarah

1783 Daughter Ann

1785 (junior) Daughter Elizabeth.

1794 His brother Nicholas alienated to him a fourth share in four parcels of land in Chiddingstone called Slaters (Tyhurst 1s 9½d).

1801-1818 Probably occupied a house at Cares Corner..

1805 Witnessed will of George Kidder.

1807 Death of Robert Nightingale – not him. Probably his son.

1808 Death of Elizabeth Nightingale (?). Possibly his daughter.

1811 Churchwarden. Parish paid 10s 6d to relieve John Awcock at Master Robert Nightingale's. Paid 2s for a journey and expenses.

1812 Death of Mary Nightingale. Possibly his wife.

1812 Received a third share of the estate of his brother Nicholas.

1813 Robert ceased sending bills to the overseers for shoes for the poor. Succeeded by his grandson Thomas.

1819 Robert, William and Thomas Nightingale referred to at Slaters (Tyhurst 1s 9½d).

1819 Parish paid him half year's rent for Richard Bartlett £2.

**NIGHTINGALE, Nicholas, son of Robert (above), born 1746 Wife Susanna, Elizabeth**

1777 Married Susanna Kemp

1778 Daughter Sarah

1787 His father left him his lands near Bowbeech (Slaters) but he alienated three parts out of four to his brothers Robert, William and Thomas.

1786-1809 Occupied Upper Gravel Pit Farm, tenant of John Warde.  
 1786-1812 Owned a quarter share in Slaters which he occupied.  
 1791 Overseer of Chiddingstone. Made several journeys on parish business.  
 1792 Surveyor of Chiddingstone.  
 1793 Death of Susanna.  
 1798-91 Occupied Harborough or Moorfields Farm at Bowbeece, tenant of heirs of Geer and Lynn. The farm had previously been occupied by his father Robert.  
 1802-04 Churchwarden of Chiddingstone.  
 1804-05 For keeping Thomas Collins 1½ years £3-18s.  
 1804 For hog fattening for the workhouse £5-17s-6d. 1805 For half a hog and other articles for the workhouse £8-2d.  
 1804 Overseer of Chiddingstone.  
 1806 He was paid £3-5s for keeping John King one year as per agreement.  
 1811-12 Churchwarden  
 1812 Death. Will (PCC).  
 To wife Elizabeth an annuity of £20 per annum. She was still alive in 1822.  
 His estate to his three brothers Robert, William and Thomas.  
 1814 Nicholas Nightingale has died leaving his fourth part of four parcels of land in Chiddingstone called Slaters (Tyhurst 1s 9½d) to his three brothers. Occupied by William Nightingale.

**NIGHTINGALE, William, cordwainer, son of Robert Nightingale (above). Wife Mary (Russell) See Edenbridge**

1783-1821 Sent in monthly bills for shoes for the poor. In 1785 total of £13-4s-5d. 1805 £2-3s-10d, £4-2s-8d, £3-5s-3d, £4-4s-6s, £3-4s-10d etc.  
*[There is no break in the cordwainer's bills so I assume that they all relate to this William; his son William may have worked under him]*  
 1782-1805 Rented part of Chiddingstone Burghersh Court House and garden from Henry Streatfeild. Also the milkhouse under the Brewhouse Chambers and the shoemaker's shop. Succeeded in 1805 by his son William. John Tye held three rooms called the Brewhouse Chambers.  
 1786 Daughter Fanny.  
 1789 Son Thomas.  
 1792 Son Samuel (qv).  
 1792 Paid £8-8s for taking Thomas Tippin apprentice.  
 1793 Overseer of Chiddingstone. Paid £1 for six days work on the parish accounts.  
 1794 Daughter Charlotte.  
 1794 His brother Nicholas had alienated to him a further share of four parcels of land in Chiddingstone (Tyhurst 1s9½d).  
 1796 Daughter Hester (qv).  
 1798 Daughter Maria (qv).  
 1800 Son Henry.  
 1802 Witnessed will of Richard Bevan.  
 1805 Churchwarden.  
 1807 Bought Hills and Walters alias Webbs Croft (Broxham 3s4d) in Edenbridge from Streatfeild. (Lockhurst Farm).  
 1809 He was paid £5 on account of Edward Jenner's trade agreement.  
 1810 (farmer) served on Grand Jury for Kings Borough (Quarter Sessions).  
 1812 Received a third share of the estate of his brother Nicholas. He occupied the land (presumably Slaters Farm).  
 1813 He was paid £3-18s for keeping Ann Fosset a year,  
 1814-1818 Occupied Slaters Farm.

**NIGHTINGALE, Thomas, son of Robert (above). Born 1751 Wife Ann**

1779 Married Ann Gasson.

1789 Witnessed marriage of John Gasson and Ann Colling.

1794 His brother Nicholas had alienated to him a fourth share in four parcels of land in Chiddingstone called Slaters (Tyhurst 1s 9½d).

1812 Received a third share of the estate of this brother Nicholas.

1819 Robert, William and Thomas Nightingale for Slaters (Tyhurst 1s 9½d). Later the premises became vested in Thomas alone.. By 1829 he was dead and was succeeded by his son Thomas.

1821 Death, at Leigh. Will (PCC).

**NIGHTINGALE, Thomas, cordwainer, born 1786, son of Thomas (above). Wife Susanna**

1806 Briefly rented a house in Sevenoaks and then briefly lived in Hastings before returning to Chiddingstone (Examination 1828).

1812 Married Susanna, daughter of Henry Eagleton, at Little Peckham.

1812 Occupied a cottage in Chiddingstone South.

1813-21 He sent bills to the overseers for shoes for the poor, succeeding his grandfather Robert. Eg £2-8s-10d, £3-8s-7d, £2-9s-5d, £1-19s-2d.

1814 Mentioned in the will of Henry Eagleton (PS 1816).

1814 He was paid £3-18s for lodging old William Hollamby.

1815 Son Thomas.

1815 Daughter Elizabeth (not baptized at Chiddingstone).

1815-1818 Occupied a house, probably in the village. ?Chiddingstone-Cobham manor house.

1815 Employed Philly Brown for a year.
