#### PETLEY, John, of Riverhead, gent – see Hever

1785 Ralph and John Petley held a messuage and lands called the Furnace Farm (Sundridge Upland 3s 4d). Ralph is recorded as having alienated his share to John by 1785 but is still recorded as the owner or the Furnace Farm in 1787 (Stanford Borough Land Tax) 1785-1792 John Petley owned Furnace Farm and Broad Hayes Mead, occupied by John Wildes.

1792 Death of John Petley of Riverhead, gent. His mother Elizabeth was his heir.

#### PETLEY, Elizabeth, widow of Charles Petley see Hever

1792 On the death of John Petley (above) his mother Elizabeth inherited Furnace Farm. 1792-1822 Mrs Elizabeth Petley owned Furnace Farm and Broad Hays Mead, occupied by George Wood.

## PETTIT, Mr

1809 He was paid £5-4s for keeping widow Fields one year.

1810 He was paid £3-6s for keeping Richard Field's boy 40 weeks.
