1806 Paid to the Sevenoaks officers two years of John Ridley's poor assessments. *[suggesting that Ridley owned land in Sevenoaks parish]*1809 Mr John Heath provided necessaries for John Ridley's wife who was ill £5-3s
1809 Mrs Goodwin was paid 18s 6d for nursing dame Ridley.
1809 To relieve the Ridley family for clothes £1-4s-1d.
1809 John Ridley's mother was paid 9s for nursing.
1809 Thomas Woollett was paid 16s 8d for things for John Ridley.
1809 To relieve John Ridley and family and for nursing his wife £6-1s-6d.

1810-11 John Heath supplied large amounts of necessaries for John Ridley's wife who was ill. 8s a month paid for nursing, at least sometimes by John Ridley's mother. Regular relief for John.

1812 To Mr Standing £5-6s for relief for Ridley's family. To Mr Morgan shoemaker for shoes for Ridley's family 11s 11d. A pair of shoes for Rebecca Ridley 6s 8d. To John Boakes 9s rent for Ridley's children. Other relief £5-17s

1813 Substantial relief for Ridley family including supplies from Mr Standing. Dame Goodwin for washing for John Ridley 6s.

1814 Supplies from Mr Standing. Bill from Mr Morgan, shoemaker 10s 2d. Bill from Mr Webb for the Ridley children £2-14s.

1815 Relief for the Ridley family. Pair of shoes for Ridley's girl 6s 9d.

1816-19 Samuel Coomber paid £26-11s for keeping Rebecca Ridley 194 weeks. Pair of shoes 7s 3d.

1819 Bills for Mary Ridley £1-4s-4d.

RIDLEY, William

1813 He was paid 17s 6d for keeping his nephew 7 weeks as per agreement. 1816 To relieve his family as per bill £2-16s *{he was probably supporting John ridley's children]*. Clothes for Ann Ridley £1-1s.

RING, Mr

1804 For articles for the workhouse 13s.

ROBERTS, William

1803 Provided clothes for young King 19s 10d.
