1767-1797 Occupied Hale Oak Farm, tenant of Woodgate.

1789 Witnessed will of Thomas Bellingham of Little Brownings.

1788 Witnessed will of Elizabeth Haynes.

1792 Occupied a farm, 22 acres, for sale (Maidstone Journal). The sale does not seem to have happened.

1797-1812 Widow Saunders occupied Hale Oak farm, tenant of Woodgate.

1802 Elizabeth Saunders witnessed the will of Thomas Older of Hale Oak (PS).

# SAUNDERS, Richard

1814-1818 Occupied Hale Oak Farm, tenant of Woodgate.

1810 Exchange between the trustees of Henry Smith esq deceased and Henry Woodgate. Woodgate grants Briggers alias Bridgers alias Hale Oak in Sevenoaks, Chiddingstone, Leigh and Penshurst to the trustees. Occupied by Richard Saunders, tenant from year to year. [The deed does not seem to have been executed].

1818 Occupied a farm in Sevenoaks, Chiddingstone, Leigh and Penshurst to be let to the highest bidder for 21 years. 137 acres.

# SAUNDERS, James, labourer. Wife Sarah

1790 Birth of his bastard son John Whale by Jane Whale.

1798 To relieve his boy (James Whale) 10s. George Longley was paid 9s for keeping the boy nine weeks. 1799 Relief for boy 4s.

1818 Daughter Elizabeth.

1815 Daughter Jane.

1815 For attending two nights at the Castle [Inn] 6s.

1816 Expense of removing him 10s.1817 To William Taylor for removing his goods 7s.

1816-18 Regular relief. 1818-21 Substantial relief and payment for working on the highways. Ill in 1818.

1818 his rent paid to William Acton £2-12s. William Acton carried his goods.

1821 Churching his wife and christening of his child 2s. Thomas Hider's wife paid for nursing James Saunders's wife 15s.

# SAWYERS, William Wife Sarah

1786-97 Paid £7-18s a month to run the workhouse (24 inmates)

1795 Received flour for two months from Richard Keeys £5-10s.

1797 On his death his widow Sarah continued to run the workhouse for some months.

1800 Sarah returned to the workhouse for three months and when she left she was paid 14s for the foodstuffs which she left behind.

# SAWYER, Ann

1788 Witnessed marriage of Richard Wood widower and Elizabeth Wood.

## SAXBY, John, of Hadlow, gent

1757-90 Owned Bradney Island in the far south of Chiddingstone parish. Probably the same as Aylands.

1782-1790 Owned Prinkham.

1790 John Saxby being seized of a messuage and divers lands called Prinkham occupied by John Everest (7s8d) has died. His son John is heir.

1790 Death. Will (PCC)

To son John Prinkham, 60 acres, in Chiddingstone and Withyham, occupied to his son Michael, a barn and 12 acres known as Aylands in Chddingstone near Chafford Bridge Mead now or late occupied by Sarah Streatfeild widow, and lands in Hadlow.

To son Henry lands in Cowden, Hadlow and Leybourne.

Daughters Elizabeth and Ann.

NB: Although John Saxby appears from the will to have rented Salmonds and Watstock, in the Streatfeild accounts Michael Saxby is the tenant.

1788-1790 John Saxby owned Bradley Island occupied by Sarah Streatfeild. This may be the same as "a barn and 12 acres known as Aylards".

## SAXBY, John, of Hadlow, gent, son of John (above). Wife Susanna. See Hever

1790 Death of his father John who left him Prinkham, 60 acres, in Chiddingstone and Withyham, occupied by Michael Saxby, and a farm and 12 acres known as Aylands in Chiddingstone near Chafford Bridge Mead occupied by Sarah Streatfeild widow. Also lands in Hadlow. The 12 acres known as Aylands is likely to be Bradley Island.

1791-1804 Michael Saxby is recorded as the owner of Prinkham.

1790-1815 John Saxby was the owner of Bradney or Bradley Island, in the far south of Chiddingstone parish.

1808-1815 John Saxby is recorded as the owner of Prinkham. However, 1806 John Saxby of Hadlow for a messuage and divers lands called Pinckham late John Saxby deceased, occupied by John Everest (Sundridge Weald 7s8d). Ditto 1812.

1820 Death. Will (PCC)

To brother Richard Saxby all that messuage with lands belonging called Prinkham Farm, 73 acres, in Chiddingstone and Withyham parishes, occupied by Richard Saxby. [However, the farm had already been sold; the will was written in 1809].

To brother Henry Saxby all that messuage situated in Penshurst and Chiddingstone, 35 acres, late in my own occupation and also all that messuage blacksmiths shop and garden lying rear Walters Green in the parish of Penshurst now or late occupied by ..... Moore. However by 1820 Henry Saxby was dead.

# SAXBY, Michael, son of John Saxby senior (above). Wife Sarah (1750-1836)

1782-1812 Occupied Prinkham, tenant of his father until 1790, and then presumably of his brother John.

1782-1812 Occupied Salmonds, Watstock and Hartsland Farms in Chiddingstone and Penshurst, tenant of Henry Streatfeild. Between 1801 and 1804 Richard Saxby was recorded as the tenant.

1782 Son Michael (not baptized in Chiddingstone).

1783 Son Charles (not baptized in Chiddingstone).

1785 Son John (not baptized in Chiddingstone).

1790 His father left him the tenancy of Salmonds and Watstock (which was not his to bequeath!) and £500. Also lands in Speldhurst and Penshurst.

1794-1804 Owned Oakenden, occupied by Edward Mitchell.

1796-98 Mr Saxby was paid the rent for William Pearless £3-3s a year. [It is not clear whether Mr Saxby is John or Michael]

1797 Borsholder of Frienden Borough.

1800-03 He was paid part of Henry Crundall's rent £2-2s. Also 1806 £3-3s

1803 He was paid the rent for Edward Gower £3-3s. Also 1806. Supplied Edward Gower with 200 faggots £2-12s.

1807 Served on Grand Jury.

1808 (of Penshurst). Death of his son Michael.

1810 He was paid the rent for Edward Pearless £3-7s-6d and Edward Gower £3-3s-0d. 1813 (farmer) Served on Grand Jury.

1819 (of Southborough) Death, aged 69 (monument).

# SAXBY, Michael, born 1782, son of Michael Saxby (above)

1808 Death, aged 26.

# SAXBY, Charles, born 1783, son of Michael (above)

1814-1815 With John Saxby succeeded Michael as the tenant of Watstock and Salmonds Farms, rented from Henry Streatfeild. From 1817-1842 Charles Saxby alone.

1815 (of Penshurst, farmer) Accused John Field of stealing corn from the farms of himself and his brother John in Penshurst and Chiddingstone.

1815 Supplied 31 stone of pork to the use of the workhouse £10-5s-6d.

1817 Mr Saxby and Mr Taylor took two days to fetch John Jenner's goods and wood £4. 1818-19 High Constable for the upper half hundred of Somerden. With William Taylor applied for a rate to reimburse them for money spent on bridges in the hundred of Somerden, Long Bridge, Waterlake Bridge, Hall Borough Bridge, Chafford Bridge.

1817 Supplied 15 stone 2lb of pork for the workhouse £3-6s-1d. Faggots for the poor £5.

1818 Reimbursed for relieving James Carden, William Comber and Richard Nye £5. 1819 (of Salmonds Farm, Penshurst) Jonathan Thompson of Henden Farm, Sundridge, wrote to him to complain about the bad state of the roads and to ask him to inspect them.(Quarter Sessions).

1819 Supplied wood and faggots for the poor £14-19s-3d. A fatt hog for the workhouse £11-2s.

1821 A bill to the overseers for relief provided for Comber £1-10s. (*continued*)

# SAXBY, John, born 1785, son of Michael (above). Wife Mary Ann

1816 Death of his son Michael in infancy (5 months).

1819 Death of his son Charles in infancy (10 weeks).

1814-1815 With Charles Saxby succeeded Michael as the tenant of Watstock and Salmonds Farms, rented from Henry Streatfeild. From 1817 Charles was the sole tenant apparently. 1815 He and his brother Charles lost oats from barns in Penshurst and Chiddingstone and accused John Field of being the thief. (Quarter Sessions).

1821 (of Penshurst) Death, aged 36.

# SAXBY, Robert, of Penshurst, gent, brother of John Saxby senior (above)

1794 Formerly occupied Pauls Grove alias Russells Croft (Chiddingstone-Burghersh 4d). Two parcels of land in Penshurst and Chiddingstone.

1799 Death. Will (PCC), written 1793, proved 1800. Aged 83.

To his natural daughter Sarah widow of Rev Vanderlure Mills late of Tonbridge clerk properties in Penshurst and Withyham and also all that customary or copyhold messuage or tenement in two dwellings with the farm, garden etc lying in Chiddingstone which I have surrendered to the uses of William Will[is}?. To my said daughter Sarah [location unknown]. His wife Mary had died in 1769.

## SAXBY, James

1794 Witnessed marriage of Robert Parker and Elizabeth Cole widow.

## SAXBY, Margaret Wyatt, spinster, of Oxted

1782-1788 Owned Lew Cross, which had been left to her by her aunt Mrs Wyatt. 1784 Lease of New Cross Farm to Richard Best for 21 years, 45 acres of £23 p.a. 1788 Will of Margaret Wyatt Saxby (PCC). She devised Lew Cross to her brother William Saxby.

## SAXBY, William, of Oxted, gent, brother of Margaret (above)

1788-1898 Owned Lew Cross which had been left to him by his sister Margaret (above). 1798 Sold Lew Cross to Henry Streatfeild.

#### SAXBY, William

1809 Witnessed will of Thomas Ware, farmer (PS). 1815 Witnessed will of William Cole.

## SAXBY, Richard, son of John Saxby senior

1790 Not mentioned in his father's will. 1820 His brother John left him Prinkham. However the farm had already been sold.

## SCOONES, Mr, attorney See Hever

1784 For parish business £8-3s.
1785 A bill to the overseers for £2-6s 2d.
1789 His bill on Sageman's account £31-3s-5d.
1782 Child in patients parish paid him £2,45s,4d.

1793 Chiddingstone parish paid him £8-15s-4d.

#### SCOTT, Thomas, shopkeeper, born 1775. Wife Mary – see Hever

1799 Married Mary Sweetman. Witness: James Kidder.

1801-1842 Owned the shop at the Hoath and also an apple orchard near Wellers Town belonging to Joseph.Langridge

1801 Son George.

1801-21 Regular bills to the overseers. In 1801 they totalled £37-14s-7d.

1803 For Richard Moore as per bill £2-12s-2d.

1803-04 For keeping Philly Hider he was paid £3-18s a year. Cloth for her £2-9s-1d.

1805 (of Chiddingstone, grocer) George Kidder left him £800 and a farm at Cowden Cross. 1807 Served on Petty Jury.

1808 He seems to have a connection with widow Colchin.

1808-09 He owned Oakenden, occupied by himself.

1809-1812 Borsholder of Frienden Borough. Indicted for not returning a list of freeholders liable to serve on juries.

1809 Constable of Somerden.

1809 Parish paid him part of John Jenner's rent £2-10s.

1813 Served on Grand Jury.

1814 Attended a meeting at Chiddingstone Castle of the inhabitants of Somerden hundred to discuss the costs of defending an indictment for not repairing Long Bridge.

1815 Two stolen posts found on his premises had been thrown over the hedge from the premises of his neighbour John Austen.

1816 (of Frienden Borough) Served on Grand Jury.

1820 Occupied Great Batts and Walnuttree Cross, tenant of Streatfeild.

1820 High Constable of the upper half hundred of Somerden.

1821 Overseer of Chiddingstone Parish paid him the rent for Edward Pearless £6 and Edward Jenner £5.

# SCOTT, George, born 1801, son of Thomas Scott (above)

1820 Putative father of a bastard child born to Elizabeth Jenner, singlewoman. Thomas Scott paid £20 recognizance. Order made. To pay 3s a week.(Quarter Sessions).
1821 George Scott paid £6 on account of Elizabeth Jenner's child. (*continued*)

1803 A bill for treating dame Neller £7.

## SCULLARD, George, esq. Wife Hester see Hever

1775 Death. He left Waterlakes Farm to his widow Hester.

1801 The manorial record is confused but in 1801 Waterlakes was possessed by John Perkins who was her half-brother. This is confirmed by the Land Tax records.
