1780-1829 Owned Castle Inn, Chiddingstone-Cobham Courthouse, Chiddingstone-Burghhurst Courthouse, Shop and Farm, Larkins, Lockskinners, Highfields, Tower Hill, Hill Hoath lands, Willetts, Hill Hoath House (TA430), Hunts, Burghurst, Gilwyns, Tyehaw, Tyehurst, High Street House, Millbrook, Smithyhams or Horseshoe Farm (part of Millbrook), Somerden Green Farm, Bore Place South, Blue Boar alehouse, Red House land, Sliders Bridge, Hunts, Brookestreet and Chandlers (in Penshurst), Coles, Watstock, Salmons, Truggers, Geers, Skinners or Corner Farm, High Buckhurst.

1790 His mother Ann Streatfeild widow had alienated Waterlakes to him (Sundridge Weald 2s 6d). According to a map of Millbrooks

Farm dated 1798 Henry Streatfeild owned Waterlakes in that year. However, the Land Tax records have widow Scullard owning it until 1797 and she left it to her step-brother John Perkins who owned in until 1827.

Ann Streatfeild widow had alienated Allens or Hickens, part of Coles, to Henry by 1790. 1794 Henry Streatfeild had acquired Kings Farm from Sarah Streatfeild but about 1806 he sold it to Robert Lipscomb.

1794 Henry Streatfeild occupied Bradley Island, tenant of Saxby, but gave it up in 1801.

1797 Henry Streatfeild had bought Great Batts from Thomas and John Driver.

1799 Henry Streatfeild had bought Wilderness from Mrs Lydia Woodgate. Also New Tye, which became part of Great High Street Farm.

1801 Henry Streatfeild had bought Wallnuttree Cross from William Camfield and combined it with Great Batts.

1801 Henry Streatfeild had succeeded Mrs Streatfeild at Bourn Mead and Clover Mead, part of Chandlers in Penshurst.

1801 Henry Streatfeild had bought Lew Cross from William Saxby.

1805 Henry Streatfield had bouight Seedcombes from Stephen Woodgate.

1806 Henry Streatfeild had bought Skipread from William Piggott.

1806 Henry Streatfeild had bought Guildridge from Stephen Woodgate; the farm was later merged with Watstock.

1811 Henry Streatfeild bought Clouts Farm from John Legg.

1811 Henry Streatfeild had bought Chested (in Penshurst) from Woodgate.

1813 Henry Streatfeild had bought Chiddingstone Mill Farm from the heirs of Sandeforth Streatfeild.

1814 Henry Streatfeild had bought Harboro Farm from Joseph Huffam..

1778 For a messuage formerly William Goldsmith (Sundridge Weald 11/2d). 1790 she had alienated the messuage to her son Henry Streatfeild.

1778 For certain lands purchased of John and Thomas Hollamby (Sundridge Weald 2s 4d). 1790 she had alienated the lands to her son Henry Streatfeild.

1778 For one messuage and 3 acres and one road in Milbrooke Mead (Sundridge Weald 6d). 1790 she had alienated the messuage to her son Henry Streatfeild.

1778 For part of Knowlands (Sundridge Weald 5d). 1790 she had alienated it to her son Henry Streatfeild.

1778 Half an acre of meadow called Close Mead (Sundridge Weald 1d). 1790 she had alienated it to her son Henry Streatfeild.

1778 Scotland Reed (Sundridge Weald 1s). 1790 she had alienated it to her son Henry Streatfeild.

1794 For two parcels of land called Pauls Grove alias Russells Croft 3 acres in Penshurst and Chiddingstone, now alienated to Henry Streatfeild (Chiddingstone-Burghurst 4d). 1812 Death at Uckfield.

1812 When Sarah Wakefield died she left Chiddingstone Mill to the heirs of Sandeforth Streatfeild, who sold it to Henry Streatfeild.

### STREATFEILD, Sandeforth, of Long Ditton See Hever

1809 Death. His heirs were left Chddingstone Mill by Sarah Wakefield in 1812; they sold it to Henry Streatfeild.

1813 Sale of his lands in Tonbridge, Seal, Leigh, Chiddingstone, Penshurst, Edenbridge, Cowden, Hever and Wadhurst including a substantial brick residence called Holdens in Southborough.

### STREATFEILD, Mrs

1788 Had succeeded Thomas Streatfeild esq in the ownership of Bourn Mead and Clover Mead, part of Chandlers Farm, Penshurst.

1801 Henry Streatfeild now owned the properties.

### STREATFEILD, Mrs Jane

1796 Death.

### STREATFEILD, Harriet, wife of Rev Thomas Streatfeild

1814 (of Long Ditton) Death, aged 38.

### STREATFEILD, John, of Penshurst, gent. Wife Sarah

1785 His widow Sarah owned part of Pilbeams (Sundridge Weald 2s 6d) and a meadow containing 3 acres called Chafford Bridge (6d). This is Kings Farm, part of Walters Green Farm, Penshurst.

1796 Sarah had died. The premises were to descend to Henry and John Streatfeild, sons of John, but John had died so Henry became the heir.

1782-1790 Sarah also occupied Bradley Island, tenant of John Saxby and Tophill and Eelpars, tenant of Francis Woodgate.

John Streatfeild of Walters Green died 1779, aged 45. His wife Sarah died in 1792. Issue: Elizabeth and Henry.

# **STREATFEILD, Henry, son of John Streatfeild (above, born 1773. Wife Elizabeth** 1792 On the death of his mother Sarah he inherited Kings Farm, part of Walters Green Farm, Penshurst.

1806 The memorial record has William Streatfeild son of John Streatfeild of Walters Green for part of Pilbeams (Sundridge Weald 2s 6d) and a meadow containing 3 acres called Chafford Bridge (6d). There is a footnote "later Henry". According to the Land Tax and Overseers records Henry Streatfeild owned Kings Farm until 1806. It was advertised for sale in 1803.

# STREATFEILD, Thomas, of Sevenoaks (1718-1802). Wife Jane See Edenbridge, Hever

1752-1802 Owned Hilders Farm.. On his death he devised it to his son Henry.

# STREATFEILD, Henry, of Sevenoaks, son of Thomas (above) See Hever, Edenbridge

1802 On the death of his father Thomas he inherited Hilders.

1817 Death. He left Hilders to his sister Catherine, wife of Thomas Lightfoot.

### STREATFEILD, Robert

1784-87 Living at Wrotham. With his wife and children he received substantial relief from Chiddingstone. 1788 Letter to Wrotham.

1790 To Mr Tomlin for relieving him and his wife £19-7s. to John Streatfeild for keeping his mother 11 weeks 16s 6d. 1790 Burial of widow Streatfeild £1-1. [It is not clear if we are referring to the same widow Streatfeild at Wrotham]

1791 Relief for widow Streatfeild.

1797-1826 Occupied Vexour, Cowlards and Breaches.

1806 Supplied peas to the workhouse £2-17s. 1808 Four bushels of peas for the workhouse £1-10s.

1808 Supplied 50 faggots and half a cord of wood for William Waite £1-10s.

1811 Supplied half a load of bushes for the workhouse garden 6s.

1814 Attended a meeting at Chiddingstone Castle to consider the cost of defending an indictment for the non-repair of Long Bridge.

1789 Witnessed marriage of Thomas Gunner and Mary Russell.

1791 Borsholder of Frienden Borough.

1791 Daughter Ann who died in 1794 (a child).

1791 For writing paper 6d. For writing the parish accounts for two years £4-4s. For writing the workhouse inventory 1s 6d. For several journeys on parish business 8s. To William Taylor for the pargements and writing the workhouse accounts and for writing paper 3s.

There were similar payments to him each year until 1796 as he was the parish clerk.

1792 Provided writing paper for the use of the vestry 6d.

1793 Son Charles.

1793 Borsholder of Kings Borough. Paid for burial fees for David Turner and a journey to Wandsworth 7s. Paid for registering Hannah Hurrion's child.

1794 Paid 1s 6d for three easy reading [materials] for the use of the children in the workhouse. For one day attending the sitting 2s 6d. [There were many such payments but they were not usually recorded against a name in the accounts].

1795 For writing advertisements and going about with them respecting a man for the navy 4s

1796 Daughter Sophia who died in 1797 (a child).

1796 For writing John Osborne's agreement 1s 6d. Journey attending sitting *[ie sessions]* 2s 6d. for a warrant 2s. For horse and cart 3s. Turnpike gates 1s. Expenses with Ann Perch 1s. Salary £4-4s a year.

1797-1821 Annual salary of £4-4s as vestry clerk. Kept the accounts of the church, overseers, and workhouse. Provided writing paper. Several bills for spinning eg 1797 £2-2s [Possibly spinning of flax in the workhouse]. Writing inventory of Edward Collins 1s 6d.

1797 Witnessed will of James Blackwell.

1798 Son Robert who died in 1799 (a child).

1800 Daughter Mary.

1800 Death of his wife Mercy.

1800-01 Considerable relief for his girl.

1801 He was paid £1-5s for keeping Anna Adams 25 weeks. 1802 He kept Sophia Hurrion 70 weeks £4-19s

1802 Witnessed marriage of James Gibb and Mary Muggridge.

1802 He was paid 10s 6d for a bond and writing on account of David Lawrence. For writing Thomas Smith's indentures 2s 6d and journeying to Sevenoaks on account of this 2s 6d.

1804 Constable of Somerden in place of Richard Keeys. He also served as borsholder for Stanford Borough in place of John Gasson. Expenses £3-4s. For going round the parish for two days taking account of stock he was paid 4s 4d.

1805 Paid for a journey to Hastings on parish business 5s. Journey to Sevenoaks to attend the sitting 2s 6d. One day going to Staplehurst 2s 6d.

1805 Writing workhouse inventory, going to Withyham, paid for letters 6s 3d.

1806 (clerk of Chiddingstone) Witnessed marriage in Hever of William Chapman and Harriet Dawes.

1806 For a journey to Sevenoaks 13s. Writing paper for assignment books and letter 1s. Journey to Sevenoaks 2s 6d. Attending sitting at Sevenoaks 2s 6d.

1806-09 High Constable for the Upper Half Hundred of Somerden. As Constable he made a journey to Speldhurst serving notices on the parish officers and making return of copy of the notice at Maidstone, plus court fees 7s 6d. William was still Constable in 1809. In 1806 he put in a claim for a rate to be levied to reimburse him for money expended on repairing several bridges.

1806 Journey to Withyham and expenses 3s 6d. To William Taylor for taking Joseph Brown and attending him two days and two nights 7s 6d.

1807 For serving a warrant on John Austen and attending him 5s. Letter to him !s 9d.For a memorandum book and writing paper 1s.

1807 For filling up the militia precept, writing militia list, journey to Sevenoaks on account of the militia 6s. Three journeys to Maidstone, Sevenoaks and Fletching on parish business 7s 6d. Journey to London 5s. Signing the assessments and oaths on the militia account and journey and expenses 10s 6d. Journey to Sevenoaks 3s 6d.

1808 Burial fees for two people from the workhouse, letter, journey to Sevenoaks, signing a poor assessment and expenses 5s 6d, Expenses going to Maidstone, what he paid on the road at Maidstone, and the post boy 17s 11d. For getting £30 at Maidstone 10s 6d. Letters from Wingham and Ticehurst 1s 9d. For serving a warrant on Joseph Hider and attending him to Mr Allnutt. Journey to Pembury and expenses 4s 6d. For transacting the militia business and a journey to Sevenoaks 7s. Oath swearing to the militia list 7s. 1808 Witnessed will of William Carrett.

1809 For taking up two travellers and conveying them to Maidstone Bridewell 10s. Three journeys to Sevenoaks, writing the militia list and delivering out the militia precepts £1-1s. For writing paper and an almanack and for a letter 4s.

1809-1824 Occupied a cottage in Chiddingstone South.

1810 Two journeys to Sevenoaks on account of the local militia 5s. Journey to the paper mill taking account of William Ballham's goods 1s 6d.

Journey to Sevenoaks with John Young to settle his parish 2s 6d. For the days going with Mr John White and Mr John Moon in valuing Chiddingstone parish £2-2s. Journey to Brenchley 2s 6d. Journey to Sevenoaks on parish business 5s. Writing the militia list and filling up the papers 2s 6d. Delivering out the militia duplicates for one day 2s.

1811 Journey to Sevenoaks 2s 6d. For two days going round the parish to take an account of the population and one day to Sevenoaks with the account 7s 6d. Copy book for the population account 1s. For a sow and pigs sent to the workhouse £5.

1812 Expenses going to the sitting at Sevenoaks 7s 7d. Journey to Sevenoaks twice 5s. Journey to Maidstone and horse 12s 6d. He was paid £15-5s for the composition for two years' tithe.

1813 He was the collector for the year's Property Tax on the tithes of the south and the north of Chiddingstone parish. Repeated in 1814.

1813 For writing all the Militia papers and lists10s. One day delivering out the Militia papers 2s 6d. Journey to Sevenoaks on militia business.

This was repeated in 1814, 1815, 1816, 1817., 1818.

1813 Journey to Rusthall and Blackham 2s 6d

1813 High Constable for lower half hundred of Somerden. With Michael Woodhams he applied for a bridge assessment at 1s in the £ to reimburse them for money laid out in building a new bridge at Waterlakes, Chiddingstone, and also repairing three other bridges at Penshurst.

1814 (senior) Witnessed will of Henry Eagleton, schoolmaster.

1814 Witnessed will of Richard Gasson.

1814 Journey to Sevenoaks 2s 6d. Journey to Sevenoaks and expenses 5s.

1815-1821 High Constable of the lower half hundred of Somerden. Applied for a rate of 10d an acre for the expense of repairing several bridges.

1816 Applied for a rate for the repair of Sliders Bridge in King's Borough.

1817 Mr Taylor and Mr Potter going to Oxted £1. Journey and expenses going to Chatham £1. Three journeys to the sittings at Sevenoaks 15s.

1818 He applied for a rate to be imposed on King's Borough for money disbursed in repairing the Great Bridge near Chiddingstone Mill. He also applied for a rate to be levied to reimburse him and Charles Saxby for money spent on repairing Long Bridge, Waterlake Bridge, Hall Borough Bridge and Chafford Bridge. 1820 Similar for two bridges near Somerden Mill.

1818 Journey to Sevenoaks on John White's business 5s. Serving a summons 5s. Journey to Sevenoaks to the sitting twice 10s.
