1795 Death.

#### WATERS, Martha

1790 Married William Eastward. Witness: John Waters.

#### WATERS, John

1790 Witnessed marriage of William Eastwood and Martha Waters.

#### WATERS, Elizabeth, born 1798

1817 Base daughter Eliza.

1817 Carey Huntley prosecuted for giving her a female bastard child.

1817 Married Carey Huntley. Witnesses:Thomas Wickenden, Ann Wickenden.

#### WATERS, Samuel

1780-1794 Occupied Blackbaldock, tenant of John Avis.

## WATERS, William

1806 Owned half an acre part of Winkhurst Green (Sundridge Upland 2d).

1812 Executors of James Hodsoll had it.

## WATERS, William, of Penshurst, carpenter

1815 Working at Bassett's Mill farmhouse. Identified a stolen oaken rafter. (Quarter Sessions).

## WATERS, Ann

1795 Married William Fielder of Chiddingstone at Penshurst.

## WATERS, Elizabeth

1796 Married John Kingswood of Chiddingstone at Penshurst.

#### WATKINS, Dr

1796 For the cure of Jane Billions £6-6s.

## **WATTON**, Thomas

1817 He was paid £3-18s for keeping Sophia Carter a year.

## WEBB, Robert, labourer. Wife Maria

1818-1819 Hired himself to Mr Fry of Chiddingstone, farmer. Then married Maria. (*continued*)

## WEEKS, William

1804-1832 Owned Polbrooks Farm, occupied by Wood.
