1789 Henry Streatfeild gave French Mead to Rev Thomas Harvey, occupied by William Wicking.

[These two statements appear to be incompatible].

1794 He supplied two bushels of peas for William Langley 1s.

1797 William Wicking agreed to hire the acre in Bourn Mead (part of Watstock) from Michaelmas 1797 at 21s per annum. (Henry Streatfeild).

1797 Witnessed will of John Gibb.

## WICKING, Thomas – see Hever, Edenbridge

1799 (of Chiddingstone) Married Ann Jeale at Hever. Witness: John Ingrams.
