1754 Death of Jane Cackett of Sundridge, widow. Will (PS) Her heir was her son-in-law Edward Wickenden.

1748 John Carwardine of Hartfield, leased Doubletons farm in Penshurst (including Marshope Mead in Chiddingstone) from William Perry for 21 years.

1749 to 1777 John Carden occupied Doubletons farm. He was succeeded in 1777 to 1804 by his son John.

1758 Thomas Carden of Penshurst married Elizabeth Bonner. Witness: Thomas Rogers.

CARDEN, William, of Penshurst, wife Sarah

1751 He witnessed sale of Willmore Land Johnson to Harvey.

CARTER, alias WELSH, Elizabeth

1778 An illegitimate child aged 7. Has intruded into Chiddingstone. To be sent back to her home parish in Canterbury.

CAVENDISH, Henry James, wife Mary, travellers from Boston in New England.

1760 Son Henry

CHALKLIN, Henry

1733 Witnessed a lease Cronk to Ovenden, concerning a cottage in Penshurst.

CHALKLIN, William

1743 There was a case at the Court of arches between William Chalklin and Abraham Floyd concerning the will of John Floyd.

CHAMBERS, Amy?

1785 Witnessed marriage between Joseph Brown of St Giles, Camberwell and Frances Lucas

CHAMP, Joseph, of Chiddingstone, tanner

1778 Reputed father of a bastard boy born of Mary Tye of Brasted. Ordered to pay 40s lying in costs and 2s a week in future.

CHAPMAN, Thomas

1737 Death

CHAPMAN, Thomas, son of Richard Chapmam, yeoman, who died in 1732.

1733 Richard Chapman in his will (PS) left his leased farm (Bergherst farm or Hunts) to his sons Thomas and Richard. He also left them Riddens and Sliders Bridge.

1733 to 1745 Thomas and Richard Chapman owned Riddens and Sliders Bridge, and occupied Burgherst farm.

1735 to 1736 Overseer of Chiddingstone parish.

1738 Thomas and Richard Chapman bought Bridgefields from George Cronk.

1741 Churchwarden.

1745 Death

CHAPMAN, Richard, son of Richard Chapman who died in 1732.

1733 His father left him £12, paid by his brother Thomas

1733 to 1745 Thomas and Richard Chapman owned Riddens and Sliders Bridge and occupied Burgherst farm (Hunts). 1745 to 1747 Richard alone.

1738 Thomas and Richard Chapman bought Bridgefields from George Cronk.

1747 Death. Will (PCC). To Mary Ann and Elizabeth Smith, daughters of Joseph Smith gardener £20 each. Witnesses: Richard Wyatt, George Bevan, Henry Whapham. He left Riddens and Sliders Bridge to Joseph Smith and Ann his wife and afterwards to their daughters Mary, Ann and Elizabeth.

CHAPMAN, William, son of Richard Chapman who died in 1733.

1733 His father left him a share of Sliders Fields, Riddens, Bridge Fields etc but he was then living in London Town, Maryland, America.

1751 He sold his interest in the above lands to Ann Streatfeild.

CHAPMAN, George, wife Elizabeth

1737 Carried out a survey of Chiddingstone-Cobham Manor house to see what repairs were necessary.

1740 Death of wife Elizabeth

CHAPMAN, John, wife Elizabeth, travellers from Berry in Sussex

1766 Son James

CHAPMAN, Benjamin, wife Sarah

1771 Benjamin Chapman, bachelor, married Sarah Hills of Hartfield. Witnesses: William Tulley, John Faulkner?

CHAPMAN, John, wife Elizabeth

1776 Son Joseph

CHAPMAN, James

1773 James Chapman, bachelor, married Elizabeth Ireland of Tonbridge. Witness: Samuel Beeby

CHAPMAN, Daniel, of Hever, wife Elizabeth

1770 Witnessed marriage of John Cooper and Sarah Inkpin at Hever

1784 Daniel Chapman, bachelor, married Elizabeth Moyes of Chiddingstone..

CHILDREN, Arthur, of Riverhill, Sevenoaks, gent, wife Alice, the daughter of John Woodgate

1733 to 1737 Owner of Hale Oak in Chiddingstone, Sevenoaks, Penshurst and Leigh.

1738 Will (PCC) To cousin Matthew Parker of Brasted £10 per annum out of Bridgetts at Hale Oak in Sevenoaks, Leigh, Penshurst and Chiddingstone. He left Hale Oak to his wife Alice.

CHILDREN, Alice, of Tonbridge, widow

1737 to 1768 she owned Hale Oak in succession to her husband Arthur Children.

1769 Will (PCC) To brother John Woodgate of Stonewall, Chiddingstone, gent, £200. To sisters Rose, married to George Swayne of Hadlow, and Ann Woodgate lands called Hale Oak. The sisters appear to have left the Hale Oak to their brother Henry Woodgate.

1761 Thomas Harvey of Tonbridge esq exchanged Gunnell Mead with him for Barrett Mead.

1780 to 1808 He succeeded Thomas Harvey as the owner of Moorden farm.

1780 to 1808 Owner of Wickhurst in Leigh and Chiddingstone.

CHITTY, Richard, wife Margaret

1751 Richard Chitty married Margaret Boakes

1761 Relief for Chitty's wife. 4s.

1756 to 1789 Tenant of Hoskins for Henden farm mostly in Sundridge and Brasted parishes. Thomas Cogger was mentioned in 1759.

COLCHIN, John, wife Ann from Bucksted, Sussex

1770 Isaac Colchin, bachelor, married Elizabeth Gunner. Witness: Edmund Bridge

1771 Son John. In 1784 William Wicking was paid 1s a week for keeping him three months.

COLE, John, of Chiddingstone, butcher, yeoman, wife Sarah

1716 John Cole inherited from his father William Cole a messuage and 4 acres situated in Chiddingstone called [Little] Hilders.

1723 to 1743 John Cole for a tenement and backside and 5 acres of land over against Hilders. (manor of Sundridge Weald).

1735 to 1737 Overseer of Chiddingstone.

1737 Served on Petty Jury. 1743 (of Kingsborough) Served on Grand Jury (Quarter Sessions)

1746 Death of Sarah Cole

1748 (of Kingsborough) Summoned to serve on the Petty Jury but he did not turn up. Fined £1. (Quarter Sessions)

1749 The heirs of Edward Cronk had alienated Clinton Brook alias Birchhurst to John Cole.

1751 Death. Will (PS) written 1732. To son William his messuage near Hilders. Annuity to wife Sarah. Witnesses: Robert Combridge, Edward Holmden, Robert Farmer

COLE, William, son of John Cole above, wife Ann,

1746 Son John, who witnessed the marriage of William Cole and Mary Potter

1747 Son William. See below

1749 Daughter Ann

1751 On the death of John Cole his son William inherited Clinton Brook which he retained until his death in 1795.

1752 John Cole who held a tenement and 5 acres of land over against Hilders has died. The premises descended to William Cole his only son. (manor of Sundridge Weald).

1738 Witnessed sale of Bridgefields Cronk to Chapman.

1738 John Constable of Penshurst, mercer, only son of Henry Constable of Penshurst, mercer, long since deceased, and Joan his wife also deceased who was formerly Joan

Piggott to Elizabeth Saxby of Penshurst, spinster, for £490-11s: All that messuage etc and parcels called Shippencrofts, Little Shortlands, Shortland Wood, Mead Plot, Beare Crofts, Highfield, Highfield wood, 44 acres in Chiddingstone, occupied by William Cronk.

CONSTABLE, William, wife Sarah

1741 His sister Susan Sanders of Tonbridge, widow, left him property. (Will Dra)

1744 Death . Will (PS) written in 1739. Bequests to four daughters of Thomas Pearson of Penshurst, his brother-in-law, to sister Susan Sanders of Tonbridge, to sister's son John Tye. Witnesses: Elizabeth Floyd, Robert Farmer

1713 William Cowlard holds a third part of Barnefields, Tyceherst and Smithiams in Chiddingstone occupied by Edward Shoebridge. (manor of Chiddingstone-Cobham).

1723 William Cowlard for a house in Hail Lane occupied by Edward Shoebridge and Fortunatus Terry.

1745 Death.,

COWLARD, John

1745 He succeeded William Cowlard for a share in Barnfields, Tyseherst and Smithiams. (manor of Chiddingstone-Cobham)

1752 Mrs Cowlard for the property.

COWLARD, William of Seal, wife Anne

1756 to 1760 Owned a share in the above property. Died in 1769. He was the father of John Ciowlard of Under river, Seal

COWLARD, John of Under River, Seal, yeoman. Wife Sarah.

1761 He sold a messuage and five parcels called Squires Crofts, 20 acres in Chiddingstone and Penshurst to Thomas Harvey of Tonbridge.

COX, Henry, of Chiddingstone, butcher

1739 Death, a bachelor. Will (PS), written in 1732. He left a messuage and orchard at Rendsley Hoath to his nephew Henry Cox of Eynsford, butcher. To nephew Samuel Arnold of Chiddingstone £40. However both nephews predeceased him. George Pawley of Ightham administer the will. The estate passed to Henry and Joseph, the sons of Henry Cox of Eynsford, butcher after the demise of Mary, widow of Henry Cox of Eynsford,, but she did not die until 1794.

COX, Henry, of Eynsford, butcher, wife Mary

1732 Henry Cox of Chiddingstone wrote a will (PS) leaving his messuage and orchard at Rendsley Hoath in Chiddingstone to Henry Cox of Eynsford, butcher. However he did not die until 1739.

1737 Death. In 1739 the messuage and orchard passed to his sons Henry and Joseph, after the death of his wife Mary.

1739 to 1780 Widow Cox held the messuage and orchard.

1779 Henry Cox died transferring his interest in the messuage and orchard to his brother Joseph.

1793 Death of Joseph Cox of Farningham intestate. He possessed the whole of the Stokehaw and Renneslegh Hoath estate which passed to his widow Elizabeth.

1794 Death of Mary Cox.

CRANWELL, James. of Chittingden in Hever, wife Mary

1713 to 1733 Occupied Chittenden, tenant of Samuel Kent. He was succeeded by widow Cranwell.

1715 Mary Cronk bequeathed to Mary, daughter of George Cronk of Penshurst husbandman £5. To his sons John, Henry, Michael and William 10s each.

1720 Death. Will (PS) Sons John, Thomas, George, William, Henry, Richard, Edward. Daughter Mary.

CRONK, John

1737 Death

CRONK, John, of Bowbeeche, carpenter, wife Elizabeth. Probably son of George Cronk, above

1695 to 1735 He owned Butt House with a forge.

1700 Robert Medhurst who held half an acre near Clinton Brooke in Chiddingstone had aliened it to John Cronk. (manor of Chiddingstone-Burghersh).

1700 to 1735 John Cronk owned Birchhurst alias Clinton Brook. He also owned a messuage and lands at Bowbeeche part of Sheffield. (manor of Hever Brocas). This appears to be Bartons farm.

1713 Henry Streatfeild sold to John Cronk Bridgefield and coppice, 10 acres, in Chiddingstone.

1721 John Cronk for six acres lying between Bower Pitts and Clinton Lands (manor of Millbrook).

1727 John Cronk holds Bridgefield now in two, near Sliders Bridge, occupied by himself. (manor of Chiddingstone-Cobham).

1728 Employed Ann Parsons for a year (Quarter Sessions).

1734 Leased a cottage in Penshurst to Samuel Ovenden of Worth, Sussex, cordwainer for 21 years.

1735 Death. Will (PCC) To wife Elizabeth property in Penshurst and Chiddingstone including a messuage and 6 acres in Chiddingstone occupied by John Cronk and Thomas Kingswood, remainder to son Edward. To son George Hay Croft, 5 acres, and a messuage and 11 acres in Chiddingstone. Also Bridgefields and coppice. To son Henry a messuage and shop in Edenbridge. To son William a messuage and shop in Chiddingstone occupied by Robert Palmer. John's daughter Elizabeth was married to Simpson Jeffrey, to whom a messuage and shop in Edenbridge. To daughter Susan £100 so long as she is not married to John Upton of Chiddingstone, turner. To son Robert his debts forgiven. Witnesses: Thomas Freebody, Mary Freebody, Edward Saxby.

1740 Death of Elizabeth, widow

1764 Edward Cronk and others the heirs of John Cronk deceased being seized of half an acre of land near Clinton Brook occupied by William Ware have alienated the same to John Cole, who has since died. (manor of Chiddingstone-Burgherst).

1735 His father left him a messuage and shop called Snowhill in Edenbridge, remainder to his daughters Elizabeth and Sarah.

1725 to 1743 He owned a house and land at Rendsley Hoath.

1730 Daughter Elizabeth (of Rendleys Heath)

1735 In his father's will he would receive the remainder after Elizabeth of a property in Penshurst provided that he had not married Sarah Barnaby of Chiddingstone, spinster. He inherited Butt House with a smith's forge occupied by Robert Palmer.

1735 Daughter Mary who married Thomas Humphrey in 1766. Witnesses: William Welfare, Mary Welfare

1737 Occupied Shortlands or Lew Cross, tenant of Constable

1738 His brother George left him and Robert Haycroft which they presumably sold to widow Lee.

1738 He sold Butt House with the forge to Henry Streatfeild.

1735 George mortgaged Bridgefields to his sister Susanna Cronk.

1738 George sold Bridgefields to Thomas and Richard Chapman of Chiddingstone.

1738 Death. Will (PS). Left Haycroft to his brothers William of Chiddingstone, carpenter, and Robert of Edenbridge, tanner. £5 to brother Edward; 1s to brother Henry. Witnesses: William Winter, Thomas Moyse, Robert Farmer

CRONK, Ann

1758 She married Nicholas Smeed. Witness: Silvanus Smile

CRONK, Elizabeth, possibly daughter of Edward Cronk junior
