Will (PCC) .He bequeathed to his son William all his real estate in the parishes of Cowden, Chiddingstone and Chevening, His lands appear to be a freehold farm called Bassetts situated in Cowden and Chiddingstone, 171acres of rich meadow, pasture, arable and woodland, with a good farmhouse, four barns granary and other convenient buildings. (Advertisement in Maidstone Journal 1811)
