

FALCONER, Henry

1745-46 Occupied Shop farm, tenant of Streatfeild

FARMER, Robert

1732 Witnessed will of John Cole

1733 Witnessed a lease Cronk to Ovenden, concerning a cottage in Penshurst.

1737 Witnessed will of Thomas Wallis.

1738 Witnessed will of George Cronk

1739 Witnessed will of Thomas Cooper

1742 Death

FARMER, William, of Sevenoaks. Wife Susanna

1762 William Farmer married Susanna Stacey. Witnesses: William Stacey, Mary Rey

FARNABY, Sir Thomas

1747 to 1760 Sir Thomas Farnaby owned Ivy House (Sleighters als Theobalds) in Chiddingstone, bought from Hyde. John Moon tenant.

1749 Sir Thomas leased Sharpe's Place to John Boakes of Chiddingstone, farmer. 130 acres in Chiddingstone, Sevenoaks and Chevening.

1750 A moiety of Sharpe's Place and Ivy house was mortgaged to John Hyde of Cheapside, hardwareman..

1755 Saville Hyde had devised Sharpe's Place to him. (manor of Bowzell).

1760 Sir Thomas was succeeded by his son Charles Farnaby. (manor of Bowzell).

FARNABY, Sir Charles of Keppington, Sevenoaks, bart, son of Sir Thomas Farnaby. He was MP for East Grinstead, later For Kent. He took the additional name of Radcliffe.

1760 to 1798 He owned Ivy House farm alias Sleighters als Theobalds, in Chiddingstone.

1770 ivy house farm leased to Churchman Field and Joseph Potter.

1778 Ivy House farm was mortgaged to Mr James Wooden of Otford.

FAULKNER, John ?

1771 Witnessed marriage of Benjamin Chapman and Sarah Hills of Hartfield

FAULKNER, Widow

1733 to 1737 She owned Chafford Bridge Mead, together with Robert Curd.

FAULKNER, George, of Penshurst, maltster. Wife Sarah

1743 Robert Curd bequeathed Chafford Bridge Mead to him. (manor of Sundridge Weald)

1751 Will (PS) , He left Trubshole in Penshurst and Chiddingstone to his wife Sarah. This seems to include Chafford Bridge Mead.

1752 Sarah Faulkner , widow, married Nicholas Locke, of Sevenoaks, widower, at Penshurst

1771 Sarah, wife of Nicholas lock, is dead, seized of a meadow containing 3 acres called Chafford Bridge, late George Faulkner. (manor of Sundridge Mead).

FIELD, Churchman of Chiddingstone, farmer

1770 Lease of Ivy House farm from Sir Charles Farnaby to Churchman Field and Joseph Potter. No further reference to Churchman Field.

FINCH, John, wife Katherine, of Chaldon in Surrey

1769 Son Joseph Boak

FINCH, John, of Edenbridge, wife Elizabeth

1784 John Finch, bachelor, married Elizabeth Woollett. Witnesses: Thomas Woollett, Ann Taylor

FIVEASH, Edward, wife Mary

1761 Married Mary Kingswood: Witness: Richard Saxby

FLETCHER, widow

1759 Occupied Bushes farm in Chevening and Chiddingstone, tenant of Hyde.

FLETCHER, William

1762 to 1765 Occupied Bushes farm in Chevening and Chiddingstone, tenant of Hyde.

FLETCHER, Solomon, of Sundridge, gamekeeper

1782 John Hyde, lord of the manor of Sundridge Weald, appointed him gamekeeper in the manor.

FLINT, Edward, wife Elizabeth

1776 Son James

FLOYD, John of Chiddingstone, yeoman, wife Sarah, Elizabeth

1728 Will (PCC) To son Abraham my messuage containing two dwellings at Coopers Corner occupied by John Nye and John Moore.

1737 Sarah Floyd, widow, witnessed will of Thomas Wallis.

1738 Sarah occupied a messuage and 11 acres in Chiddingstone belonging to George Cronk

1739 Sarah witnessed will of Thomas Cooper

1743 There was a case at the Court of Arches between William Chalklin and Abraham Floyd concerning the will of John Floyd of Chiddingstone.

1744 Death of Elizabeth Floyd, widow

FLOYD, Abraham, of Hever, son of John Floyd above

1728 Inherited a messuage containing two dwellings at Coopers Corner.

1743 There was a case at the Court of Arches between William Chalklin and Abraham Floyd concerning the will of John Floyd (above).

1778 He had alienated a messuage and orchard at Coopers Corner to Samuel Beeby. (manor of Sundridge Upland).

FORD, John , of Leigh, wife Mary

1723 Married Mary Busbridge.

1736 Death of wife Mary

FRAIR, Martha

1776 Martha Frair, spinster, married Thomas Haynes. Witnesses: Henry Whapham, Margaret Haynes

FRANCIS, John

1737 Occupied Little Frienden, tenant of Thorpe.

FRANCIS, Thomas

1783 to 1785 Managed the workhouse. His salary was not specified but he sent in a bill for expenses at about £10 to £12 a month.

FRANKS, George

1783 Occupied Moorden farm, tenant of Children.

FRICKER, Henry, wife Ann

1735 Son Thomas who died the same year

1736 Daughter Mary who died in 1741

1737 Death

1741 Death of Ann Fricker, widow

FRIEND, Thomas, of Hever, wife Susanna

1749 Thomas Friend married Susanna Baker

FULLER, Elizabeth

1760 Death

FULLER, John, of Chiddingstone, farmer

1749 to 1765 Occupied New Tye farm in Chiddingstone and Hever, tenant of Sarah Woodgate.

1765 Death. Will (PS). He left all his property to his nephew Isaac Roffey. Witnesses: Edward Everest, John Taylor, Francis Firminger

FULLMAN, Thomas, of Penshurst, wife Mary

1785 Thomas Fullman, bachelor, married Mary Glover. Witnesses: John Glover, Ann Glover

FULLMAN, William

1728 Occupied a small messuage in Chiddingstone, tenant of Richard Hayward.

FUNNELLS, Richard

1756 to 1769 Occupied Bore Place South, tenant of Hyde.
