

GAINSFORD, John

1770 John Gainsford, bachelor, married Jane Kidder, daughter of George Kidder.

Witness: John Piggott

GAINSFORD, Elizabeth

1778 Elizabeth Gainsford (spinster) married John Virgo. Witnesses: Anne Virgo, David Longhurst

GANDER, Mary, of Chiddingstone, spinster

1739 She married Terry Owen, labourer, at the Fleet.

GASSON, Richard, wife Elizabeth

1743 to 1788 Occupied Waterlakes farm, tenant of Seyliard.

1743 Son Richard

1745 Son Thomas. He died in 1817 aged 71. (monument in churchyard)

1747 Daughter Elizabeth who in 1779 (or her mother) witnessed marriage between Thomas Nightingale and Ann Gasson.

1749 Son John

1750 Occupied Bowbeech farm and Waterlakes, tenant of John Seyliard of Bletchingley.

1753 Daughter Ann who (spinster) married Thomas Nightingale in 1779. Witnesses: John Burton, Elizabeth Gasson.

1754 Son Richard

1757 Daughter Sarah who died in 1777.

1758? Daughter Philly who died in 1778

1778 Death of Elizabeth Gasson (which one?)

GASSON, Edward, wife Elizabeth

1741 to 1761 Tenant to Hoskins for Brook farm, mainly in Brasted parish.

1751 Daughter Mary

GASSON, Mary,

1775 Base daughter Jane

GASSON, Thomas

1783 to 1815 Occupied Lockskinners farm, tenant of Streatfeild.

1784 Overseer of the poor.

GEAL, William, wife Sarah

1780 Daughter Mary

GEARING, Thomas, wife Jane

1774 (of Chiddingstone). Daughter Sarah baptised in Hever

GEORGE, Katherine

1736 Married Henry Upton

GILBERT, Clement, widow of Thomas Gilbert of Chiddingstone, husbandman, who died in 1726.

1726 Will of Thomas Gilbert (PS). He left his messuage called Bassetts to Clemence, remainder to John Jennet of Leigh, husbandman.

1741 Death

GILBERT, Mercy

1752 Her father, John Taylor, left her 5s. she was the wife of James Gilbert

1775 Death

GILBERT, John

1770 to 1775 paid £3-19s a year to Chiddingstone parish for the maintenance of his natural child born of Mary Holford.

GILES, John

1740 Occupied a messuage bounding against the highway from Somerden Cross to Penshurst north, against the lands formerly of the heirs of Richard Jessup west and south, and against the lands of the heirs of William Trendle towards the east.

GILES, Philippa

1750 Death

GLOVER, James

1752 to 1762 Occupied Little Frienden.

GLOVER, John, wife Sarah

1755 John Glover married Sarah Taylor, spinster. Witnesses: John Still, George Bevan

1755 Daughter Elizabeth

1759 Owned by Chiddingstone to Cowden with children Elizabeth and James.

GLOVER, Mary

1760 Mary Glover married John Rogers. Witness: Robert Mercer

GLOVER, Mary

1769 Mary Glover, spinster, married Edward Levite Witness: John Levite.

GLOVER, Mary

1785 Mary Glover, spinster, married Thomas Fullman of Penshurst, Witnesses: John Glover, Ann Glover

GLOVER, John

1785 Witnessed marriage between Thomas Fullman of Penshurst and Mary Glover

GLOVER, Ann

1785 Witnessed marriage between Thomas Fullman of Penshurst and Mary Glover

GOLDSMITH, John, of Shoreham, Kent, carpenter, wife Elizabeth

1731 Death. Will (PCC). He left a share of Funks to his wife Elizabeth.

1731 to 1740 Widow Goldsmith owned a share of Funks. After her death it passed to her daughter Elizabeth who was married to Henry Goodyer.

GOODHUGH, Stephen, wife Elizabeth

1763 Son John

1769 Daughter Ann

1772 Son Stephen

1785 Received relief 2s 6d.

GOODHUGH, William, a stranger

1762 Death

GOODHUGH, Thomas, of Chiddingstone, wife Jane

1764 Wrote to William Streatfeild at Brighton. Mr Austen had summoned the courts of Tyhurst, Sundridge Weald, Chiddingstone-Cobham, and Chiddingstone-Burghurst. The tenants came in beyond expectation.

1774 Ann Streatfeild left him £50 in her will but did not die until about 1812.

1779 Witnessed will of John Waterman.

1780 Death. Will (PCC). To wife Jane, living at Bromley, an annuity. Residual legatee Mrs Anne Streatfeild

GOODWIN, William, wife Elizabeth

1774 Daughter Ann

GOODWIN, James

1777 Jams Goodwin being seized of a messuage and 16 acres of land in Chiddingstone late Green has alienated it to Thomas Hayes. (manor of Bowsell).

GOODYER, Henry, wife Elizabeth

1735 Elizabeth Goldsmith was succeeded at Funks by her daughter Elizabeth, married to Henry Goodyer.

1755 Henry is dead and Elizabeth his widow is now seized (manor of Bowsell)

1765 Death of Elizabeth Goodyer of Shoreham, Kent, widow. Will (PCC). She bequeathed Funcks 30 acres in Chiddingstone to her son John Goldsmith Goodyer

GOODYER, John Goldsmith Goodyer, son of Henry Goodyer. Above

1765 He inherited Funks from his mother Elizabeth Goodyer, widow.

1777 He had alienated Funks to Thomas Haynes who is now seized (manor of Bowsell).

GORE, Thomas, wife Mary

1748 to 1749 Owned Hever Lodge and Cransted farm in right of his wife Mary, daughter of Sir Orlando Humphreys.

GORE, Charles, esq, MP for Hertfordshire, wife the widow of Sir Orlando Humphreys

1745 Occupied Hever Lodge and Cransted farm , tenant of his nephew Thomas Gore above.

1746 to 1749 He owned or occupied Hever Castle farm in Hever and Chiddingstone.

GORWEL, James

1747 Death

GOWER, William, husbandman, wife Ann

1730 William Gower of Penshurst married Anne Thorpe

1747 Daughter Anne, baptised in Penshurst.

1748 Acknowledged by Penshurst to Chiddingstone with children Thomas, Mary and Edward.

GOWER, William, wife Aves

1760 William Gower married Aves Mills. Witness: William Tye

1780 Death of William Gower senior?

GOWER, William , wife Ann

1760 William Gower married Ann King. Witness: Samuel King

1764 Daughter Elizabeth

1777 to 1788 Possibly occupied a house and smithy at Bowbeech.

GOWER, Thomas, wife Ann

1767 Daughter Ann

GREEN, Thomas of Sevenoaks, wife Ann

1723 to 1735 Ann Green, widow, owned Little Funks. She was succeeded in 1735 by her son Francis. (manor of Bowsell).

GREEN, Francis, of East Grinstead, gent

1735 to 1755 Owned Little Funks in Chiddingstone.

1755 Will. (PCC). He left Little Funks to his son Edward. Edward aliened it to James Goodwin.

GRINLEY, Mrs Mary, from Sunbury, Middlesex, daughter of Mr Edward Smith

1782 Death, aged 47 (monument in churchyard).

GROOMBRIDGE, John

1736 Death of his son John

1753 Death

1755 Death of widow Groombridge

GROOMBRIDGE, James

1768 Death

GROVE, John

1738 Death

GROVE, Sarah

1752 Death

GROVE, Edward

1772 Married Sarah Smith of Chiddingstone at Hever. Witnesses: James Saxby, Daniel Chapman

GUILFORD, Francis Lord

1734 Sold Moorden farm in Chiddingstone, Leigh and Penshurst to Richard Children of Leigh for £3450

GUNNER, William, wife Elizabeth

1757 Son Thomas

1759 Son William

1761 Son John

1763 Daughter Elizabeth

1765 Daughter Mary

1767 Son George

1770 Son Edward

1772 Daughter Ann

1774 Daughter Jane

1785 Parish provided him with a cord of wood 4s 6d.

GUNNER, Elizabeth

1769 Base daughter Elizabeth

1770 (spinster) She married Isaac Colchin. Witness: Edmund Bridge.
