

MADDOX, Erasmus, of East Greenwich, timber merchant, wife Mary

He was related by marriage to Edmund Burges of Sevenoaks, gent, who had owned Forge Field, Chiddingstone.

1704 Edmund Burges died. Will (PCC). He left his real estate in Chiddingstone to his kinswoman Hannah Coney, to his niece Sarah married to James Styles of Chelsfield, and others.

1707 Forge Field was owned by Hannah Coney, James Styles, Reginald Maddox, and Nicholas Wright of Greenwich, (manor of Sundridge Weald)..

1729 Forge Field was owned by Hannah Coney, Erasmus Maddox and the heirs of James Styles of Chelsfield.

1736 Death of Erasmus Maddox. Will (PCC). He left his real estate to his wife for life, remainder to his three daughters.

1741 Death of Hannah Coney, spinster, of East Greenwich. Will (PCC). She left her share in extensive lands in Sevenoaks and elsewhere and including a messuage and lands at Withyham called Blackham [which would include Forge Field] to Mary Maddox of East Grinstead, the widow of Erasmus.

1757 Death of Mary Maddox, widow of East Greenwich. Will (PCC)

MARCHANT, William, wife Elizabeth

1769 to 1812 Occupied Bore Place South farm, tenant of Streatfeild.

1771 Daughter Mary

1773 Son Robert. He died in 1853 (monument in churchyard).

1775 Son John

1778 Son Richard

1780 Daughter Elizabeth who died in 1783.

1782 Daughter Jane

1783 to 1810 he occupied Kiln farm, tenant of Attwood and Coles, tenant of Streatfeild.

1783 Surveyor (a parish office).

1784 Son Jesse

1785 (of Frienden Borough) Served on Grand Jury. (Quarter Sessions).

1782 Death of Elizabeth Marchant, aged 42.

1812 Death, aged 67. (monument in churchyard).

MARCHANT, Thomas

1785 Witnessed marriage between William Hubble of Chevening and Anne Potter

MARCHANT, Jane

1783 to 1785 She received substantial relief, including 100 faggots.

MARDEN, John, wife Jane

1757 John Marding of Chiddingstone married Jane Norris at Penshurst.

1758 Daughter Martha who married Robert Tye of Hever in 1780. Witnesses: Anne Turner, William Waite

1761 Daughter Sarah

1764 Daughter Jane

MARSHAL, James, wife Catherine

1749 James Marshal married Catherine Pope

MARTIN, John, of Chiddingstone, patten maker, nephew of John Kingswood, wife Frances

1732 John Kingswood left him a share of lands in Leigh.

1740 to 1758 He owned Bartons farm near Bowbeece, occupied by Thomas Waterman.

1741 Overseer of Chiddingstone parish

1743 John Martin witnessed the will of William Cronk.

1758 Death. Will (PCC). Left to his wife Frances two tenements and 10 acres in Chiddingstone, occupied by Thomas Waterman and Thomas Webb, remainder to son John. daughter Mary. Son Richard whose children were John, Edward Dorton and Sarah. Witnesses: Edward Kingswood, Philip Harrison,

1760 Death of widow Martin

MARTIN, John

1747 He occupied a cottage on the Stonewall estate.

MARTIN, John, wife Elizabeth

1748 Acknowledged by Chiddingstone to Bromley with son John

MARTIN, William

1740 Death

1743 Death

MARTIN, William, mercer, wife Rachel

1743 He and Sidney Streatfeild viewed the damage done at Somerden Green farm by widow Streatfeild.

1746 William Martin married Rachel Knight, both of East Grinstead

1747 Daughter Elizabeth

1750 Daughter Sally who (spinster) , in 1780, married Michael Saxby of Penshurst.
Witnesses: Thomas Shorey, Mary Whapham.

1752 to 1779 Occupied Shop Farm, tenant of Streatfeild

1776 Death of Rachel Martin, aged 56.

1779 Death, aged 62. (monument in churchyard).

MARTIN. William

1765 Death

MARTIN, Barnard, wife Elizabeth.

1752 Occupied Polebrooks farm, tenant of Burgis.

1763 Witnessed marriage of William Lee and Elizabeth Elwood

1763 Death of his daughter Elizabeth. Buried in Hever.

1767 to 1770 Again occupied Polebrooks farm, tenant of Burgis.

1770 Witnessed marriage of John Williams of Penshurst and Sarah Cox.

MARTIN, Elizabeth, daughter of Richard Martin

1770 Death, aged 23 (monument in churchyard).

MASON, William

1774 Witnessed marriage of Michael Bromley of East Grinstead and Susanna Head

MASON, Thomas

1783 to 1785 Received substantial relief and his rent paid to Mr Wood of Linfield (£2-10s).

MATTHEWS, Thomas, wife Mary

1777 Thomas Matthews , bachelor, married Mary Smyther. Witness: Thomas Smither.

1778 Daughter Elizabeth

1781 Son Thomas

1785 Daughter Martha

MAY, John, wife Mary. See Stevens**MAY, Jonathan, wife Sarah**

1784 Jonathan May, bachelor, married Sarah Jeffery. Witnesses: William Young, Sarah Bowra?

1784 Mr Horton was paid 1s for a copy of Jonathan May's examination.

1785 Son Jonathan

1786 Occupied Tyehaw House together with John leigh, tenants of Streatfeild.

1820 Death (monument in churchyard).

MAYNARD, Susannah

1777 Susannah Maynard, spinster, married Richard Upton. Witnesses: Milly Older, James Cox.

MAYNARD, Thomas, wife Charity

1776 Thomas Maynard, bachelor, married Charity Smith. Witness: Nicholas Welfare

1776 Daughter Mille

1779 Son John

1780 Daughter Elizabeth who died in 1782

1782 Son Thomas

1785 Daughter Elizabeth

1785 He was paid 8s for keeping Mary Weller.

MAYNARD, Richard, wife Elizabeth

1740 Acknowledged by Chiddingstone to Penshurst with daughter Ann.

1780 Death

MEARES, Elizabeth

1755 Married Richard Monk. Witnessed by Robert Palmer

MEDHURST, William, of Chiddingstone, yeoman, wife Anne

1719-29 Tenant of Millbrooks alias Somerden manor and farm owned by Hyde. He died in 1729

1730 Will (PCC). To daughter Ann £40 at age 21. Sons Thomas, John, William. Brothers John Medhurst and John Piggott.

1729 to 1740 William's widow Anne continued to tenant Somerden farm.

MEDHURST, widow

1733 to 1746 Occupied Hale farm, tenant of heirs of Beecher

MEDHURST, Elizabeth

1748 Of Chiddingstone, buried in Penshurst.

MEDHURST, John, wife Mary

1732 John Medhurst married Mary Best.

1749 Death of John Medhurst

MEDHURST, John, wife Sarah

1740 Acknowledged by Hever to Chiddingstone

MEDHURST, Edmund, of Chiddingstone, weaver, wife Elizabeth

He had a son Edmund by an earlier wife.

1687 Son John

1689 Daughter Elizabeth

1692 Son William who died in 1711.

1696 Son Simon

1698 Son George

1698 Death. Will (PS). He left Slaters to his widow Elizabeth for life, remainder to sons John and William

1727 Elizabeth Medhurst, widow, held four parcels of land near Bowbeeche in Chiddingstone and Hever, occupied by herself, late belonging to Richard King (manor of Tyhurst). This is Slaters farm.

1732 Death of Elizabeth Medhurst, widow. Will (PS) . she bequeathed Slaters farm to her son George.

MEDHURST, George, yeoman, son of Edmund Medhurst above . Wife Anne

1730 to 1737 Occupied Waterlakes farm, tenant of Seyliard. In 1740 his widow was the tenant.

1732 His mother Elizabeth Medhurst left him Slaters farm. Will (PS)

1735 to 1736 Churchwarden

1737 Death. Will (PS). He left his messuage near Bowbeeche occupied by his sister Elizabeth and himself to his wife Anne, remainder to daughter Anne.

1737 to 1768 Slaters farm belonged to widow Medhurst. **Is this Anne?**

MEDHURST, Elizabeth

1745 to 1756 Widow Medhurst occupied a property in Chiddingstone North, tenant of Cole.

1764 Elizabeth Medhurst is seized of four parcels of land in Chiddingstone, occupied by John Barton. (manor of Tyhurst).

1768 Death of Elizabeth Medhurst, widow. **Who was she?** She devised Slaters to William Humphrey. (manor of Tyhurst).

MEDHURST, Edmund

1698 He inherited Pilbeams from his father Edmund (Will PCC)

1724 Edmund Medhurst for a house in Bradney Lane, occupied by Richard King (Survey of Church Seating).

1737 Pilbeams has been divided. Thomas Peach took two thirds and Edmund Medhurst one third (Little Pilbeams or Kings farm).

1743 Edmund Medhurst who held part of Pilbeams has died. The premises descended to his son Robert. (manor of Sundridge Weald).

1747 Had previously sold (part of) Pilbeams to Thomas Peach.

MEDHURST, Robert, son of Edmund Medhurst above

1743 to 1746 He owned Kings farm, part of Pilbeams, inherited from his father. He alienated it to Thomas Butcher.

MEDHURST, Humphrey

1744 Death

MEDHURST, Ann, of Hartfield

1749 Death, aged 21? (monument in churchyard).

MEDHURST, Ann

1754 Daughter Rebecca.

MEDHURST, Ann

1755 (spinster) Married Thomas Humphreys. Witnessed by William Lettington

MEDHURST, William, of Aylesford, baker

1753 He was the son of John Medhurst junior of Leigh and Abigail, daughter of John Beckett of Penshurst. Joseph Beckett paid him £100 and William released all claim to Newhouse and 22 acres in Penshurst and Chiddingstone.

MEDHURST, Thomas, of Leicester Square, Soho, poulterer

1766 Anne Dobbs sold to him her moiety of 3 yards in Millbrook Mead and also a messuage with 5 parcels, 15 acres, near Somerden Cross. He then sold the above moiety to Thomas Hollamby of Chiddingstone who already possessed the other moiety.

MEDHURST, Elizabeth

1761 Received 6s relief.

1773 Death

MEDHURST, Simon, of Leigh, yeoman, wife Sarah, daughter of Thomas Wallis).

1696 Born, son of Edmund and Elizabeth Medhurst above

1730 to 1783 Occupied Wickhurst farm in Leigh and Chiddingstone

1732 Left 5s by his mother Elizabeth Medhurst, widow (Will PS)

1765 He bought Charcott farm in Leigh and Chiddingstone from Paulet St John. He owned it from 1765 to his death in 1784 and occupied it himself from 1780.

1777 Witnessed marriage of George Aylard and Anna Cross.

1777 to 1784 Occupied Stonelake farm, tenant of Everest, in succession to William Medhurst. Followed by Thomas Medhurst.

1784 Will (PCC), To son Thomas Charcott farm in Leigh and Chiddingstone, occupied by son Simon. Sons William, Simon. Brother-in-law Thomas Wells of Hever, nephew Richard Shoebridge of Chiddingstone. Daughter Sarah wife of Edward Barker.

MEDHURST, Simon, son of Simon Medhurst above

1784 Occupied Charcott farm in Leigh and Chiddingstone, tenant of his father. He was bequeathed Little Wickhurst farm in Leigh

MEDHURST, Thomas, son of Simon Medhurst above, wife Rebecca

1784 Inherited Charcott farm in Leigh and Chiddingstone from his father. He held it until his death in 1799. Will (PCC)

1788 to 1791 Occupied Wickhurst farm in Leigh and Chiddingstone.

MEDHURST, William, son of Simon Medhurst senior of Leigh, wife Ann

1763 William Medhurst of Leigh married Ann Cross. Witness: Thomas Hore?

1765 Daughter Sarah, baptised in Penshurst

1767 to 1773 Occupied Stonelake, tenant of Everest succeeded by Simon Medhurst, then Thomas Medhurst.

1784 Will. He gave his property in Penshurst to his two sons Thomas and William equally divided.

MEECOMB, Henry, of Penshurst

1749 Death

MERCER, Richard

1740 Occupied land to the west of Willmott Lands.

MERCER, Robert

1759 Witnessed marriage of George Longley and Mary Rolls

1760 Witnessed marriage of John Rogers and Mary Glover

MERCHANT, John

1742 Son Richard

MILLS, Thomas, wife Mary

1737 Acknowledged by Chiddingstone to Sevenoaks

MILLS, William, wife Ann

1755 William Mills married Ann Wakeman. Witnessed by Richard Bevan

MILLS, David, wife Mary, travellers from Scotland

1759 Daughter Mary

MILLS, Aves

1760 Aves Mills married William Gower. Witness: William Tye

MILLS, Elizabeth

1766 (spinster) She married Thomas Baker. Witness: Nicholas Weller

MITCHELL, Edward, wife Mary

1780 Edward Mitchell, bachelor, married Mary Leigh. Witnesses: John Leigh, Elizabeth Leigh. Brother-in-law of James Blackwell.

1782 Death of Edward Mitchell, infant

1782 Son James

1784 Son Edward

1783 to 1784 He was paid 48s for keeping Baker's girl Mary 48 weeks.

1784 He supplied a sack of peas for John Tiping. 1785 He supplied peas for the poor £1-11s-6d.

1785 He kept Hurrion's girl 23 weeks at 1s a week. He supplied a hog for the workhouse £4-13s-9d. (continued).

MONK, Edward , wife Ann, née Budgen

1736 Death

1739 (Anne Monk, widow) Daughter Susa£, presumably by Sidney Streatfeild.

1744 Sidney Streatfeild left to Susan Monk, daughter of Ann Monk, widow, £300 at age 21 without any interest in the meantime

MONK, Edward , wife Ann

1750 Edward Monk married Ann Brazier

1750 Son Richard

1751 Son John

1754 Son Edward who died the same year (infant)

1754 Death of John Monk of smallpox

1755 Son Edward

1757 Daughter Ann

1761 He was paid 4s for lodging John Whale senior 4s.

1765 Daughter Mary

MONK, Richard, wife Elizabeth

1755 Richard Monk married Elizabeth Meares. Witnessed by Robert Palmer

1756 Daughter Sally who died in 1769

1758 Son James

1760 Daughter Elizabeth

1763 Son Richard

1765 Son John who died in 1769

1768 Daughter Philly

1771 Son John

1774 Daughter Mercy

1779 Occupied Gilwyns, 19 acres, tenant of Henry Streatfeild

MOON, John, of Chiddingstone, farmer, wife Mary

1743 to 1759 John Moon occupied Ivy House, tenant of Farnaby.

1743 to 1767 John Moon occupied the northern part of Bore Place farm, tenant of Hyde.

1755 Recommended for the post of borsholder of Frienden "liberty".

1757 (at the Chequers) Listed as an alternative to Joseph Beckett as constable of the upper half hundred of Somerden.

1763 Death of wife Mary, buried in Westerham.

MOON, Mary

1780 Death

MOORE, Thomas, of Penshurst. Wife Keziah

1779 Thomas Moore, bachelor, married Keziah Knell. Witnesses: Elizabeth Hills, Thomas Trice

MORGAN, Thomas, of Chiddingstone, husbandman, wife Clemens

1728 Occupied Bowsell in Chiddingstone and Chevening, tenant of Richard Hayward

1732 (bachelor) Married Clemens Smith, spinster, of Orpington, at the Fleet.

MORGAN, Francis, of Leigh, yeoman .

1745 to 1762 Occupied Charcott farm in consideration of a lease for 15 years at £43 per annum from Sarah St John of Sevenoaks.

1766 to 1777 Widow Morgan occupied Charcott farm.

MORTON, James Hardis, wife Mary

1780 James Hardis Morton married Mary Whapham. Witnesses: Thomas Driver, Mary Shorey

MORTON, Dr

1783 to 1784 He was paid £2-2s a quarter for medicines for the poor.

1783 Medicines for Stephen Young £1-1s. Medicines for Elizabeth Moyce £3-3s.

MOYCE, Samuel, wife Mary

1736 Samuel Moyce married Mary Cole

1756 Death

MOYCE, Thomas, carpenter, son of John Moyce, wife Ann

1722 Apprenticed by Chiddingstone to William Streatfeild, gent.

1724 William Streatfeild left £10 to put out Thomas Moyce as apprentice.

1724 He was apprenticed to George Chapman of Tonbridge, carpenter.

1739 Thomas Moyce married Ann Beaven

1738 witnessed will of George Cronk.

1739 Thomas and Ann acknowledged by Brasted to Chiddingstone.

1739 Thomas Moyes acknowledged by Chiddingstone to Great Peckham.

1740 Son Thomas

1743 Daughter Ann

1749 Daughter Hannah who (spinster) married Daniel Bach in 1776. Witness: Nicholas Welfare.

1750 Daughter Philly

1754 Son John. He died in 1831 (monument in churchyard).

1755 Witnessed marriage of John Scudder and Elizabeth Bevan

1756 Son Samuel

1758 Daughter Amelia

1761 Son David

1765 Death of Ann Moyce

1779 to 1785 Occupied a house at Somerden Green, tenant of Streatfeild. Succeeded by John Moyce.

1784 Dame Moyce was paid 5s for laying Thomas Hollamby's wife.

1784 He made coffins for Robert Leigh 9s and for widow Walker 9s.

1785 He made coffins for two poor people (9s each) and for Smeed's child 2s 6d.

1785 Dame Moyce was paid 5s for laying Adams's wife and 10s for two other women.

1785 Death of Thomas Moyce. A coffin was made for him and expense of laying forth 6s. A bell rung for his wife 1s.

1763 Base daughter Elizabeth

MOYCE, Elizabeth

1783 Dr Morton was paid £3-3s for her cure.

MOYES, Elizabeth

1784 Banns for marriage of Daniel Chapman and Elizabeth Moise of Chiddingstone at Hever. The marriage took place at Chiddingstone. Witnesses: Thomas Boakes, Rachel Boakes

MUGGRIDGE, William, of Penshurst, wife Elizabeth, née Tye

1719 to 1743 Occupied Great Brownings and Breeches farms in Chiddingstone, tenant of Jewell.

1733 to 1743 Occupied Blackhouse, tenant of Humphrey.

1738 Death of William Muggridge, perhaps a son.

1741 Overseer of Chiddingstone parish.

MUGGRIDGE, Elizabeth

1741 Elizabeth Muggridge, spinster, of Chiddingstone, married Henty Mandy, bachelor, of Sevenoaks, carpenter, at the Fleet.
