

**PACKHAM, Ann**

1773 Married William Woodhams. Witnesses: Sarah Cackett, John Woodhams.

**PACKHAM, Margaret of Tonbridge**

1776 Married (spinster) William Langridge. Witnesses: William Piggott, Susannah Langridge

**PAGE, Edward**

1780 Occupied Chested farm, mainly in Penshurst, tenant of Woodgate. (Land Tax). Then Perryman Page, then Edward Page again 1788 to 1801. He also occupied Seedcombes farm in Chiddingstone.

1801 Death. Will (PCC).

**PAGE, Perryman, wife Elizabeth**

1751 Perryman Page of Leigh married Elizabeth Older

1751 Daughter Sarah. In 1782 she witnessed marriage of Elizabeth Page and Edward Leigh. She died in 1798 and left a will (PCC). Died in 1797 aged 46 (Monument in churchyard).

1756 Daughter Elizabeth. In 1775 she witnessed the marriage of William Smith and Winny Langridge. In 1782 she (spinster) married Edward Leigh. Witnesses: Sarah Page, James Blackwell

1771 Death of Elizabeth Older. Will (PS). Bequests to her daughter Elizabeth Page and granddaughters Sarah and Elizabeth.

1772 to 1787 Licenced at the "Maypole", formerly known as the "Chequer". Succeeded by Sarah Page.

1779 Perryman and Elizabeth Page witnessed the marriage between John Ashdown and Elizabeth Young.

1783 He occupied Chested farm, mainly in Penshurst, tenant of Woodgate. (Overseers' accounts). Followed by Edward Page.

1784 Sent in a bill to the overseers for 11s 9¼d. Overseers paid him rent for Thomas Hollamby £2-10s. Supplied 50 faggots 6s.

1787 Death, aged 71. (Monument in churchyard)

1788 Death of wife Elizabeth, aged 66. (Monument in churchyard)

**PAIFREBLE, Anne PAISIBLE ?**

1774 Anne Paifreble, spinster, married Robert Hunt. Witnesses: Anne Sears, Homden Hunt

**PALMER, Elizabeth, of Chiddingstone, widow**

1731 Death of Edward Palmer, husbandman

1736 She married William Hollins of Seale, husbandman at the Fleet

**PALMER, Robert , of Chiddingstone, blacksmith, wife Dorothy**

1701 to 1726 Occupied Butt House and forge, tenant of Cronk. In 1725 there was a widow Palmer

1726 Will (PS). Wife Dorothy. daughters Dorothy, wife of William Hooller of Penshurst and Elizabeth, sons Robert, Richard, Nicholas, Thomas. Witnesses: Thomas Weller, Samuel Arnold

**PALMER, Robert, son of Robert Palmer, above, of Chiddingstone, blacksmith, wife Mary**

1726 John Cronk leased to him for 21 years Butt House and forge. He held it until 1738.

1735 Daughter Mary who died in 1746

1737 Death of wife Mary

1746 Sidney Streatfeild left him a wainscot bookcase and £10.

1750 Witnessed will of Thomas Dobbs

1755 Witnessed marriage of Richard Monk and Elizabeth Meares

1761 Death

**PALMER, widow**

1746 Occupied Highfields house and land, tenant of Streatfeild. (manor of Chiddingstone-Cobham).

1752 Death

**PALMER, Ann**

1754 Son John

**PALMER, Ann**

1756 She married William Seal of Brenchley. Witness Thomas Bulb?

**PALMER, Abigail**

1771 Death

**PALMER, John**

1782 Witnessed marriage between James Blackwell and Elizabeth Leigh

**PARKER, Hannah**

1761 Base son Robert Cockerell

**PARKER, William**

1767 to 1773 Occupied Chafford Bridge Mead, tenant of Streatfeild.

1779 (of Stanford borough) Possibly served on the Petty Jury (Quarter Sessions)

**PARKHURST, Thomas**

1761 Married Mary Langridge. Witness: Elizabeth Collyer

**PARSONS, Ann, singlewoman**

1737 Settlement examination Now residing in Chevening. About 1723 to 1727  
Employed by Samuel Arnold of Chiddingstone. About 1728 employed by John Cronk of  
Chiddingstone. Has done nothing since to gain a settlement. Ordered to Chiddingstone,  
but quashed.

**PARSONS, John, wife Frances**

1738 Death of wife Frances

1748 Death

**PARSONS, John, wife Ann, née Denton**

1735 Son John who died in 1736

1746 Death of Ann Parsons

**PARSONS, John, wife Ann**

1751 John Parsons married Ann Kinman

1752 Son John

1754 Son Richard

1761 Daughter Mary

1761 Received relief

1781 Death

**PARSONS, Ann**

1762 Base daughter Sarah who died in 1764

1764 Death of Ann Parsons or above

**PARSONS, Elizabeth**

1757 (infant) Death

**PARSONS, Jane**

1770 Jane Parsons (spinster) married William Deadman of Ringmer. Witness: Thomas Smyther

**PARSONS, Mary**

1779 Base son Richard

1783 to 1784 William Brooks paid for keeping her child at 1s 6d a week.

**PARSONS, Ann**

1784 William Brooks paid 1s 6d a week for keeping her girl three months.

**PAVEY, John, of Sevenoaks, wife Elizabeth**

1750 John Pavey married Elizabeth Morgan

**PAWLEY, George, of Ightham.**

1743 Administered property of Henry Cox, butcher, including messuage and orchard at Rannesley Hoath.

**PAYNE, Elizabeth**

1740 Mistress of John Hyde of Bore Place, by whom he had three base children; John, Humphrey and Savilla. In his will (PCC) he left her a large annuity.

**PEARCH, Thomas, of Chiddingstone, yeoman, wife Susanna**

1729 to 1751 Owned the larger part of Pilbeams farm

1739 Served on the Grand Jury (Quarter Sessions).

1748 (of Frienden borough) Summoned to serve on the Petty Jury but did not turn up. Fined £1

1751 Will (PCC) Gave Pilbeams, which he had purchased from Edmund Medhurst, to wife Susanna, remainder to son Henry. To son Thomas one guinea.

1752 Widow Pearch owned Pilbeams farm (Chiddingstone rates).

**PEARCH, Thomas, son of Thomas Pearch, above, wife Ann**

1751 Thomas Pearch senior in his will gave his son Thomas one guinea. Wife Ann was deceased. Children Thomas, John, William, Susanna.

1762 His daughter Susanna married John Everest. Witness: Robert Saxby

**PEARCH, Henry, son of Thomas Pearch senior above**

1751 He inherited Pilbeams farm after the death of his mother.

1756 He had alienated Pilbeams farm to John Everest who became his brother-in-law.

**PEARCH, William**

1750 Witnessed will of Thomas Dobbs

**PEARLESS, John, wife Mary**

1733 to 1765 Occupied Forge Field and possibly Blackham in Withyham, tenant of heirs of Edmund Burges. He was succeeded by William Pearless 1767 to 1783.

**PEARLESS, William, of Bassetts farm in Cowden.**

1749 to 1785 He occupied part of the land belonging to Bassetts Mill, tenant of heirs of Bassett.

1761 Witnessed marriage of William Smith and Ann Kitchenham

1795 He was probably the husband of Mary, daughter of Joseph Langridge, who occupied a farm in Rotherfield and also Bassetts Mill. He was succeeded by Mrs Pearless.

**PERRIN, Thomas, of Hever, wife Elizabeth**

1733 Thomas Perrin married Elizabeth Smither

**PERRY, Jane**

1761 Death

**PERRY, William**

1746 to 1752 Owner of Marshope Mead, part of Doubletons farm, followed by Mrs Perry 1756 to 1777.

1748 He leased Doubletons farm to John Carwardine (?Carden) of Hartfield for 21 years.

**PETERS, Ann, of Chiddingstone, widow**

1732 Elizabeth Eastwood alleged that Anno Peters, her mother, had died intestate. (PS admon)

**PETERS, John, wife Allen, travellers from Yewell in Surrey.**

1766 Daughter Frances

**PETLEY, Ralph**

1728 to 1751 Owned Furnace House farm in Hever and Chiddingstone.

1751 On his death Ralph was succeeded by his cousin Charles Petley of Chatham. Charles Petley sold the farm to his mother Jane.

**PETLEY, Jane, mother of Charles Petley**

1752 to 1770 she owned Furnace house farm. When she died in 1770 she was succeeded by her grandsons, Ralph Robert Carter Petley and John Petley, the sons of Charles Petley,

**PETLEY, Ralph and John**

1785 Ralph and John Petley held a messuage and lands called the Furnace farm. Ralph alienated his share to John (manor of Sundridge Upland).

**PIERCE, Ann, of Chiddingstone, widow**

1733 Married Henry Terry, widower, husbandman, of Wrotham at the Fleet

**PIERCE, John**

1743 to 1746 Occupied Chittenden, tenant of Samuel Kent. 1759 Widow Pierce was the tenant.

**PIGG, Elizabeth, or Standen, a stranger**

1765 Death

**PIGGOTT, Philipps, widow**

1721 Alleged that Nicholas Piggott had died intestate. (PS admons). He died at Chiddingstone in 1721.

1723 Will (PS). Children: Philippa, William, Nicholas, Henry, Mary, George. Brother-in-law Henry Piggott

**PIGGOTT, Philippa**

1724 Philippa Piggott, spinster, of Chiddingstone married Richard Mattenly, bachelor, of Fulham, potter, at the Fleet.

**PIGGOTT, Henry, son of Nicholas Piggott, wife Mary**

1688 On the death of his father he inherited Skinners.

1732 His brother-in-law John Ashdowne bequeathed to him a farm situated at Rendsley Heath, occupied by Thomas Turner, remainder to his son Nicholas Piggott. This farm is Batts.

1738 He owned land west of Lew Cross

1739 Will (PC) To son Nicholas Skinners in Chiddingstone and other lands, Daughter Mary Driver. Witnesses: John Tye, James Lawrence, A Farmer

1746 Death, aged 65. (monument in churchyard).

1757 Death of widow Mary Piggott, aged 69. (monument in churchyard)

**PIGGOTT, Nicholas, son of Henry Piggott, wife Sarah, daughter of Thomas Driver**

1746 Inherited Skinners and Batts on the death of his father.

1747 Daughter Sarah who died the same year. (monument in churchyard)

1747 Served on the Grand Jury (Quarter Sessions). Also 1749, 1751, 1753. (This is unusually frequent)

1758 Death, aged 44. (monument in churchyard). Will (PCC) He left his farms to his wife Sarah, remainder to Nicholas, son of Thomas Driver of Edenbridge. However Nicholas Driver died in 1762. Witnesses: William Lover, George Young, Thomas Ellis

1758 to 1771 Sarah Piggott owned Batts farm, which was mortgaged to a succession of persons.

1771 Death of widow Piggott. Succeeded by Thomas and John Driver, brothers of Nicholas deceased.

**PIGGOTT, John, wife Elizabeth**

1740 John Piggott of Chiddingstone married Elizabeth Trendle at Sundridge.

1750 Son John

1753 Witnessed will of John King.

1747 Owned a moiety of Skipreed and Oakenden farms to 1773 in right of his wife, daughter of William Streatfeild.

1753 Served on Petty Jury (Quarter Sessions).

1756 to 1773 Occupied Skipreed and Oakenden farms.

1770 Witnessed marriage of John Gainsford and Jane Kidder ?

1775 Brother-in-law of John Denman, of Edenbridge, yeoman.

1770 Witnessed marriage of Thomas Shorey and Sarah Denman.

1775 Death. (monument in churchyard). He was succeeded at Skipreed and Oakenden by his son William.

**PIGGOTT, William, son of John Piggott above**

1775 to 1805 Occupied Skipreed farm of which he owned a share. Also Brookers.  
1776 Witnessed marriage between John Cole and Elizabeth Denman of Hever.  
1776 Witnessed marriage between William Langridge and Margaret Packham.  
1779 John and Elizabeth Cole alienated their share of Skipreed to William Piggott.  
1780 Thomas and Sarah Shorey alienated their share of Skipreed to William Piggott.  
1780 George and Mary Randall alienated their share of Skipreed to William Piggott.  
1782 He had alienated Oakenden to Thomas Hogsflesh.  
1783 (of Stanford Borough) served on the Grand jury (Quarter Sessions). Also 1785  
1784 William Piggott mortgaged Skipreed to George Kidder of Chiddingstone, yeoman.  
1785 Churchwarden.

**PIGGOTT, John, of Chiddingstone, husbandman, wife Sarah**

1750 Son William  
1752 His daughter Mary married John Taylor.  
1761 Death. Will (PC). To son John land in Cowden. Annuity to son William. To daughter Mary Taylor £4-4s. Witnesses: William Ellis, ..... Sutton, John Ingrimes.

**PIGGOTT, John, senior**

1740 to 1756 Rated for a property in Chiddingstone South.  
1747 Possibly served on the Grand Jury (Quarter Sessions) and on the Petty Jury in 1750

**PIGGOTT, Mercy**

1759 Death

**PINNE, John wife Ann**

1736 John Pinne married Anne Kingswood  
1760 Death  
1761 He had received 5s relief. His widow received 5s relief.

**PINN, Mary, widow**

1728 Death of George Pinne, labourer.  
1746 Death

**PINN, William, wife Elizabeth**



1744 William Pinn married Elizabeth Carr

1751 Acknowledged by Penshurst to Chiddingstone with his children William, Amy and Thomas

1755 Son Richard

1778 Daughter Sarah. Born and privately baptised about 1767 and publicly received into the church 1778

**PINN, William, of Penshurst**

1748 Death of his daughter Elizabeth

**PINN, John**

1773 Death

1773 Death of widow Pinn

**PINN, Henry, of Chiddingstone, husbandman, wife Elizabeth**

1753 (bachelor) Married Elizabeth Essex at the Fleet.

1753 Acknowledged by Chiddingstone to Sevenoaks.

1780 Death

**PINN, widow**

1781 Death

**PIPER, Elizabeth**

1773 Base son Thomas who died the same year.

**PLEDGE, Mary**

1741 Death

**POCOCK, Henry, wife Frances**

1730 Henry Pocock married Frances Moyce

1750 Death of Henry Pocock

1761 Widow Pocock received 6s relief.

1762 Death of widow Pocock

**POLLARD, Mary**

1784 Base daughter Lydia Hurron. Parish paid £1-4s=6d for Mary's laying in.

1784 to 1785 Parish paid her and her child considerable relief.

1785 Her child kept by John Longley and his wife 18s.

**POLLARD, Thomas, wife Mary**

1757 Acknowledged by Chiddingstone to Buxted in Sussex, with son Thomas.

1772 Death

**POLLARD, Thomas**

1781 Death

**POLLARD, widow**

1783 to 1785 Small amounts of relief.

**POPE, Mary**

1736 (widow) Death

**POPE, William, labourer, wife Ann, wife Susanna**

1734 to 1737 With Benjamin Carr occupied Hoath farm, tenant of Woodgate.

1735 William Pope married Susanna Chapman

1736 Son Thomas

1748 Death

**POPE, Frances**

1747 Death

**POPE, Elizabeth**

c1755 married John Swetman of Chiddingstone at Hever.

**POPLETT, John, Susanna**

1759 John Poplett married Susanna Best

1750 Son Thomas

1751 Daughter Sarah. In 1778 she (spinster) married Thomas Webb. Witnesses: Mary Poplett, William Webb.

1752 Daughter Susanna.

1755 Daughter Mary. In 1778 she witnessed the marriage of Sarah Poplett and Thomas Webb. In 1783 she married Edward Collins. Witnesses: William Hollamby, Sarah Collins.

1757 Daughter Mercy who (spinster) married John Humphreys of Sundridge in 1777.  
Witness: William Carpenter

1760 Son John

1762 Son William

1765 Daughter Elizabeth

1769 Son Emmanuel who died in 1771

**POTTER, Joseph, the elder, of the Ivy House, Chiddingstone, yeoman, wife Elizabeth**

1766 Son John

1770 Lease from Sir Charles Farnaby of Ivy House farm to Joseph Potter and Churchman Field (who soon disappears)

1765 to 1806 Occupied Ivy House farm in Chiddingstone

1783 Surveyor (a parish office).

1784 For keeping William Langridge's boy none year at 1s a week. Supplied 50 faggots for the poor 5s.

1795 Death of wife Elizabeth, aged 66

1806 Death, aged 76. (monument in churchyard). Will (PCC) To daughter Mary, wife of William Cole £10. To son William Potter of Henden in Sundridge debts forgiven and £10. To daughter Ann Hubble, widow annuity of £8. To son Joseph a messuage at or near the Hoath. Son John of Toys Hill, Brasted, deceased.

**POTTER, Anne, daughter of Joseph Potter**

1785 Anne Potter, spinster, married William Hubble of Chevening. Witnesses: Thomas Marchant, Mary Hubble

**POTTER, Joseph, son of Joseph Potter, senior, wife Elizabeth**

1783 Joseph Potter of Chiddingstone married Elizabeth Weare at Hever, licence with consent of parents. Witnesses: William Potter, Daniel Chapman.

1784 (of Chiddingstone) Daughter Ann, baptised in Hever.

1785 (junior) Son Joseph

**POTTER, John**

1742 to 1746 Rector of Chiddingstone

**POTTER, Mary, daughter of Joseph Potter**

1774 She married William Cole. Witness: John Cole

**POTTER, William**

1783 Witnessed marriage of Joseph Potter and Elizabeth Weare at Hever.

**PREMBLE, William**

1778 Part owner of Forge Field in Chiddingstone. He was probably married to Margaret, daughter of Erasmus Maddox. He was succeeded by Michael Preamble.

**PRICE, Richard**

1780 to 1794 Occupied Bough Beech farm (Clouts farm) and Polebrook farm, tenant of Burgis.

1785 Churchwarden.

1785 Provided a cord of wood for John Ingram 9s. wood and faggots for workhouse and poor £7-19s-10d. For carriage of coals to the workhouse 15s.

**PRICE, Mary**

1784 Base daughter Elizabeth. Parish paid 5s relief for the child.

**PRICKLER, Robert, wife Ann**

1737 Daughter Martha

1785 The parish paid 4s for leather for him.

**PURDAY, Richard, of Brasted, wife Elizabeth**

1746 Richard Purday married Elizabeth Daniel

**PURL, Sarah**

1759 Death

**PURSER, Elizabeth, widow**

1774 Married Samuel Waters of Chiddingstone at Hever, by licence. Witnesses: John Humphrey, Daniel Chapman.
