

RANDALL, George, of Penshurst, collarmaker, wife Mary

1775 On the death of John Denman Mary inherited a third of a moiety of Skipreed farm. George and Mary alienated it to William Piggott in 1780.

1785 He supplied a three gallon pot for the workhouse 3s.

RANDALL, Hannah

1771 Hannah Randal, spinster, married Robert Bennett. Witness: John Hill

RANDALL, Anne

1779 Anne Randall, spinster, married John Best. Witnesses: John Hill, Sarah Hill

RANDALE, Mary

1781 Death

RANGER, Josiah

1743 to 1745 Occupied Bushes farm in Chevening and Chiddingstone, tenant of Hyde.

REED, Joseph, wife Ann

1748 Son William

1749 Occupied Hilders in Chiddingstone and Hever, tenant of Streatfeild. (Hever records).

1750 Acknowledged by Chiddingstone to Sevenoaks with children William and Joseph.

REED, Joseph

1784 to 1785 He was paid for keeping his daughter for 18 weeks £1-7s

REED, Judith, of Sevenoaks

1784 to 1785 Chiddingstone paid her considerable relief. She appears to be the daughter of Joseph Reed.

REY, Mary

1762 Witnessed marriage of William Farmer of Sevenoaks and Susanna Stacey

RICHARDS, Sarah

1778 Witnessed marriage of William Cackett and Philly Longhurst

RICHARDSON, Mary

1774 Witnessed will of Matthew Everest

1778 (widow) married Nicholas Welfare. Witnesses: Ann Welfare, Thomas Driver

RIVERS, Sir George, of Chafford Park, Penshurst, wife Dorothy

1686 to 1734 Owner of Pilbeams farm.

1734 Death. Will (PCC) The estate to be sold and the proceeds to go to his “friend” Mrs Anne Maria Thom and his five natural children. However his surviving legitimate daughters and the heirs of those deceased filed a bill in chancery to overturn the will and after decrees in 1743 the court ordered the estates to be sold.

1743 The estates were purchased by Stephen Woodgate, gent. (manor of Sundridge Weald)

ROBINSON, Nevil, wife Elizabeth

1785 Daughter Sarah

ROBINSON, Mary

1784 Mary Robinson, spinster, married Abraham Boakes. Witnesses: William Bowrah, Elizabeth Wickerson

ROFFEY, alias ROFWAY, Isaac, of Chiddingstone, farmer wife Palmer

1765 Inherited the property of his uncle John Fuller. This was presumably the lease of New Tye farm, tenant of woodgate.

1766 Isaac Roffey, bachelor, married Palmer Cacket spinster. Witness: Edward Kimler

1767 Daughter Nanne, who married Charles Longhurst

1769 Daughter Sarah, who married William Wales

1774 Son Isaac. He died in 1838 aged 64 (monument in churchyard).

1782 Death of Isaac Roffee. Will (PS) He left everything to his wife Palmer. Witnesses: Edward Kimber, William Tye, J Sutton.

1798 Death of Palmer Roffey of Chiddingstone, widow. Will (PCC), Her son Isaac was executor.

ROGERS, Thomas

1758 Witnessed marriage of Thomas Carden of Penshurst and Elizabeth Bonner

ROGERS, John, wife Mary

1760 John Rogers married Mary Glover. Witness: Robert Mercer

1761 Son James

1762 to 1794 He occupied Scalefields and a field once part of Truggers, tenant of Douglas

1763 Son John

ROLLS, Mary

1759 Mary Rolls married George Longley. Witness: Robert Mercer

ROOTS, Thomas, gamekeeper

1756 Appointed gamekeeper in the manor of Milbrook in Chiddingstone by Bernard Hyde.

ROOTS, John

1759 to 1765 Occupied Beachlands, tenant of Hyde

ROPER, John

1743 to 1745 He occupied Woodsgrove at Coopers Corner, tenant of John Bassett.

ROSE, George, wife Elizabeth

1737 Death of his daughter Elizabeth

ROSE, George, of Hams, Sussez, yeoman, wife Sarah

1725 to 1746 Occupied Lockskinners, and Tyehurst farms, tenant of Streatfeild. A 21 year lease was signed in 1726.

1739 His goods were distrained upon to satisfy a debt to Henry Streatfeild, his landlord.

1750 Witnessed will of Thomas Dobbs.

1752 Daughter Elizabeth

1755 Daughter Sarah Barton

ROSES, Mr

1784 For keeping Langridge's girl one year £2-12s (1s a week).

ROUND, Richard, of Seal, gent

1733 to 1747 Mr Round owned Camphill farm in Chiddingstone parish

1779 Death of Richard Round of Seal, gent. Will (PCC).

1780 to 1791 Mrs Round owned Camphill farm.

RUSSELL, Elizabeth

1778 She witnessed marriage of William Nightingale and Mary Russell of Penshurst

1766 Base son Walter Barton

RUSSELL, Mary, of Penshurst, daughter of Thomas Russell below.

1778 Mary Russell, spinster, married William Nightingale. Witnesses: Thomas Russell, Elizabeth Russell

RUSSELL, John

1773 Occupied Vexour farm mainly in Penshurst , tenant of Harvey.

1785 Abraham Anderson claimed to work for Mr Russell of Vexore.

RUSSELL, Thomas, wife Mary

1731 He died in 1803, aged 72. His wife Mary died in 1816 aged 84. Their daughter Mary Nightingale died in 1830 aged 92. William Nightingale died in 1828 aged 79. (Monument in churchyard0.

1777-94 Occupied Vexour farm, tenant of Harvey.

1778 Thomas Russell witnessed marriage of William Nightingale and Mary Russell.

1784 Occupied 4 acres of land in west Chested Mead, tenant of Harvey.

RYE, Susannah

1767 (spinster) Married Samuel Bevan. Witnesses: Richard Saxby, John Waterman.

RYE, Elizabeth

1782 Death

RYE, Thomas

1763 Death (infant)

RYE, John

1777 to 1783 Occupied Finch Green farm, tenant of Bostock.
