TAYLOR, John, wife Sarah

1746 to 1759 Occupied Hoath farm, tenant of Woodgate.

1762 to 1786 Sarah Taylor, widow. Occupied Hoath farm, Geers, Riddens and Bridgefields in Chiddingstone, tenant of Streatfeild.

TAYLOR, Richard

1738 Witnessed sale of Lew Cross Constable to Saxby.

1738 Witnessed sale of Bridgefields Cronk to Chapman.

1740 Occupied Burnthouse formerly Mountjoys, 4 acres, formerly John Turner.

TAYLOR, Elizabeth

1766 Married John Whale. Witness: Henry Crayford

TAYLOR, Jane, widow

1770 Death

TAYLOR, William, of Hever

1764 William Taylor came into court and acknowledged to hold a messuage near Bough Beech in Chiddingstone late Thomas Taylor and formerly John Piggott . He alienated the butcher's shop to Edward Hoare and his wife Ann. (Manor of Tyhurst).

1766 Death

TAYLOR, Ann, widow from Hever

1770 Death

TAYLOR, William, wife Mercy

1777 William Taylor, bachelor, married Mercy Keeys. Witnesses: Richard Keeys, Richard Keeys junior.

1778 Son Richard

1784 Son William

1784 Witnessed marriage between Edward Brookes of Penshurst and Hannah Heath.

1784 Signed the parish accounts.

1836 Death, aged79. Mercy died in 1800 aged42. (monument in churchyard))

TAYLOR, John, wife Mary

1765 (bachelor) Married Mary Downe. Witness: John Austen

TAYLOR, Ann

1784 Witnessed marriage between John Finch of Edenbridge and Elizabeth Woollett

TAYLOR, Thomas

1734 to 1752 Held Great Sheffield. "Thomas Taylor for his tenement and lands" (Chiddingstone rates).

1759 to 1773 Occupied Furnace House farm, tenant of Petley. He was succeeded by widow Taylor 1777 to 1783.

TAYLOR, Thomas

1782 Death

TENNISON, Dr Thomas

1727 to 1742 Rector of Chiddingstone. He was also rector of Sundridge and Chevening.

TERRY, widow

1773 Death

THIRROWGOOD, Elizabeth, a traveller from Dublin

1773 Base son Henry

THOMAS, Susannah

1778 Susannah Thomas, spinster, married John Tipping. Witnesses: John Hills, Sarah Thomas

THOMAS, Sarah

1778 She witnessed marriage of John Tipping and Susannah Thomas

THOMPSETT, William, or TOMSETT, wife Sarah

1735 Death of daughter Susan

1755 Death

1759 Death of widow Thomsett

THOMPSON, Hester

1741. Death. Of Chiddingstone, buried in Hever.

THORPE, Oliver, of Penshurst, gent, wife Sarah, née Streatfeild

1703 to 1733 Owner and occupier of Little Frienden farm, in conjunction with his brother John

1733 Death, Will (PCC). His lands in Chiddingstone not mentioned.

THORPE, John, of Rochester, doctor in Physics of Oxford University. Brother of Oliver Thorpe above

1703 His grandfather John Thorpe of Westerham, clothier, left him and his brother John Little Frienden farm.

1703 to 1733 John and Oliver Thorpe held Little Frienden farm in conjunction.

1751 Death. Will (PCC).

1751 Doctor John Thorpe who held certain lands and wood 10 acres near Frienden Cross has died. The premises descended to his son John Thorpe. (manor of Sundridge Weald).

THORPE, John, esq, son of John Thorpe above

1751 Inherited Little Frienden from his father.

1756 to 1778 Owned Little Frienden farm

1778 John Thorpe, esq, being seized of certain lands and woods 10 acres near Frienden Cross hath alienated the same to William Woodgate esq (manor of Sundridge Weald).

THORP, Bartholomew

1779 Witnessed marriage between William Hollamby and Philly Bevan.

1782 Witnessed marriage of John Winter of Edenbridge and Anne Aylard

TIBBALDS, Hannah

1757 She married Richard Knight. Witness: William Lee

TIPPING, John, wife Susanna

1778 John Tipping, bachelor, married Susannah Thomas. Witnesses: John Hills, Sarah Thomas

1780 Son John

1782 Daughter Jenny

1783 relief 4s.

1784 Provided with a sack of peas by Edward Mitchell. 19s.

TOOTH, Edward, wife Sarah

1738 Death of wife Sarah

1740 Death

TOOTH, Edward, wife Elizabeth

1739 Edward Tooth married Elizabeth Knight

TOOTH, John, of Chiddingstone, carpenter, wife Sarah

1747 He (bachelor) married Sarah Carr of Cowden, spinster, at the Fleet.

TOPSEL, Thomas

1743 Occupied Marshope Mead, part of Doubletons farm in Penshurst

TORKINGTON, Mrs Anne

1780 to 1788 Owned Hale farm

TRAMPLIN, James, carpenter, wife Susanna

1773 Intruded into Chiddingstone from Edenbridge. Ordered to be sent back to Edenbridge but this quashed. (Quarter Sessione).

TRENDLE, William

1738 His heirs owned land east, north and west of Willmore Land.

TRICE, Thomas

1779 Witnessed marriage of Thomas Moore of Penshurst and Keziah Knell

TULLEY, William

1771 Witnessed marriage of Benjamin Chapman and Sarah Hills of Hartfield.

TURLEY, Edward

1759 Occupied Skinners, tenant of Piggott

TURNER, John, alias Fann, of Groombridge, mercer, wife Elizabeth

1723 to 1752 Owner of Walnut Tree Cross farm (Buckhurst) in Chiddingstone

1734 He granted Thomas Maynard of Withyham ,farmer, an annuity of £12 from Buckhurst.

1736 He leased Buckhurst and 14 parcels of land at Rendsleys Hoath to James Knight for 21 years.

1752 (of Framfield, Sussex). He left Buckhurst to his wife Elizabeth for life, remainder to his children Thomas, Moses, Richard and Sarah.

1754 Death of Elizabeth Turner

1764 Thomas Turner came into court and acknowledged to hold a quarter share of Buckhurst farm. (manor of Chiddingstone-Burghersh).

1775 Thomas Turner had purchased the shares of his brother Moses and his sister Sarah.

TURNER, Thomas, of East Hoathly, Sussex, mercer, son of John Turner (above)

1775 He had purchased the shares of his brother Moses and his sister Sarah in Buckhurst farm.

1775 He mortgaged Buckhurst farm to John Morris of Lewes, mason.

1777 He aliened Buckhurst farm to John Everest of Chiddingstone, gent.

TURNER, John

1693-1740 Owned a messuage and 7 acres, part of Bassetts (manor of Sundridge Weald) Also Roses farm and (from at least 1708) Mountjoyes.

1740 Death, intestate. The estate passed to his nephews, the sons of his brother Richard, in gavelkind.

1743 John Turner who held a messuage and 7 acres formerly part of Bassetts farm has died. The premises descended to his nephews William, John, Richard, George, Thomas and Robert who alienated their shares to their brother Richard. (manor of Sundridge Weald). Mountjoyes passed to Richard.

TURNER, Richard, of Leigh, yeoman, son of Richard Turner, brother of John Turner above. Wife Ann.

1722 to 1762 He owned land late Thomas Barr (Turners farm) in Chiddingstone and Leigh parishes. (Chiddingstone rates).

1743 Inherited a messuage and 7 acres formerly part of Bassetts farm from his uncle John Turner. Also Mountjoys alias Burnt House lands.

1743 to 1765 Owned the above properties. He also owned another part of Bassetts from his mother.

1744 Possibly constable of the hundred of Somerden. He reported that there were no Papists within his jurisdiction.

1767 Widow Turner held Turners farm. Richard had died intestate and Turners farm was shared by gavelkind between his heirs William and George. Mountjoyes, now called Burnt hHouse, passed to William Turner.

1778 Richard Turner had conveyed the two parts of Bassetts farm to Richard Barr Turner. (manor of Sundridge Weald)

TURNER, Richard Barr

1778 Richard Turner (above) had conveyed to him a messuage and 7 acres part of Bassetts farm (manor of Sundridge Weald).

1777 to 1794 Richard Barr Turner owned the above property.

TURNER, William, of Leigh, yeoman, son of Richard Turner, brother of John Turner above. Wife Elizabeth.

1743 to 1756 Owner of Roses farm, inherited from his uncle John Turner. Also Mountjoyes alias Burnt House lands.

1768 On the death of Richard Turner intestate he inherited a moiety of Turners farm. He is not mentioned later in the Chiddingstone rates.

1776 Death

TURNER, William. of Leigh, yeoman, son of Richard and Ann.

1768 Mountjoyes or Burnt House land allotted to him.

1780 to 1798 Owner of Mountjoyes or Burnt House land.

TURNER, George, of Leigh, yeoman, son of Richard Turner, brother of John Turner above. Wife Sarah.

1730 to 1762 Occupied Moorden farm, 224 acres, in Leigh, Chiddingstone and Penshurst, tenant of Richard Children.

1759 Owner of part of Jessop's Land. He occupied Willmott Land and Moorden, tenant of John Children.

1762 to 1770 Owner of Roses farm

1768 On the death of Richard Turner intestate George inherited a moiety of Turners farm.

1808 George and Richard Turner, the co-heirs of John Turner of Leigh, yeoman sold Turners farm to William Wells.

TURNER, John, of Kemsing, yeoman, son of Richard Turner, brother of John Turner above.

1767 to 1795 He appears to be the occupant of Mountjoyes or Burnt House lands, tenant of his brother William.

1770 to 1808 Owned and occupied Turners farm, together with George Turner.

1783 Witnessed marriage between Thomas Oliver and Sarah Turner

1808 George and Richard Turner, the co-heirs of John Turner of Leigh, yeoman, sold Turners to William Wells.

TURNER, Thomas, wife Elizabeth

1729 Occupied a farm at Rendsleys Heath, tenant of John Ashdowne.

1734 to 1735 Churchwarden

1743 (of Kingsborough) Possibly served on the Grand Jury (Quarter Sessions)

1718 Death of John Tye, butcher, who occupied a house and lands at Bowbeech, tenant of John Piggott (manor of Tyhurst).

1724 John Piggott for a house at Bowbeech Green, occupied by widow Tye (Survey of church seating).

1733 John Piggott occupied by widow Tye (Church Repair).

1747 Death

TYE, William, wife Susanna

1747 William Tye married Susanna Pearson

1748 Daughter Sarah

1752 Witnessed will of Thomas Butcher.

1760 Witnessed marriage of William Gower and Aves Mills

1766 Witnessed will of Isaac Roffey.

1797 Former occupant of Truggers Cottages.
