#### WICKING, William

1749 to 1797 Occupied Larkings and Penshurst Lands farms in Chiddingstone and Penshurst, tenant of Streatfeild. 1765 to 1797 Also Pemmel's Fields.

12784 He was paid 12s for keeping John Colchin three months at 1s a week.

## **WICKING, Thomas**

1785 Dame Hullion was paid 10s 6d for mending for him (a lot)

#### WIGSELL, Robert, of Leigh, then Chiddingstone, yeoman. Wife Ann.

1754 he bought Blackhouse from Jonathan Staple

1761 Overseer for Chiddingstone north side.

1773 He sold Blackhouse to John Woodhams who was to allow Robert and Ann to continue living in the house with food etc supplied for the rest of their lives.

#### WILLIAMS, Daniel, of Penshurst, schoolmaster, wife Mary

1724-32 Mr Daniel Williams owned Pottings, occupied by Edward Monk (Manor of Sundridge Weald 1s 2d).

1732 Will (PS). To wife Mary, remainder to sons Daniel and Richard, Pottings,

1732-37 Mary Williams owned Pottings. On her death which was before 1743 Pottings passed to her sons Daniel and Richard. 1743 Richard had alienated his share to Richard who is now seized (manor of Sundridge Weald 1s 2d),

#### WILLIAMS, Richard

1752 Richard Williams had alienated Pottings to John Woodgate. (manor of Sundridge Weald 1s 2d).

#### WILLIAMS, John, of Penshurst, wife Sarah

1770 John Williams, bachelor, married Sarah Cox, widow. Witness: Barnard Martin

# WINCKWORTH, Ann, a stranger

1754 Death

# WINTER, William, wife Ursula, daughter of Robert Abraham

1723 Robert Winter married Ursula, daughter of Robert Abraham, farmer, at Westerham.

1731 William Winter mortgaged messuages at Hill Hoath to Christopher Burfoot.

1732 William Winter mortgaged messuages at Hill Hoath to Anne Abraham.

1736 Death of wife Ursula

1738 Witnessed will of George Cronk.

1740 Death

# WINTER, William, son of William Winter above

1752 Servant of Thomas Streatfeild of Chiddingstone who left him £50 and an annuity of £5.

1765 Nephew of Ann Abraham, who left him messuages at Hill Hoath. William alienated the property to Henry Eagleton (manor of Penshurst and Halemote)

1778 Death

#### WINTER, John, of Edenbridge, wife Anne

1782 John Winter married Anne Aylard. Witnesses: Bartholomew Thorp, Richard Holmes.

1784 to 1785 He was paid £7-13s for keeping Ann Cross for more than a year. (Possibly this includes keeping Ann herself as well as her daughter Ann). Also Elizabeth Cross 13s 6d. Sarah Cross 6s. Aylard's child 6s (his wife's).

1766 Son William

1739 Death

# WOOD, John, wife Mary

1765 John Wood married Mary Aidy. Witness: Thomas Sales

1766 Son Michael

# WOOD, Richard, wife Mary

1770 Richard Wood (bachelor) married Mary Boakes, daughter of John Boakes Witnesses: John Boakes, Thomas Wood.

1770 Daughter Elizabeth

1772 Daughter Charlotte

1773 Occupied Blackhouse, tenant of Wigzell.

1780 Daughter Jane who died in 1781

1784 Daughter Martha

1809 John Boakes left a legacy to the children of his daughter, late the wife of Richard Wood, namely Elizabeth, William, Sarah, Jesse, and Martha.

# **WOOD, Thomas**

1770 Witnessed marriage of Richard Wood and Mary Boakes.

#### WOOD, Samuel

1785 Sold half a bushel of flour to the overseers 3s.

1785 His wife nursed Hider's wife 5s.

#### WOODEN, Thomas, of Shoreham, wife Penelope

1746 Thomas Wooden of Shoreham married Penelope Lambert of Shoreham

# **WOODGATE**, Thomas

1738 His heirs owned land south and east of Bridgefields.

## WOODGATE, John, gent

Died in 1727. Will (PCC) He left Stonewall to his eldest son William.

#### WOODGATE, alias LONGLEY, John See LONGLEY

# WOODGATE, Stephen, of Sevenoaks Weald, gent, brother of John Woodgate (1681-1754)

1722 to 1754 Owner of Chested and Seedcops (Seedcombes) farms. Also Gildridge farm.

1729 Stephen Woodgate seized of certain lands in Chiddingstone near a house formerly belonging to Richard Streatfeild and lands called Seedcombes. (manor of Sundridge Weald).

1731 He leased Silcocks Mead to John Head for 21 years.

1733 to 1754 Owner of New Tye which he had bought from William Streatfeild of Tonbridge. 100 acres in Chiddingstone and Hever.

1735 He bought Frienden farm from the heirs of William Woodgate.

1743 He bought Pilbeams, sold by the heirs of Sir George Rivers.

1754 Death. Will (PCC) Large amounts of property in Chiddingstone left to his nephew Rev Francis Woodgate and to niece Sarah, daughter of brother Henry Woodgate. To Francis he left Frienden farm(100 acres), Silcocks Mead (17 acres), and Tophill farm (60 acres)

# WOODGATE, William, of Stonewall, gent, son of John Woodgate above. (1695-1743)

1727 He inherited Stonewall from his father John.

1743 Death, intestate and unmarried. Presumably Stonewall was inherited in gavelkind by his brothers Henry, Francis, John and uncle Stephen. In 1747 they made a settlement.

## WOODGATE, Henry, of Tonbridge, son of John Woodgate, above (1701-1787)

1787 Will (PCC). To brother Francis my moiety of Stonewall, occupied by George Kidder. Also Hale Oak.

# WOODGATE, Rev Francis of Mountfield, Sussex, , son of John Woodgate, above. (1706-1790)

1754 His uncle Stephen Woodgate left him large amounts of property in Chiddingstone, including Frienden, Silcocks Mead and Tophill.

1754 to 1790 Owner of Chested and Seedcops (Seedcombes) farms, inherited from his uncle Stephen.

# WOODGATE, John, of Stonewall, Chiddingstone, gent, son of John Woodgate, above. (1712-1770)

1739 Churchwarden.

1743 Overseer of Chiddingstone parish.

1743 On the death of William Woodgate intestate and unmarried Stonewall was presumably inherited in gavelkind by his brothers Henry, Francis, John and uncle Stephen. They came to a settlement in 1747 by which John gained Stonewall, wellfield and a wood in Penshurst.

1743 to 1770 John lived at Stonewall. He owned extensive lands in Withyham, Hartfield and Forest Row.

1743 to 1762 Occupied Lewcross farm, tenant of Saxby

1752 Richard Williams had alienated Pottings to John Woodgate.

1753 Served on the Grand Jury (Quarter Sessions).

1769 His sister Alice Children of Tonbridge, widow, left him £200.

# WOODGATE, William, of Bletchingley

1735 Will (PCC) Frienden farm in Chiddingstone to be sold. It was bought by Stephen Woodgate.

## WOODGATE, Rose, of Somerhill in Tonbridge

#### 1744 Death

# WOODGATE, Henry, of Paternoster Row, London, bookseller.

1762 Declared bankrupt He owed £852 to Thomas Swayne.

1764 Bankrupt. Sale of a third part of two messuages and 140 acres of land in Chiddingstone, Hever and Penshurst. Subject to the life estate of Lydia Woodgate, spinster, aged 57. (London Gazette).

1764 Sale of a third part of Newtyes, Longshott, Crabbed Grove, Shippens Croft, Harper's Croft, Marsh Hope, Buckhurst.

# WOODGATE, Sarah, daughter of Henry Woodgate

1754 Her uncle Stephen Woodgate left her New Tye farm in Chiddingstone and Hever, 100 acres.

1760 Will (PCC). To sister Lydia Woodgate, remainder to her nephews Henry and John, sons of her late brother William Woodgate and to James Fremlin, son of her sister Ann Fremlin, deceased: lands called New Tye, occupied by John Fuller, and Low Buckhurst, occupied by James Knight.

# WOODGATE, Lydia, daughter of Henry Woodgate

1760 Her sister Sarah left her New Tye farm in Chiddingstone and Hever, 100 acres. She held it until 1797 but her heirs had sold their reversionary interests

# **WOODGATE**, Margaret

1754 Death

#### WOODGATE, William

1778 to 1783 Owned Frienden Wood which he had obtained from John Thorpe

# WOODHAMS, John, of Chiddingstone, yeoman, wife Mary, Ann

1757 to 1795 Occupied Millbrook or Somerden farm, tenant of Streatfeild. 1757 Lease. 1762 Lease. Succeeded in 1795 by Michael Woodhams.

1767 Son Michael

1769 Son John

1770 to 1795 He occupied Horseshoe farm, tenant of Wallis, later Streatfeild.

1771 Son William

1773 He bought Blackhouse from Robert Wigzell.

1774 Daughter Elizabeth

1774 Witnessed marriage of William Cole and Mary Potter

1777 Death of Mary Woodhams, aged 42. (monument in churchyard)

1782 Witnessed marriage between William King and Elizabeth Waite.

1784 Witnessed marriage between Richard Shoebridge and Ann Haywood.

1784 Supplied Elizabeth Best with 100 faggots 12s 6d.

1794 Death, aged 76. Will (PCC) Wife Ann. To sons John and William all stock etc on a farm in Hartfield and £100 each. To daughter Mary, wife of Thomas Hollamby, £100. To daughter Ann wife of John Aynscombe £100. To the granddaughters of Sarah, wife of John Hills, deceased £100. To daughters Elizabeth, Sarah, Sophia, the last two aged less than 21. They are the daughters of a second wife Ann. To son Michael Black House.

1808 Death of his wife Ann. Aged 37! (monument in churchyard).

# WOODHAMS, Sarah, daughter of John Woodhams

1769 Base daughter Elizabeth. An Elizabeth Woodhams died in 1780

1770 (spinster) She married John Hills. Witness: Thomas Smither

1795 John Woodhams left £100 to the three daughters of Sarah Hills, deceased, namely Sarah, Ann and Hannah.

1795 John Woodhams left £100 to his daughter Sarah at age 21. This must be a second daughter of that name.

1784 Elizabeth Woollett, spinster, married John Finch of Edenbridge. Witness: Thomas Woollett, Ann Taylor

# WOOLLETT, Thomas, wife Ann.

1765 to 1794 Licensed victualler at the Blue Boar.

1784 Witnessed marriage between John Finch of Edenbridge and Elizabeth Woollett.

1806 Death, aged 65. His wife Ann died in 1788 aged 65. (monument in churchyard)

# WRITE, William, wife Ann

1767 William Write, bachelor, married Ann Best. Witness: William Best

# WYATT, William, of Oxted, gent, wife Elizabeth

1756 He is to marry Elizabeth Saxby. She vested Lewcross farm to trustees to pay the profits to her for her sole use.

1764 He is now seized of a messuage and parcel called Shortlands 7 acres, in Chiddingstone now occupied by Richard Best. (manor of Chiddingstone- Burghersh).

1769 He leased Lew Cross farm to Richard Best for 21 years.

1775 Will of Elizabeth Wyatt (PCC). To niece Margaret Wyatt Saxby lands in Speldhurst and Lew Cross Farm in Chiddingstone. To sister Ann Floyd an annuity.
