1747 Settlement examination of Elizabeth. She had intruded herself into Chiddingstone. The last place of legal settlement of herself and her husband, who had absconded from her to Eynsford, was Eynsford. She was ordered to be sent to Eynsford.

1748 Daughter Sarah

**HAMBLETON, Thomas, of Sundridge, collar maker**

1778 John Blundell and John Tebbott had alienated a messuage and 20 acres at Coopers Corner (Piggotts farm) to Thomas Hambleton (manor of Sundridge Upland).

1780 to 1794 he owned Bartons farm near Bowbeeche, occupied by John Barton.

1785 he had bought Woodsgrove (Day's Castle) from William and John Day.

1794 He died.

1779 Base son Stephen Young

1782 Base son John Young

**HAMMOND, Peter, wife Mary, Mary, Hannah**

1737 to 1740 occupied Pottings near Stonewall, tenant of Williams.

1739 Son Peter

1741 Daughter Sarah who died in 1742

1743 Son John

1744 Death of Mary Hammond

1746 Peter Hammond married Mary Stephens

1758 Death of Mary Hammon

1759 Peter Hammond married Hannah Vorrill. Witness: Will Constable

1771 Death

1778 Death of widow Hammond.

**HANES, Mr Thomas, wife Margaret**

1778 Son Thomas

**HARBROW, Thomas, of Croydon, tanner, wife Ann**

1734 Thomas Harborough owned Harborough or Moorfields.

1764 Thomas Harborough for a tenement and lands called Great Sholefield , Bowlands and Beechenwood near Bowbeech, occupied by John Nightingale. (manor of Chiddingstone Burghersh).

1769 Will (PCC) Left his freehold messuage in Chiddingstone occupied by John Nightingale and other property to wife Ann, with remainder to daughter Elizabeth married to John Lynn of Seal, barber.

1774 Death

#### **HARRIS, John, wife Margaret**

1740 Owned Little Winkhurst farm.

1752 He had married Margaret the widow of George Allen and was therefore recorded as owning Little Winkhurst farm. When she died the farm passed to her daughters by George Allen.

#### **HARRIS, Thomas**

1740 to 1749 Owned Little Winkhurst farm

1762 to 1773 Occupied Piggotts farm near Coopers Corner, tenant of Blundell

#### **HARRISON, John**

1736 Acknowledged by Chiddingstone to Canterbury.

1744 Witnessed will of Mary Arnold of Rendsley Hoath

1752 Death

#### **HARRISON, Philip**

1753 Death

#### **HARROD, Mr Thomas, wife Charity**

1768 Thomas Harrod of Westerham, bachelor, married Charity Whapham. Witnesses: Henry Whapham, John Waterman

1769 Daughter Sarah

1785 Death of Mrs Harrod

#### **HARTLEY, William**

1764 Occupied Buckhurst farm in Hever and Chiddingstone, tenant of Woodgate.

**HARVEY, Thomas, of Tonbridge, esq**

1755 Thomas Harvey of Redleaf, Penshurst, gent, bought a messuage called Newhouse with 22 acres in Penshurst and Chiddingstone for £173.

1761 He bought from John Cowlard a messuage and five parcels called Squires Crofts or Cowlards, 29 acres, in Chiddingstone and Penshurst.

1758 Thomas Harvey of Tonbridge esq gave to John Children of Tonbridge esq Willmott Lands and also Jessup's Land.

1761 He bought Vexour farm in Penshurst and Chiddingstone from Deborah Northey.

1764 Deborah Northey alienated 4 acres of land in West Chested Mead to Thomas Harvey

1766 Witnessed marriage of William Carden of Penshurst and Sarah Wallis

1771 He gave George Children of Tonbridge Gunnell Mead in exchange for Barrett Mead.

1779 Death. He seems to have been succeeded at Moorden by George Children.

1784 Thomas Harvey esq being seized of 4 acres of land in West Chested Mead is dead,. By his will he devised it to his son the Rev Thomas Harvey, clerk, who is now seized (manor of Chiddingstone-Burghersh).

**HARVEY, Thomas, esq**

1782 Owned Doubletons farm in Penshurst.

**HAWES, Isaac**

1774 Settlement examination. He had practised the business of a farrier and cow leech in Kent for eight years but had fallen ill and forced to lie in barns and live by begging. Arrested in Chiddingstone and sent to his home parish of Purleigh in Essex.

**HAYES, Thomas, wife Mary**

1758 Thomas Hayes married Mary Jessop of Sevenoaks. Witness: Thomas Humphrey

**HAYNES, Francis, gent, wife Elizabeth**

1773 Death of Francis Haynes, gent (not in Chiddingstone)

1788 Death of Mrs Elizabeth Haynes, aged 68. (monument in churchyard). Will of Elizabeth Haynes of Chiddingstone, widow (PCC). Children: William Haynes, Elizabeth Moor, Margaret Haynes, Thomas Francis Haynes

**HAYNES, Thomas, son of Francis Haynes, above wife Martha**

1776 Thomas Haynes, bachelor, married Martha Frair. Witnesses: Henry Whapham, Margaret Haynes.

1777 James Goodwin being seized of a messuage and 16 acres of land in Chiddingstone late Green has alienated the same to Thomas Haynes (manor of Bowsell).

1777 John Goldsmith Goodyer has alienated Funks to Thomas Haynes. (manor of Bowsell).

1783 Thomas Haynes had been succeeded by William Haynes at Funks.

1790 Thomas Haynes had alienated Funks to the lord of the manor. (manor of Bowsell). However he was succeeded as owner by Sir Nelson Rycroft.

1790 Thomas Haynes alienated Little Funks to the lord of the manor.

**HAYNES, Margaret, daughter of Francis Haynes, above**

1776 She witnessed marriage of Thomas Haynes and Martha Frair

**HAYNES, William, of Chiddingstone, citizen and draper , son of Francis Haynes, above. Wife Amelia**

1777 to 1813 Owned Little Hale farm and Little Seedcombes farm.

1785 Witnessed marriage between Joseph Brown of St Giles, Camberwell and Frances Lucas.

1785 ( of Frienden borough) Served on Petty Jury (Quarter Sessions)

1813? Death, aged 73. His wife Amelia died in 1834 aged 73. (monument in churchyard).

**HAYNES, William**

1779 (infant) Death

**HAYWARD, Richard, of Woldingham, gent**

1732 Will (PCC) To son John Stonelake and Bowsell.

1732 Richard Hayward who held Stonelake and Critchfield has died. By will he devised his premises to his sons Thomas and Richard (manor of Sundridge Weald).

**HAYWARD, John. of Chelsham and Woldingham, gent. Son of Richard Hayward above.**

1737 to 1752 He owned Stonelake and Crutchfield, inherited from Richard Hayward. (manor of Sundridge Weald).

1753 Will (PCC). He left all his properties situated in Chiddingstone, Hever, Leigh, Sundridge or elsewhere to his brother-in-law John Brasier with remainder to his nephew Richard Hodsden.

**HAYWARD, widow**

1783 She was paid 8s for keeping Earl's girl

**HAYWOOD, Ann**

1784 Ann Haywood, spinster, married Richard Shoebridge. Witnesses: John Woodhams, Grace Sales

**HAZLEDEN, William, wife Elizabeth**

1785 William Hazleden, bachelor, married Elizabeth Waite. Witnesses: Thomas Hazleden, Sarah Hazleden

**HAZLEDEN, Thomas**

1785 Witnessed marriage between William Hazleden and Elizabeth Waite

**HAZLEDEN, Sarah**

1785 Witnessed marriage between William Hazleden and Elizabeth Waite.

**HEAD, John, of Chiddingstone, yeoman, wife Margaret**

1722 to 1752 Occupied Frienden farm, tenant of Woodgate. Succeeded by Robert Head.

1731 to 1734 Occupied Baileys, tenant of Hyde.

1731 He leased Silcocks Mead from Stephen Woodgate for 21 years. Succeeded by Robert Head

1740 Churchwarden

1753 Death

**HEAD, Robert, wife Susanna**

1745 Robert Head married Susanna Waghorn

1748 Son John. He witnessed the marriage of Susanna Head and Michael Bromley.  
Death 1808, aged 60

1749 He occupied Skipreed farm, tenant of Denman/ Piggott.

1750 Daughter Susanna who married (spinster) Michael Bromley of East Grinstead in 1774. Witnesses: William Mason, John Head

1754 He occupied Silcocks mead in succession to John Head.

1756 to 1783 Occupied Frienden farm, tenant of Woodgate. Followed by John Head (1788 to 1797)

**HEAD, Mary, widow, from Leigh**

1771 Death

**HEAD, Ann**

1781 Base son John

1785 Base daughter Harriet

**HEAD, Catherine**

1784 Catherine Head , spinster, married Henry Crundwell of Tonbridge. Witnesses: Michael Bromley, Philly Coster?

**HEAD, Mrs**

1785 Parish paid her expenses 11s. For keeping Mary Weller 5s.

**HEASMAN, Robert**

1785 He kept Elizabeth Langridge for 49 weeks at 1s a week.

**HEATH, William, of Leigh, gent**

1717 George Children who held a house and lands at Bowbeech called Hillyfields has aliened it to William Heath, gent. (manor of Chiddingstone-Cobham). This is Clouts farm.

1721 to 1746 Owner of Clouts farm and Polebrooks farm.

1737 William Heath possessed lands in the vicinity of Coles farm (manor of Sundridge Weald)

1740 owned land east of hammerhawe.

1745 Owned land north and east of Kingsfield, Syndercroft and Tye.

1746 Admon of William Heath of Leigh, granting the administration of his goods to his sister Mary, wife of John Burges. Includes a messuage and 80 acres at Bough Beech Green.

**HEATH, Hannah**

1784 Hannah Heath, spinster, married Edward Brookes of Penshurst. Witnesses: Susanna Langridge, William Taylor

**HEVER, Jeremiah or HEAVER**

1749 Formerly occupied three yards of meadow near Somerden Green at the backside of Sharpe's Place, tenant of Farnaby.

**HICKENS, Gabriel, wife Esther or HIGGINS**

1745 Occupied a cottage named Hammerhawe.

1748 Acknowledged by Penshurst to Chiddingstone.

1747 Burial of daughter Mary in Penshurst.

1770 Death of Hester, wife of Gabriel Higgins of Chiddingstone. Buried in Penshurst.

**HICKINS, Mary**

1777 Mary Hickins, spinster, married Richard Collins. Witnesses: Thomas Sales, James? Waters.

**HIGGINS, John, wife Mary**

1752 John Higgins married Mary Dabson

**HIGGINS, Sarah**

1759 Sarah Higgins married Adam Cox. Witness: Ann King

**HILDER, Edward**

1771 Occupied Gunnell Mead, 6 acres, exchanged between George Children and Thomas Harvey.

**HILDER, William and Sarah**

1774 Witnessed marriage of John Hilder of Penshurst and Mercy Cole

**HILDER, John, wife Mercy**

1774 John Hilder of Penshurst married Mercy Cole. Witnesses: William Hilder, Sarah Hilder

1774 Daughter Mercy

1774 Death of Mercy Hilder

**HILL, John**

1771 Witnessed marriage of Robert Bennett of Withyham and Hannah Randal

**HILLS, Sarah, of Hartfield**

1771 Sarah Hills married Benjamin Chapman. Witnesses: William Tulley, John Faulkner?

**HILLS, John, wife Elizabeth**

1779 John Hills, bachelor, married Elizabeth Knell. Witnesses: James Knell, Keziah Knell

1779 Son Thomas

1779 Elizabeth Hills witnessed marriage between Thomas Moore and Keziah Knell.

1779 Witnessed marriage between Thomas Smyther and Elizabeth Denton.

1781 Son John

1782 Son James

1784 Daughter Elizabeth

1784 to 1785 He and his wife received relief. 1785 Elizabeth was provided with a horse 1s.

1785 Daughter Jane

**HILLS, John, wife Sarah**

1770 John Hills, bachelor, married Sarah Woodhams, daughter of John Woodhams  
Witness: Thomas Smither

1775 Daughter Hannah

1777 Son John who died the same year (infant)

1778 Daughter Mercy

1778 He witnessed marriage of John Tipping and Susannah Thomas.

1779 John and Sarah Hill witnessed marriage between John Best and Anne Randall

1779 Death of Sarah Hills.

1795 John Woodhams left £100 to three granddaughters of Sarah Hills, namely Sarah, Ann and Hannah.

**HILTON, John, wife Anne**

1740 to 1752 Occupied Little Seedcombes farm, tenant of Swaysland.

**HOADLEY, Thomas, wife Sarah**

1783 to 1814 Occupied the northern part of Bore Place farm, tenant of Hyde.

1783 Daughter Elizabeth



1784 Death of Thomas Hoadley, infant, not publicly received.

1784-85 For keeping Edward Kingswood (a child) 52 weeks at 1s a week. For keeping Thomas Levett one week 6d.

1785 Death of Sarah Hoadley

1814 Death, aged 63. His wife Sarah died in 1816 aged 65. (monument in churchyard).

**HOARE, Thomas, wife Mary**

1749 Thomas Hoar married Mary Jenner

1751 Son John

1754 Son Thomas

1756 Daughter Sarah

1759 Son Richard

1778 John Jenner had alienated a moiety of two cottages at Chiddingstone Causeway formerly part of Bassetts to Thomas Hoare. (manor of Sundridge Weald).

**HORE, Thomas ?**

1763 Witnessed marriage of William Medhurst of Leigh and Ann Cross.

**HOAR, Mary, infant**

1750 Death

**HOARE, Edward, wife Ann**

1764 William Taylor had alienated the butcher's shop at Bowbeeche to Edward Hoare. (manor of Tyhurst).

1764 to 1791 Edward Hoare owned and occupied the butcher's shop at Bowbeeche.

1777 Witnessed marriage between Thomas Ingram and Else Smith ?

**HOARE, John, wife Sarah**

1775 John Hoar, bachelor, married Sarah Holford. Witness: George Langridge

1775 Daughter Sarah

1778 Son John

1784 Daughter Elizabeth

1784 to 1785 Received regular relief.

**HOARE, John, wife Mary**

1776 Son Thomas and daughter Mary. Thomas died in 1777 (infant)

1780 Daughter Ann

1783-855 Parish paid her the rent for John Daniel £3 a year.

1785 She provided 2 dozen of flax for the workhouse 16s.

**HODGE, William**

1781 Death

**HODSDEN, Richard**

1780 to 1801 Owner of Stonelake farm. He was left it in the will of John Hayward (1753) in succession to John Brasier.

**HOGSFLESH, Thomas, of Otford, miller**

1782 William Piggott had alienated Oakenden to him.

1789 Death. Will (PCC) he left Oakenden to his son John Hogsflesh.

**HOLDER, William , labourer, wife Mary**

1724 Occupied Cranstead House with Edward Humphrey, tenant of Sir William Humphrey, bart.

1736 Daughter Hannah

**HOLFORD, Mary**

1769 Base son John

1770 to 1775 John Gilbert paid £3-18s a year for the maintenance of his natural child by Mary Holford.

**HOLFORD, Sarah**

1775 Sarah Holford, spinster, married John Hoar. Witness: George Langridge

**HOLLAMBY, John**

1730 to 1733 Occupied Funks, tenant of Goldsmith

**HOLLAMBY als NICHOLAS, John**

1701 Died leaving sons John , James, Thomas, Richard and William. Will (PS)

**HOLLAMBY als NICHOLAS, John, of Coles in Chiddingstone, yeoman, son of John Hollamby above, wife Hannah**

1701 Inherited Coles from his father John Hollamby

1731 He leased Kiln farm from Thomas Spence for 21 years.

1735 Death of son John aged 23.

1737 Churchwarden

1738 Witnessed will of John Hyde of Bore Place.

1744 He released Coles to Thomas Baldwin of Plaxtol, gent to pay off a mortgage of £562-7s-6d to John Whittaker. However he continued to be rated for the property until his death.

1744 Death of daughter Hannah, aged 25.

1747 Sarah St John leased to him lands to the north of Coles farm together with Dung Croft and the Three Crutch Fields.

1749 Death, aged 74. Will (PS). He left his property to his wife Hannah and to his sons Thomas and Benjamin, and daughter Mary. Witnesses: Samuel Bannister, Elizabeth Taylor, Thomas Horton.

1750 Hannah was a party in the sale of Coles to Sarah St John junior.

1776 Death of wife Hannah, aged 88 (monument in churchyard)

**HOLLAMBY als NICHOLAS, James, son of John above**

1701 With his brother Thomas he inherited the Three Crutch Fields and Dung Croft, part of Coles.

1727 James Hollamby of Chislehurst, yeoman, and his brother Thomass sold the Three Crutch Fields and Dung Croft to John Streatfeild.

**HOLLAMBY, Thomas**

1747 Death

**HOLLAMBY als Nicholas, Thomas, of Penshurst, yeoman, son of John Hollamby above.**

1750 He and his brother Benjamin sold Coles to Sarah St John junior.

1762 to 1780 He occupied Kiln farm, tenant of Attwood.

**HOLLAMBY, Benjamin, of Chiddingstone, yeoman, son of John Hollamby, above, wife Elizabeth, Sarah**

1750 He and his brother Thomas sold Coles to Sarah St John junior.

1750 to 1759 He occupied Kiln farm, tenant of Kebbel.

1751 Now described as husbandman. He leased Coles from Sarah St John junior for 12 years.

1752 Son Benjamin

1753 Daughter Elizabeth

1757 Mentioned as an alternative to Jeremiah Colyer as borsholder for Frienden borough.

1764 Death of Elizabeth Hollamby

1778 Benjamin Hollamby of Tandridge, widower, married Sarah Carden. Witnesses: Elizabeth Sanders, John Sanders.

1767 Thomas Hollamby of Chiddingstone, who already possessed one moiety now bought the other moiety from Thomas Medhurst. Now described as a messuage with 5 parcels, 15 acres, near Somerden Cross Also 3 yards in Millbrook Mead. 1768 The property mortgaged. 1769 The property sold to Ann Streatfeild who in 1779 released it to her son Henry.

If Philly was born in 1763 she would have been 16 when she married William.

**HOMWOOD, William, wife Ann**

1735 Tenant to Robert Streatfeild for a property in Chiddingstone South.

1737 Son William who died the same year

**HOOD, Samuel, wife Elizabeth**

1761 Son William

1763 Daughter Susanna who died the same year

1765 Daughter Elizabeth

1769 Son Simon

1785 Received some relief.

**HOOD, Ann and Mary, infants**

1775 Deaths

**HOOD, Elizabeth**

1784 Base daughter Susan Boakes. Elizabeth received 2s relief.

**HOOK, William, wife Jane**

1743 to 1745 Occupied Millbrook alias Somerden farm, tenant of Hyde.

1743 Daughter Mary

1745 Son John

1750 Son Charles

1752 Acknowledged by Chiddingstone to Chigwell in Essex with children Mary, John, and Charles.

**HOOK, .....**

1783 to 1785 Hook's child kept by John Card who was paid 6d a week by the parish (clearly an infant).

1746 Son John

**HOOKER, Thomas, wife Sarah**

1775 Daughter Hester

**HORTON, Mr**

1784 He was paid 1s for a copy of the examination of Jonathan May.

**HOSKINS, William, esq, of Oxted, wife Martha**

1740 to 1743 Owner of Upper Gravel Pit farm succeeding Charles Hoskins, gent. He also owned Henden, largely in Sundridge.



1768 Martha Hoskins widow leased Henden in Sundridge, Brasted and Chiddingstone for 21 years to John Cogger

**HOSKINS, Charles, esq, of Barrow Green Place in Oxted, heir of Sir William Hoskins.**

1746 to 1762 Owner of Upper Gravel Pit farm, succeeding William Hoskins, esq. He also owned Henden.

1768 to 1790 Henden was owned by Miss Susannah Chicheley Hoskins...

**HOWE, Henry, wife Elizabeth**

1752 On the death of Margaret, widow of George Allen, he inherited a half share in Little Winkhurst farm through his wife Elizabeth, daughter of Margaret.

1778 Sarah Allen of Sundridge and Henry Howe in right of his wife the sister of the said Sarah for a messuage or tenement called Winkhurst and certain lands adjoining containing 9 acres (manor of Sundridge Upland).

1785 Sarah Allen died and in 1801 Mrs Howe was recorded as an owner of Little Winkhurst.

**HUBBLE, Benjamin**

1767 to 1763 Occupied Bushes farm, tenant of Hyde.

**HUBBLE, William, of Chevening, wife Ann**

1785 William Hubble, widower, married Anne Potter. Witnesses: Thomas Marchant, Mary Hubble.

1788 to 1797 Occupied Bushes farm, tenant of Hyde

**HUBBLE, Mary**

1785 Witnessed marriage between William Hubble and Anne Potter.

**HUGGET, Elizabeth**

1752 Death

**HUGGETT,, George**

1760 Death

**HULLION See HURRION**

**HUMPHREY, John, licensed victualler, wife Rebecca**

1740 to 1743 Occupied the Castle Inn, tenant of Streatfeild.

1742 Daughter Sarah

1744 Son John, baptised in Penshurst.

**HUMPHREY, John, of St Margarets, Rochester, wife Rachel**

1708 to 1754 Owned Blackhouse farm in Chiddingstone.

1754 Sold Blackhouse to Jonathan Staple of Sevenoaks who sold on to Robert Wigzell of Leigh, yeoman.

**HUMPHREY, John, wife Mary**

1762 to 1801 Occupied Hever Castle farm in Hever and Chiddingstone.

1774 Witnessed marriage of Samuel Waters of Chiddingstone and Elizabeth Purser, widow, at Hever.

**HUMPHREY, William**

1768 Elizabeth Medhurst devised Slaters to William Humphrey who later aliened it to Robert Nightingale (manor of Tyhurst).

**HUMPHREY, Thomas, wife Sarah, Mary**

1762 Thomas Humphrey married Sarah Abraham. Witnesses: Mary Whapham, Elizabeth Saxby

1765 Death of Sarah Humphreys

1766 Thomas Humphrey, widower, married Mary Cronk (spinster). Witnesses: William Welfare, Mary Welfare.

**HUMPHREY, William of Edenbridge, wife Mary**

1784 William Humphrey, bachelor, married Mary Eve. Witnesses: Richard Sutton, Cecilia Crothall

**HUMPHREY, Richard, of Hever, wife Ann. See Hever**

At an unknown date Elizabeth Eastwood alienated Stoneyfield farm and the "Chequer" to him. After his death the property passed to his only son John. (manor of Millbrook)

1767 to 1781 Occupied Hever Lodge and Cransted farm, tenant of Waldo.

1769 Death of daughter Ann, aged 7 months.

1779 Richard Humphrey of Stanford Borough served on the Grand Jury (Quarter Sessions).

1781 Death, aged 49. Succeeded by his son John. (monument in churchyard)

1785 Death of widow Ann Humphrey of Hever Lodge, aged 40. (monument in churchyard)

**HUMPHREY, Mrs**

1785 Paid 1s 2d for making clothes for the poor.

**HUMPHREYS, Sir William**

1715 to 1735 Hever Castle farm and Hever Lodge in Hever and Chiddingstone belonged to him. He died in 1735

**HUMPHREYS, Sir Orlando, son of Sir William above**

1735 to 1737 Owner of Hever Castle farm, Hever Lodge and Cransted farm in Hever and Chiddingstone. Succeeded by his daughter Mary.

1737 to 1746 Mary was married to William Bell Waring.

1748 to 1749 Mary was married to Thomas Gore. In 1746 to 1749 Charles Gore held the Hever Castle estate.

1749 The Hever estate was sold to Timothy Waldo.

**HUMPHREYS, Thomas, wife Ann**

1755 Thomas Humphreys married Ann Medhurst, spinster. Witnessed by William Lettington

1756 Son William

1757 Daughter Ann

1758 Thomas Humphrey witnessed the marriage of Thomas Hayes and Mary Jessop of Sevenoaks.

1760 Thomas Humphrey witnessed marriage of Sampson Cornwall of Penshurst and Elizabeth Crayford.

1760 Son Thomas who died the same year from smallpox

1760 Deaths of Ann and Thomas Humphreys from smallpox.

1761 Relief paid to Thomas Humphrey's family £1-4s.

**HUMPHREYS, Ann, of Hever**

1769 Death

**HUMPHREYS, William**

1755 Witnessed marriage of James Daniel and Margaret Oxley

1764 Death of William Humphrey

**HUMPHREYS, William, infant**

1765 Death

**HUMPHREYS, John, wife Elizabeth**

1776 Daughter Sarah

1781 Daughter Ann who died in 1783

**HUMPHREYS, Edward, wife Sarah**

1732 Edward Humphrey married Sarah Medhurst

1732 Edward Humphrey occupied a messuage and 11 acres in Chiddingstone, tenant of John Cronk, carpenter

1735 Daughter Sarah

1761 Relief for Edward Humphreys 8s.

1762 Death from smallpox

1762 Death of Sarah Humphreys, widow, from smallpox.

**HUMPHREYS, John, wife Mercy**

1777 John Humphreys of Sundridge, bachelor, married Mercy Poplett. Witness: William Carpenter

1778 Son John

1781 Son Thomas

1782 Daughter Mary

**HUMPHREYS, John, wife Mary**

1779 Daughter Jane

1784 Daughter Sarah

1785 Received 5s relief.

**HUMPHREYS, Thomas**

1784 Death

**HUNT, Robert, wife Ann**

1774 Robert Hunt, bachelor, married Anne Paifreble. Witnesses: Ann Sears, Homden Hunt

1776 Son Abraham

1778 Daughter Lydia

**HUNT, Homden**

1774 Witnessed marriage of Robert Hunt and Anne Paifreble

**HUNTLEY, James, of Sevenoaks, wife Sarah**

1737 James Huntley married Sarah Barnaby

1785 Death of Sarah Huntley

**HUNTLEY, Thomas**

1754 Death

**HURRION or HULLION, James, wife Elizabeth**

1765 James Hurrior married Elizabeth Whale. Witness: John Whale

1765 Son James

1767 Daughter Elizabeth

1769 Daughter Mary

1771 Daughter Sarah

1773 Daughter Ann who died the same year (infant)

1774 Daughter Hannah

1777 Son Samuel

1779 Daughter Mercy

1782 Son John

1783 Dame Hullion was paid 10s 6d for mending for Thomas Wicking. A lot.

1785 Daughter Ann

1785 Edward Mitchell was paid 1s a week for keeping his girl 23 weeks. John Longley was paid 8s for keeping his child.

**HYDE, John, of Sundridge, gent. Wife Mary**

1718 to 1729 Owned Bushes farm on Chevening and Chiddingstone. Also Bore Place in Chiddingstone

1729 Will (PCC). To eldest son John pictures and books. To youngest son Strode £10. Property in Sundridge to son Saville and four daughters Elizabeth, Sackville, Frances Tidmarsh and Margaret. Brothers William and Edward.

### **HYDE, John of Bore Place, esq., son of John Hyde, above**

1729 His father left him the pictures and books at Bore Place.

1728 to 1740 John Hyde owned Baileys and Ivy House (alias Sleighters als Theobalds) in Chiddingstone. He also owned Millbrooks or Somerden farm, Sharpe's Place, Bushes farm and Bore Place.

1740 Will (PCC). To nephew Bernard, son of Strode, an annuity out of Melbrook farm in Chiddingstone and Penshurst. To his mistress Elizabeth Payne an annuity of £50. To his natural children named John, Henry and Savilla. £1000 each at age 21. To his brother Saville messuages and farms called Edlows, Sleighters als Theobalds and Sharpe's Place. To his brother Strode Bore Place and the manor and farm of Melbrooke. To his mother Mary the pictures at Sundridge Place.

Possibly Edlows is Bushes farm.

1743 John Hyde esq who lately held a messuage and several parcels of land called Sleighters als Theobalds has died. He gave Theobalds to his brother Saville. Saville is since dead and by will Saville gave Theobalds to his widow Sarah for life, remainder to his son John. (manor of Sundridge Upland).

1747 Reference to John Hyde of Cheapside, natural son of John Hyde esq and Savilla, natural daughter, married to Thomas Rowe of St Clement Danes, haberdasher.

John Hyde of Cornhill, hardwareman, seems to have inherited Sharpe's Place and Sleighters als Theobalds in Chiddingstone. However this contradicts other information.

### **HYDE, Saville, son of John Hyde, above, wife Sarah**

1725 His father left him property in Sundridge.

1740 His brother John left him messuages and farms called Edlows, Sleighters als Theobalds and Sharpe's Place in Chiddingstone, Penshurst., Sevenoaks, Chevening, and Brasted. Saville had a son John.

1743 Saville had died (manor of Sundridge Upland). In 1747 Theobalds was sold to Sir Thomas Farnaby.

1755 John Hyde, esq, who held Sharpe's Place etc is dead. Sharpe's Place was devised to Saville Hyde his brother who has also died. Saville devised Sharpe's Place to Sir Thomas Farnaby, bart. (manor of Bowzell).

### **HYDE, John, son of Saville Hyde**

1741 to 1789 owned Baileys in Chiddingstone., presumably succeeding his father who succeeded John Hyde above.

1767 On the death of Bernard Hyde he inherited the northern part of Bore Place farm.

1782 John Hyde appointed Solomon Fletcher of Sundridge gamekeeper in the manor of Sundridge Weald

1789 Death of John Hyde of Sundridge and Quorndon in Leicestershire. He was succeeded at Bore Place North by his son Saville John Hyde of Quorndon.

**HYDE, Strode, esq, of Boar Place, Chiddingstone, son of John Hyde, above, wife Elizabeth**

1729 His father left him £10

1740 His brother John left him Bore Place and the manor of Melbrooke and Melbrooke farm, remainder to Bernard Hyde. Strode had a daughter Elizabeth.

1741 Appointed Timothy Duke to be gamekeeper within his manor of Millbrook.

1742 Death. Will (PCC) to wife Elizabeth Boar Place, Somerden, etc. to daughter Elizabeth £600 of South Sea annuities. To son Bernard estates at Hammersmith and Gillingham. His brother Barnard inherited Millbrook farm.

**HYDE, Bernard, gent, son of Strode Hyde, wife Susanna**

1740 His uncle John Hyde left him an annuity of £14 out of Melbrook farm in Chiddingstone and Penshurst.

1741 On the death of his brother Strode he inherited Millbrook or Somerden farm and Bore Place .

1742 His father left him estates at Hammersmith and Gillingham.

1749 to 1756 He owned Bushes farm in Chevening and Chiddingstone. In 1763 a map of Bore Place Manor farm belonging to Henry Streatfeild shows Bushes and part of Bore Manor farm to the west as belonging to John Hyde, esq.

1748 Daughter Mary Elizabeth

1748 Barnard Hyde of Bore Place leased Millbrook farm to Samuel Overy for 14 years.

1756 Bernard Hyde has appointed Thomas Roots his menial servant gamekeeper of and within the manor of Milbrooke in Chiddingstone with power to kill game for the lord's use and to take and seize guns etc.

1757 Barnard Hyde leased Millbrook or Somerden farm to John Woodhams for 14 years. However by 1760 the farm belonged to Henry Streatfeild.

1767 Death. He sold the southern part of Bore Place to Henry Streatfeild before 1762.

**HYDE, John, of Cornhill, hardwareman, (natural?) son of John Hyde above**

1750 Sir Thomas Farnaby mortgaged a moiety of Sleighters als Theobalds and Fowkes als Sharpe's Place to John Hyde of Cheapside, hardwareman for £1000.

**HYDER, Joseph, wife Martha**

1784 Son Joseph. The parish paid 1s 9d towards the christening of his child. His wife was nursed by Wood's wife. Received some relief.
