1761 Churchwarden of Chiddingstone north side.

1765 Witnessed marriage of John Wood and Mary Aidy.

1767 to 1773 Occupied Beachlands, tenant of Hyde

1777 Witnessed marriage of Richard Collins and Mary Hickins

**SALES, Thomas, junior**

1746 to 1752 Occupied Hale farm

**SALES, Grace**

1784 Witnessed marriage between Richard Shoebridge and Ann Haywood.

**SALMOND, Edward**

1749 to 1752 Owned Blackbaldock farm in succession to Joseph Beckett. I do not know what followed.

**SALTONSTALL, Richard**

1738 His land lay east and south of Willmore Land.

**SANDERS, Elizabeth and John**

1773 to 1783 Occupied Roses farm, tenant of Avis

1778 They witnessed marriage between Benjamin Hollamby of Tandridge and Sarah Carden.

**SAUNDERS, John**

1738 He had lately owned land west of Bridgefields.

**SAUNDERS, John**

1765 to 1780 Occupied Moorden farm, tenant of Harvey.

**SANDERS, Richard, or SAUNDERS**

1767 to 1797 Occupied Hale Oak, tenant of Woodgate

**SAXBY, Henry, of Penshurst, yeoman, son of Henry and Anne Saxby**

1726 Will (PS). To brother John his lease of Salmons .Brother Robert, sister Mary Skinner, widow, sister Sarah Saxby, sister Anne Trice (deceased), sister Joan deceased. Witnesses: John Constable, George Fletcher, Richard Taylor junior

**SAXBY, John, of Penshurst, yeoman, son of Henry and Anne Saxby, wife Elizabeth**

1726 John Saxby inherited lease of Salmons from his brother Henry.

1733 John Seyliard leased Salmons and Hartridge to John Saxby of Penshurst, yeoman for 21 years at £170 a year.

1733 to 1752 Occupied Salmons and Watstock farms , tenant of Seyliard.

1738 Death of his son Henry, aged 21

1741 Death of his wife Elizabeth aged 67. (monument in churchyard).

1750 Occupied Salmonds, Watstock, Southfields, tenant of John Seyliard of Bletchingley.

1752 Death. He was succeeded by Robert Saxby.

**SAXBY, John**

1754 (of Salmons) Death

**SAXBY, Elizabeth of Penshurst, spinster**

1738 John Constable sold to her Shortlands (Lew Cross). In 1740 it was in the occupation of Mr William Saxby., then John Woodgate

1756 Elizabeth Saxby is to marry William Wyatt of Oxted, gent. She vests Lew Cross farm in trustees to pay the profits to her for her sole use.

**SAXBY, Mr William, probably brother of Margaret Wyatt Saxby**

1738 He was constable for Upper Somerden borough.

1740 Occupied Lew Cross farm, tenant of Elizabeth Saxby.

1788 Margaret Wyatt Saxby left Lew Cross farm to her brother William.

**SAXBY, Robert, wife Mary**

1752 to 1767 Occupied Salmons and Watstock, tenant of Scullard, in succession to John Saxby

1762 Witnessed marriage of John Everest and Susanna Pearch

1764 George Scullard leased Salmons to Robert Saxby for 7 years at £189-4s a year

1769 Death of wife Mary, aged 46?

1770 Richard Saxby occupied Watstock.

1799 Death, aged 83. (monument in churchyard).

**SAXBY, Richard, wife Sarah**

1740 to 1756 Occupied Beachlands, tenant of Hyde.

1749 to 1767 Occupied Hunts farm, tenant of Streatfeild.

1751 Son John

1761 witnessed marriage of Edward Fiveash and Mary Kingswood?

1770 to 1774 Occupied Salmons and Watstock farms, tenant of Scullard. Succeeded by John Saxby

**SAXBY, Mary**

1747 Death

**SAXBY, .....**

1752 Occupied Lockskinners farm , tenant of Streatfeild (Particulars of Streatfeild estate).

**SAXBY, Elizabeth**

1762 Witnessed marriage of Thomas Humphrey and Sarah Abraham.

**SAXBY, William**

1737 Occupied Paynes Land, tenant of Seyliard.

1761 Relief for William Saxby 3s.

1763 Death

**SAXBY, Margaret Wyatt**

1775 Her aunt Elizabeth Wyatt left her lands in Speldhurst and Lew Cross Farm in Chiddingstone.

1775 to 1794 She owned Lew Cross farm, tenant Richard Best.

1788 Will (PCC). She demised Lew Cross farm to her brother William Saxby.

**SAXBY, Richard, junior, wife Mary**

1767 Witnessed marriage of Samuel Bevan and Susannah Rye?

1768 Daughter Mary

**SAXBY, John, of Hadlow, gent, wife Elizabeth, daughter of Michael Bassett.**

1744 John Saxby the younger who has lately intermarried with Elizabeth Bassett acknowledged to hold a third of Buskhope jure uxoris. (manor of Sundridge Weald). This also applies to Prinkham.

1757 The lands of Michael Bassett were divided between his three daughters and their husbands.

1757 to 1790 He owned Bradney Island. (Aylande)

1770 John Burgis in right of his wife Sarah, William Everest in right of his wife Mary and John Saxby in right of his wife Elizabeth had divided the lands of Michael Bassett and John Saxby had received Prinkham.

1777 Ann Streatfeild leased Salmons and Watstock to John Saxby the elder of Hadlow , yeoman, and his sons John Saxby the younger of Penshurst, yeoman, and Michael Saxby of Penshurst, yeoman, for 21 years at £193-12s-6d a year, after seven years £226 a year. Michael Saxby was to dwell at Salmons and let Watstock to “careful people”.

1790 Will (PCC) He owned Prinkham, occupied by his son Michael, and lands in Penshurst to his son John. To son Michael Salmons and Watstock rented from Henry Streatfeild, esq.

1790 To son John my barn with four pieces of land thereto belonging containing 12 acres known as Aylande in Chiddingstone near to a certain place there called Chafford Bridge Mead.

**SAXBY, Michael of Penshurst, son of John Saxby of Hadlow, yeoman, wife Sally**

1777 Ann Streatfeild leased Salmons and Watstock to him by agreement with his father and brother. He was to dwell at Salmons and to let Watstock to “careful people”

1760 Michael Saxby of Penshurst , bachelor, married Sally Martin. Witnesses: Thomas Shorey, Mary Whapham

1780 to 1801 Michael Saxby occupied Salmons and Watstock.

1782 to 1812 Michael Saxby occupied Prinkham farm.

1819 Death, aged 69. Sally died in 1836 aged 86. (monument in churchyard).

**SCOTT, Samuel, labourer, wife Sarah**

1724 Tenant of Held House.

1732 Sarah was the niece of John Kingswood

1745 Death

1756 Death of widow Scott

**SCUDDER, John, wife Elizabeth**

1755 John Scudder married Elizabeth Bevan, spinster: Witnesses: Thomas Moyce, George Bevan

1755 Son Jesse

1756 Death of Elizabeth Scudder

**SCULLARD, George, of the Inner Temple, London, wife Hester**

1761 On the death of Ann Seyliard George Scullard inherited Waterlakes farm in right of his wife Hester.

1775 Death of George Scullard. Will (PCC). He bequeathed all his property to his wife Hester.

1775 to 1797 Widow Scullard owned Waterlakes.

**SEAL, John, of Chiddingstone, husbandman, wife Susanna**

1746 (bachelor) Married Susanna May, spinster, of Sevenoaks.

**SEAL(E), William, presumably a blacksmith, wife Ann**

1756 William Seal of Brenchley married Ann Palmer. Witness Thomas Bulb?

1756 Son Richard who died in 1757

1757 Daughter Molly

1759 Son William

1761 Son Thomas Beckett

1762 Son Richard who died the same year

1762 to 1791 Occupied Butt House and forge, tenant of Streatfeild

1765 Son Robert

1767 Death of Nanne Seal, infant

1783 Churchwarden.

1784 Paid 8s 6¼d for work done at the workhouse. Ditto 1785 12s. Also a bill to the overseers for 15s 6d.

1785 Paid £1-0s-6d for several journeys on parish business.

**SEARLES, Thomas, senior, of Chiddingstone, yeoman, wife Mercy**

1755 Will (PCC). To wife Mercy and son George his messuage at Medhurst Row in Edenbridge. To son Thomas £10. To son John 1s. To daughters Mercy and Mary Searles £15 each. Witnesses Thomas Stubberfield, Thomas Nye

**SEARLES, Thomas, of Chiddingstone, farmer, son of Thomas Searles above, wife Sarah**

1746 (bachelor) Married Sarah Rootes of Leigh, spinster

**SEARS, Edward, wife Ann, travellers from Bexley**

1774 Daughter Mary

1774 Ann Sears witnessed marriage of Robert Hunt and Anne Paifreble?

**SELBY, Elizabeth**

1762 William Jewell of Sevenoaks left Breeches farm to his widow Hester, with remainder to his cousin Elizabeth Selby. In 1780 and 1788 Breeches farm was owned by Selby.

**SEYLIARD John, of Pendhill and Salmons, wife Margaret**

1675 to 1745 Owner of Waterlakes farm in Chiddingstone.

1745 Death. Succeeded at Waterlakes by his son John.

**SEYLIARD, Lady**

1744 To be sold pursuant to a Decree of the High Court of Chancery a capital messuage called Boxley abbey and also several other freehold farms in the parishes of Boxley, Brasted and Chiddingstone, late the estate of the Lady Seyliard. (London Gazette)

**SEYLIARD, John, of Bletchingley, son of John Seyliard above, wife Ann**

1733 (junior) Leased Watstock to John Saxby of Penshurst for 21 years.

1745 He inherited Waterlakes farm from his father.

1750 Will (PCC) t

To wife Ann mansion house called Salmonds in Penshurst together with Watstock farm occupied by John Saxby. Also Bowbeech and Waterlakes farm in Chiddingstone occupied by Richard Gasson.

1752 John Seyliard who held Waterlakes has died. The premises descended to his daughter (Ann). (manor of Sevenoaks Weald).

1764 Daughter Ann died in 1760 aged 12 and Waterlakes passed to Hester, daughter of Thomas Seyliard, John's brother. Hester married George Scullard. (manor of Chiddingstone-burghersh)

1749 Richard Shoebridge of Chiddingstone served on the Petty Jury (Quarter Sessions).

1757 Richard Shoebridge married Mary Smith. Witness: Henry Eagleton

1759 Witnessed marriage of Edward Waite of Penshurst and Susanna Shoebridge

**SHOEBRIDGE, Susanna**

1759 Susanna Shoebridge married Edward Waite of Penshurst. Witnesses: Richard Shoebridge, Thomas Waite

**SHOEBRIDGE, Edward, wife Elizabeth**

1734 His land lay west of Moorden in Penshurst

1739 Death of wife Elizabeth

1740 Death

**SHOEBRIDGE, Jane**

1770 Base son John

1771 Jane Shoebridge married William Hollamby. Witness: John Cole

**SHOEBRIDGE, Jesse**

1777 Witnessed marriage of George Aylard and Anna Cross

**SHOEBRIDGE, Richard, wife Ann**

1784 Richard Shoebridge , bachelor, married Ann Haywood. Witnesses: John Woodhams, Grace Sales

1784 Simon Medhurst left a farm in Speldhurst to nephew Richard Shoebridge.

1784 Constable.

1785 (junior) Daughter Ann

1785 Kept Henry Kingswood for 47 weeks at 1s a week and making some clothing 1s.

**SHOEBRIDGE, Richard, wife Susanna**

1704 Born, not in Chiddingstone. Died 1792, aged 88. (monument in churchyard)

**SHOEBRIDGE, Richard, son of Richard above, wife Ann**

1729 Born, not in Chiddingstone. Died 1816 aged 87 (monument in churchyard)

**SHOEBRIDGE, William, wife Hannah**

1785 William Shoebridge, bachelor, married Hannah Crowhurst . Witnesses: George Dulake, Ann West

**SHOEBRIDGE, Mrs**

1782 Death

**SHOREY, Charles**

1770 Witnessed marriage of Thomas Shorey and Sarah Denman.

**SHOREY, Mary**

1780 Witnessed marriage between James Hardis Morton and Mary Whapham.

**SHOREY, Thomas, of Chiddingstone, yeoman, wife Sarah**

1770 to 1788 Occupied Hunts farm, tenant of Streatfeild.

1770 Thomas Shorey, bachelor, married Sarah Denman. Witnesses: John Piggott, Charles Shorey

1771 Son John who died in 1772 (infant)

1773 Son William

1775 On the death of John Denman Sarah inherited a third of a moiety of Skipreed. In 1780 Thomas and Mary alienated it to William Piggott.

1776 Daughter Sophia

1778 Son Thomas

1776 Overseer of the poor of Chiddingstone.

1778 He witnessed marriage of William Boakes and Ann Leigh

1779 Daughter Sarah

1780 Witnessed marriage between Michael Saxby and Sally Martin.

1783 Son John

1784 and 1785 Signed the parish accounts. 1785 Reimbursed for relieving the poor.

**SKINNER, Mary, widow**

1726 Henry Saxby of Salmons left her, his sister, £4

1740 Death

**SKINNER, Thomas**

1746 to 1752 He occupied Scale Fields and a field late part of Truggers, tenant of Douglas

**SKINNER, Thomas, wife Mary**

1770 Thomas Skinner, bachelor, married Mary King of Limpsfield. Witnesses: Thomas Bellchambers, John Beyles.

**SLADE, Stephen**

1780 Witnessed marriage between George Kidder and Elizabeth Cripps.

**SMALL, John, labourer, wife Catherine**

1724 Occupied Highfield House, tenant of Henry Streatfeild.

1747 For 30 years served Henry Streatfeild as a gardener. Henry left him an annuity of £8.

1749 Will of Mary Arnold witnessed by Catherine Small.

1756 Death

1771 Death of Mrs Small, widow



**SMEED, Nicholas, husbandman, wife Ann**

1758 Nicholas Smeed married Ann Cronk. Witness: Silvanus Smile

1758 Son William

1760 Daughter Ann

1763 Son George

1765 Daughter Mary who died the same year.

1766 Daughter Elizabeth

1766 Jane Mills of Cowden , spinster, left to Anne, wife of Nicholas Smeed of Chiddingstone, husbandman, £28. Will (Drb), proved 1785.

1769 Daughter Sarah

1772 Death of Jane Smeed, infant

1775 Son Sylvanus

**SMEED, ....., of East Hoathly**

1785 Relief £6-5s-5d. This is a large amount suggesting that he was living at East Hoathly but belonging to Chiddingstone. Payment in a lump sum rather than by weekly installments. Also £10-17s-1d. Overseers spent £1-14s-6d on a journey concerning Smeed's account.

**SMEED, William, tailor, barber**

1785 Several bills for shaving the inmates at the workhouse eg 1s 3d, 9d, 1s 8d, 2s 2d.

1785 Parish paid for a coffin for his child 2s 6d. Burial charges 3s 6d.

1785 For making three pairs of breeches 1s 6d. (continued)

**SMILE, Silvanus**

1758 Witnessed the marriage of Nicholas Smeed and Ann Cronk.

**SMITH, John, wife Joan**

1739 Death of wife Joan

1751 Death of John Smith

**SMITH, William, wife Mary**

1735 Daughter Mary

1737 Daughter Ann who possibly married Thomas Older in 1756. Witness: John Whitbread. In 1750 she made a sampler, aged 13, which was shown at an exhibition in 1928.

1741 Death of Elizabeth, daughter of William Smith

1743 Daughter Elizabeth who (spinster) married George Turner alias Cronk of Hever in 1771. Witness: Thomas Older

1768 (senior) Death

**SMITH, Mary, possibly daughter of Joseph Smith**

1757 She married Richard Shoebridge of Leigh. Witness : Henry Eagleton

**SMITH, Sarah**

1749 Her kinswoman Mary Arnold gave her half a house at Rendsley Hoath for life.

**SMITH, Joseph, of Chiddingstone, gardener, wife Ann**

1722 Married Ann Turner at Hever.

1724 Daughter Mary

1727 Daughter Ann who married Thomas Older.

1729 Daughter Elizabeth who married David Embury

1747 Richard Chapman left £20 each to Joseph's daughters Mary, Ann and Elizabeth Smith. He also left Sliders Bridge farm and Riddens to Joseph Smith and his wife Ann and afterwards to their daughters Mary, Ann and Elizabeth.

1749 Death. 1752 to 1761 Widow Smith owned Sliders Bridge and Riddens.

1761 Widow Smith conveyed Sliders Bridge farm and Riddens to Henry Streatfeild but she continued to live at Sliders Bridge for a while.

**SMITH, Elizabeth, daughter of Joseph Smith**

1753 Daughter Charity. In 1776 Charity (spinster) married Thomas Maynard. Witness: Nicholas Welfare.

1777 Son Joseph

1781 Son William

1782 William Smith for Saunders tenement and orchard near Sliders Bridge, (Streatfeild rent book).

1784 Ill with smallpox. Mr Brook provided necessaries 7s 9<sup>3</sup>/<sub>4</sub>d. Edward Leigh the same 7s 11d. Milk 8s 0<sup>1</sup>/<sub>2</sub>d.

1785 To Thomas Smith and his mother for nursing him £3-3s. Relief 2s 6d.. (continued)

**SMITH, Thomas, blacksmith, wife Mary**

1785 Thomas Smith, bachelor, married Mary King. Witnesses: John Aynscombe, Sarah King

1785 Possibly it was he and his mother who were paid £3-3s for nursing William Smith ill with smallpox.

1761 William Smith married Ann Kitchenham. Witness: William Pearless

1756 to 1759 Probable occupant of Piggotts farm, tenant of Atherfold or Blundell.

**SNASHALL, Richard**

1785 Richard Snashall of Chiddingstone married Susanna King at Hever. Witnesses: John King, Daniel Chapman

**SNELLING, Mr Edward, wife Mary**

1754 Death of son Stephen. (monument in churchyard)

1755 Son Enos

**SOANE, William, of Chiddingstone, wife Ann**

1740 Acknowledged by Tatsfield to Chiddingstone with daughter Sarah.

1742 Charged with being the father of a bastard male child born to Elizabeth Best of Penshurst.

**SPEARMAN, Body**

1780 to 1791 Occupied Dyehurst farm, tenant of Waldo

**SPENCE, Thomas, esq., wife Anne**

1731 Leased Kiln farm to John Hollamby of Chiddingstone yeoman, for 21 years.

1740 Deceased. His daughter Henrietta married Thomas Powys of Lilford, Northampton and the Kiln farm was part of the marriage settlement.

1751 Thomas Powys sold the Kiln farm to George Kebbel of Shoreham, Kent.

**STACE, William, wife Mary**

1740 William Stace married Mary Pope

**STACEY, William , wife Elizabeth**

1736 Daughter Elizabeth

1738 Daughter Susannah who married William Farmer of Sevenoaks in 1762.

Witnesses: William Stacey, Mary Rey.

1742 Son William. In 1762 he or his father witnessed the marriage of Susannah Stacey and William Farmer of Sevenoaks.

1745 Son Richard

1746 Occupied Willetts, tenant of Edward Everest who had leased the property to Henry Streatfeild.

1779 Occupied a messuage with 3 acres near Hillhoath, tenant of Henry Streatfeild.

1780 John Still witnessed marriage between Henry Eagleton and Mary Bennett.

1783 Served on Petty Jury (Quarter Sessions). Also 1785

**STILL, John, wife Hannah**

1771 John Still of Chiddingstone married Hannah Randal at Penshurst.

**STILL, Nicholas, of Chiddingstone, yeoman**

1777 Will (PCC). Annuity to his mother Sarah. To brother John all his messuages and lands, remainder to his sons William and Edward. Brothers Thomas and Simpson, sister Susan Still.

**STILL, Sarah**

1782 Base son John

**ST JOHN, Sarah, of Sevenoaks, widow**

1743 John Streatfeild had mortgaged Charcott farm to Sarah. After his death his widow Ruth was unable to pay the interest on the mortgage and so Sarah gained the farm. There was a law suit heard in 1744 resulting in a decree in 1746.

1745 John Streatfeild had mortgaged lands to her: Hammerhawe, Truggers, Children Land etc, Dung Croft, Three Crutch Fields. Now they are released to her.

1646 Sarah St John widow leased to Francis Morgan of Leigh the farm called Charcott in Leigh and Chiddingstone.

1747 Sarah leased to John Hollamby lands to the north of Coles farm together with Dung Croft and the Three Crutch Fields.

1755 Death. Will (PCC). She had paid off the mortgages on Coles including to Richard Brown of Bermondsey, fellmonger. Left her lands to her daughter Sarah.

**ST JOHN, Sarah, of Sevenoaks, spinster, daughter of Sarah above.**

1750 Thomas and Benjamin Hollamby als Nicholas and their mother Hannah sold to Sarah Coles farm.

1751 Sarah leased Coles to Benjamin Hollamby als Nicholas for 12 years.

1755 Sarah inherited from the mother the lands at Coles belonging to her mother. Also Charvcott farm in Leigh and Chiddingstone.

1756 Death. Will (PCC)

**ST JOHN, Rev Paulet of Wellingborough, , nephew of Sarah St John junior.**

1756 Sarah St john junior bequeathed Coles and Charcott farms to him.

1765 He sold Charcott farm in Leigh and Chiddingstone to Simon Medhurst of Leigh.

1766 He sold Coles to Ann Streatfeild

**STONE, David, wife Mary, travellers from Cookley Green, Oxfordshire**

1783 Daughter Sophia

**STREATFEILD, William, of Oxted, gent, wife Sarah**

1734 Death. He owned a messuage called Chandlers and 26 acres in Penshurst, also 4 acres in Penshurst and Chiddingstone called Bourn Brook Croft. He also owned Oakenden in Chiddingstone.

1742 He had been succeeded by his widow, now Sarah Sheppard of Oxted, who leased the above lands to Thomas Waterman of Penshurst, yeoman, for 21 years.

**STREATFEILD, William, of Rendsley Hoath, yeoman**

1713 to 1747 Inherited Skipreed and Brookers from Richard Streatfeild of Ford Place, Penshurst.

1732 John Ashdowne of Leigh left to his wife, remainder to William Streatfeild of Rendsley Heath his messuage called Charcott situated in Leigh and Chiddingstone.

1733 William Streatfeild sold Charcott farm to John Streatfeild.

1734 to 1746 He succeeded William Streatfeild above for Oakenden.

1737 Served on Grand Jury. 1743 of Stanford Borough, gent, served on Grand Jury (Quarter Sessions).

1740 Churchwarden

1746 Witnessed will of John Taylor, husbandman

1747 Death. He was succeeded at Skipreed, Oakenden and Brookers by his two daughters.

(a) Mary who married John Denman of Edenbridge, yeoman.

(b) Elizabeth who married John Piggott of Chiddingstone

**STREATFEILD, Richard, of Otford, yeoman, brother of William Streatfeild of Oxted above**

1717 to 1762 Owner of Slow Croft, Gratwick Field, Oakenden alias Frinden and Alkinden occupied by William Streatfeild (manor of Chiddingstone-Cobham)

1762 Death. Will (PCC) He left his lands called Oakenden to his nephew Robert Streatfeild of Shoreham, collar maker.

**STREATFEILD, Robert, of Shoreham, collar maker, nephew of Richard Streatfeild above**

1762 His uncle Richard Streatfeild of Otford, yeoman, left to him lands at Oakenden.

**STREATFEILD, Thomas, of Sevenoaks**

1726 Will (PCC). He left his lands to his infant grandson Thomas.

1726 to 1745 Widow Streatfeild owned Hilders in Chiddingstone and Hever.

**STREATFEILD, Thomas of Sevenoaks, grandson of Thomas Streatfeild above.**

1749 to 1804 Thomas Streatfeild owned Hilders, occupied by Cole.

**STREATFEILD, Robert, of Penshurst**

1735 Death. It says Richard but corrected to Robert.

**STREATFEILD, Thomas, of Speldhurst**

1739 Death

**STREATFEILD, John, of Charcott in Leigh, eldest son of Thomas Streatfeild of Penshurst, yeoman, wife Ruth**

1722 Succeeded his father Thomas as occupant of the Three Crutch Fields and Dung Croft, part of Coles, tenant of Hollamby.

1727 James Hollamby sold the Three Crutch Fields and Dung Croft to John Streatfeild.

1733 Mr William Streatfeild sold him Charcott farm in Leigh and Chiddingstone.

1736 Daughter Susanna

1740 Son John



1740 He owned Truggers, formerly belonging to Robert Streatfeild.

1740 John and Ruth Streatfeild sold the Three Crutch Fields and Dung Croft to Richard Brown of Bermondsey, fellmonger. Also Charcott farm. Probably a mortgage.

1744 Sarah St John prosecuted John Streatfeild (who was dead) and Richard Brown concerning the non-payment of the interest on the mortgage.

1743 Ruth Streatfeild widow released Charcott farm to Sarah St John of Sevenoaks, widow following the distraint on Ruth's goods for non-payment of rent for Charcott farm of which John Streatfeild had become a tenant of Sarah following failure in paying his mortgage interest. **The dates are a problem**

1745 John Streatfeild formerly of Vexor farm had mortgaged to Sarah St John and then released to her: Hammerhawe, Truggers, Children Land etc, Dung Croft and Three Crutch Fields.

**STREATFEILD, Henry, of High Street House, Chiddingstone, gent., wife Elizabeth.. (1679-1747)**

1710 to 1747 Owned Lockskinners and Tyehurst farms

1722 to 1742 He owned Somerden Green farm. In 1742 he leased it to Mary Streatfeild, widow. And in 1744 to Sidney Streatfeild

1737 He bought Rock House from Thomas Weller and renamed it the Catle Inn. (Deed).

1738 He bought Butt House with the forge from William Cronk.

1839 He bought Chiddingstone-Cobham manor house and Hilly Field from Ann Laggatt widow.

1744 Death of his daughter Elizabeth

1746 He bought Willetts from Edward Everest for £113-3s.

1747 Death. Will (PCC). To son Henry much property in Chiddingstone.

**STREATFEILD, Thomas, of Chiddingstone, gent, brother of Henry Streatfeild (above) (1683-1752)**

1710 to 1752 Owned Red House land.

1752 Death. Will (PCC). To nephew Richard £6000. To Thomas Streatfeild son of cousin Robert Streatfeild of Hever Castle deceased £100. To my housekeeper Ann Abrahams £10. To servant William Winter £50

**STREATFEILD, Henry, esq., son of Henry Streatfeild, above, wife Ann née Sidney (1706-1762)**

1747 On the death of his father he inherited the bulk of his property. Lockskinners, Tyehurst..

1753 Death of son Henry who had been born in 1753 at St Ann's, Westminster.

1758 Witnessed will of Elizabeth Blundell, his housekeeper of many years.

1759 He bought Hoath Farm (Truggers) from John Woodgate alias Longley.

1779 Ann Streatfeild released to him Burghurst Court and a messuage called Hunts and lands.

1760 He had acquired Millbrook alias Somerden farm from Barnard Hyde. In 1762 he leased the farm to John Woodhams .

1760 or thereabouts. Barnard Hyde sold Bore Place to Henry Streatfeild.

1761 Widow Smith sold Sliders Bridge farm to Henry Streatfeild.

1762 Death intestate. He was succeeded by his sons Henry and Richard Thomas Streatfeild, infants, and his widow Anne.

1766 Ann Streatfeild, widow, bought Coles from Rev Paulet St John of Wellingborough.

1771 Admon of the goods of his father granted to Ann as Henry junior was deceased.

1774 Ann Streatfeild widow wrote a will but she did not die until about 1812.

1779 Ann Streatfeild released to her son Henry properties bought by her from Mary Streatfeild of Uckhurst, widow. They included the manor house called Burghurst Court and a messuage called Hunts with lands.

1783 Thomas and John Driver sold Skinners to Henry Streatfeild,.

1790 Ann Streatfeild transferred Coles and other lands to her son Henry.

**STREATFEILD, Richard Beard, gent, of Copwood, Uckfield, son of Henry Streatfeild, above, wife Mary (1709-1770)**

1741 Death of his daughter Mary

1742 Death of his daughter Elizabeth

1746 His brother Sidney Streatfeild left him Hunts and Burghurst farm.

1747 Served on the Grand Jury (Quarter Sessions).

1749 Summoned to serve on the Grand Jury but not to be found. (Quarter Sessions)

1752 He inherited £6000 from his uncle Thomas. A ring to his wife's father Mr Eagles.

1754 (of Chiddingstone, gent) Constable for the lower half hundred of Somerden.

1770 Death, He left everything to his wife Mary. Mary sold the manor house called Burghurst Court and a messuage called Hunts with lands to Ann Streatfeild, widow.

**STREATFEILD, Mr Sidney, son of Henry Streatfeild, wife Elizabeth (1713-1745)**

1731 to 1746 Owned Hunts and Burghurst farm.

1738 He owned land north and east of Lew Cross.

1743 He and William Martin assessed the damage done at Somerden Green farm by widow Streatfeild. 1744 The farm was leased to him.

1745 Death. Will (PCC). To his brother Henry 100 guineas. To his father's housekeeper Elizabeth Blundell £50. To his wife Elizabeth a ring. To Robert Palmer blacksmith a bookcase. To friend John Upton £50 and musical books and instruments, tools and a gun. To Mrs Abrahams a ring. To Sarah Monk a ring. His farms Bergherst and Chandlers to his brother Richard Beard Streatfeild. Witnesses: C Lake, William Blundell, Francis Austen..

**STREATFEILD, Henry, son of Henry Streatfeild above, wife Elizabeth Catherine, Charlotte (1757-1829)**

1762 On the death of his father intestate he and his brother Richard Thomas Streatfeild inherited the Streatfeild estate.

1779 For the barring of all estates tail and for vesting the same in Henry Streatfeild for 10s Henry Streatfeild sells to Thomas Goostrey of St James Westminster gent all that the manor of Chiddingstone-Cobham and the capital messuage known as High Street House together with the rest of his estate in order that a good and effectual common recovery may be executed against the saif Thomas Goostrey.

1780 Witnessed marriage between George Kidder and Elizabeth Cripps.

1782 Richard Thomas Streatfeild released to his brother Henry possession of Millbrook alias Somerden manor and farm.

1784 Son Henry, born in the close of Winchester and baptised there April 21<sup>st</sup> 1784

1783 Daughter Elizabeth Harriet, born in Winchester 1783.

**STREATFEILD, Richard Thomas, of Uckfield, wife Jane, Anne (1759 – 1813)**

1762 On the death of his father intestate he and his brother Henry inherited the Streatfeild estate.

1782 He released to Henry the manor and farm of Millbrook alias Somerden and Bore Place.

**STREATFEILD, Robert of Hever, gent, wife Barbara**

1728 to 1741 He occupied Hever Castle farm in Hever and Chiddingstone, tenant of Humphreys.

1709 to 1741 He owned Lower Gravel Pit farm. 1722 to 1741 He also occupied Upper Gravel Pit farm , tenant of Hoskins.

1737 Robert Streatfeild occupied Dyehurst farm, tenant of Humphreys.

1741 Death Will (PCC). Sons William, Robert, Thomas. Brother-in-law Robert Streatfeild of Burwash. He left the bulk of his estate to his son William.

1743 Robert Streatfeild of Hever has died. By will he devised Lower Gavel Pit farm to his son William Streatfeild. (manor of Sundridge Weald)

1752 Thomas Streatfeild bequeathed rings to widow Barbara and to Elizabeth Streatfeild her sister and to Robert Streatfeild her brother.

1761 On the death of his son William his widow Barbara assumed the ownership of his properties as his grandson William was an infant.

1771 Death of Barbara, widow from Croydon.

**STREATFEILD, Mr William of Hever Castle, gent, son of Robert Streatfeild of Hever. Wife Sarah.**

1741 His father? left him the bulk of his estate including Lower Gravel Pit farm. He also occupied Upper Gravel Pit farm. Tenant of Hoskins.

1740 to 1752 Occupied Hever Castle farm in Hever and Chiddingstone, tenant of Humphreys , later Waldo.

1745 to 1759 Occupied Hever Lodge, tenant of heirs of Humphreys, later Waldo.

1746 Married Mrs Sarah Thorpe, by licence, at Penshurst.

1748 Death of son Robert

1751 Death of son William

1756 Son William

1756 to 1759 Occupied Red House land, tenant of Henry Streatfeild.

1761 Death , leaving a son William, aged 5.

1770 William Streatfeild is dead, leaving one son William, an infant. Barbara Streatfeild of Croydon, widow of Robert Streatfeild, father of William, is now seized for life by virtue of her marriage settlement. (manor of Sundridge Weald).

**STREATFEILD, William, son of William Streatfeild above**

1756 Born, the son of William Streatfeild of Hever Castle. On his father's death in 1761 he inherited Lower Gravel Pit farm but as he was an infant his grandmother Barbara took possession until her death in 1771. She was followed by William's mother Sarah and in 1780 Mr Charles Wakefield, the second husband of William Streatfeild senior was in possession. He again took possession after the death of William in 1798.

**STREATFEILD, Mrs Elizabeth, of Cowden**

1777 Death

**STREATFEILD, Robert, husbandman, wife Susanna**

1741 He and his wife were removed from Chiddingstone to East Grinstead. (Sussex Family Historian Vol 3 No 4)

1741 Acknowledged by Chiddingstone to East Grinstead.

1744 Son John

**STREATFEILD, Sarah**

1753 Death

**STREATFEILD, Thomas, of Brenchley, wife Elizabeth**

1760 Thomas Streatfeild of Brenchley married Elizabeth King. Witness: John Streatfeild

1761 (of Chiddingstone) Burial of wife Elizabeth in Penshurst.

**STREATFEILD, John**

1760 Witnessed marriage of Thomas Streatfeild of Brenchley and Elizabeth King

**STREATFEILD, William of Somerden Green , gent, wife Mary**

1716 to 1742 He leased Somerden Green farm from Henry Streatfeild. He owned a messuage and three rods of meadow in Millbrook mead which he devised by will to his widow Mary (manor of Sundridge Weald).

1742 Death. Henry Streatfeild leased Somerden Green farm to his widow Mary.

1743 Damage done (mostly trees) at Somerden farm by widow Streatfeild viewed by Sidney Streatfeild and William Martin. Widow Streatfeild promised to pay 5 guineas for the damage done.

1747 His daughter Ann married Thomas Dobbs at the Fleet.

1764 Death of Mary. She was succeeded in a messuage and 3 rods of meadow in Millbrook Mead by her daughters Anne Dobbs and Thomas Hollamby.

**STREATFEILD, John, of Penshurst, gent , wife Sarah**

1765 to 1777 Occupied Tophill farm, tenant of Woodgate.

1770 He had acquired Chafford Bridge Mead from Faulkner.

1773 to 1779 He possessed Little Pilbeams farm, formerly belonging to Thomas Butcher.

1779 Death. Will (PCC) He left to Sarah lands in Penshurst and also a farm called Little Pilbeams in Chiddingstone, 20 acres, together with a meadow of 3 acres called Little Stonebridge Mead during the minority of his sons John and Henry.

1780 to 1791 Mrs Streatfeild occupied Tophill farm, tenant of Woodgate and owned Little Pilbeams farm.

1790 Rev Francis Woodgate left to his son amongst other properties Tophill farm, occupied by the widow of John Streatfeild, gent.

1768 (of Walters Green). Daughter Elizabeth, baptised in Penshurst

**STREATFEILD, Robert, esq., of Warsworth, Surrey.**

**STREATFEILD, Robert, of Cowden or Delaware , gent**

1737 Robert Streatfeild of Cowden who held Chiddingstone Mill farm has alienated it to his son Robert Streatfeild of Delaware or Burwash. (manor of Sundridge Weald)

1744 Death

**STREATFEILD, Robert, gent, of Delaware or Burwash (1696-1782) , wife Mary**

1737 His father alienated to him Chiddingstone Mill farm which he kept until his death in 1782.

1741 Brother-in-law of Robert Streatfeild of Hever who made him overseer of his will

175 2 Thomas Streatfeild bequeathed to him a ring and to his sisters Barbara and Elizabeth

1782 Death. Will (PCC) Messuages in Chiddingstone occupied by Richard Keeyes bequeathed to great-nephew William Streatfield.

1761 Witnessed will of John Taylor

1761 Witnessed will of Ann Abraham.

1762 Witnessed marriage of Samuel Bevan and Philly Keayes.

**SUTTON, J**

1753 Witnessed will of John King

**SUTTON, Richard**

1784 Witnessed marriage between William Humphrey of Edenbridge and Mary Eve.

**SWAYNE, Rose, sister of John Woodgate, Ann Woodgate and Alice Children**

1730 Will (PS) . To her daughter Mary her messuage and land situated at Chiddingstone. In default to her brothers Thomas and Francis Green and her sister Anne, married to Samuel Stileman of Otford, yeoman.

**SWAYSLAND, Anne, daughter of Jane Swaysland, above.**

1730 Inherited Little Seedcombes from her mother which she held to at least 1743.

**SWETMAN, John, of Chiddingstone, wife Elizabeth**

C1755 Married Elizabeth Pope at Hever
