Rabbit, John (1785 of Burwash, Sussex, England) and Sarah Foster (b. about 1785 in Kent, England) m. 14 Oct 1806 Tonbridge, Kent, England (Pallot's m. index). Possible d. info: John, Mar 1865 in Tonbridge, Eng. and Sarah, 5 Mar 1851 in Hadlow, Kent, Eng. Their posterity:

Mary Rabbit (1807 of Hadlow) and John Pucknell (1807 of Tunbridge), m. 17 Oct 1830 Leigh, Kent, Eng.

John's parents were James Pucknell (1783 of Tonbridge) and Susannah Betts (1781 of Leigh, Kent). Mary's death was registered between Apr-Jun 1871 at Tonbridge, Kent.

Sarah Pucknell (Jan 1831 of Tunbridge, Kent, christening 9 Jan 1831—d. Dec 1905 at Tunbridge) m. William Homewood (1829 of East Peckham, Kent) during the 3rd quarter of 1850 at Tonbridge, Kent. William's parents were Obed/Obadiah Homewood (1805 of Rotherfield—pos d. Jan 1885 at Battle, Sussex) and Keziah Field (1805 of --pos. d. Jan 1867 at Tonbridge) see chr. record **Note: Sarah Pucknell (1831) is not on the 1871 census. However, William is not listed as a widower. See if she appears in later censuses.** Obed and Keziah were married 7 Jan 1827 at Hadlow, Kent.

Sarah Homewood (1851 of Tonbridge) appears as a 2 month old in 1851 but doesn't appear on 1861 census. Death record shows she died between Jan-Mar 1852 at Tunbridge, Kent.

John Homewood (1854 of Tonbridge—d. 1895 at Dartford) m. Emily Harriett Ashenden (Feb 1856 of Southfleet, Kent—pos d. Jul 1904 at Dartford) in 17 Oct 1881 at Stone, Kent. Emily's parents were William Ashenden (1825 of Meopham) and Charlotte Ovenden (1833 of Wrotham). Emily was a widow by the 1901 Census. **Information on William Ashenden's uncertain birth year can be found in the Appendix. Charlotte's sibs are listed there as well.**

Emily Jane Homewood (May 1885 of Stone, Dartford, Kent—d. 1977 Dartford)

Arthur George Homewood (Feb 1889 of Swanscombe, Dartford, Kent) m.

Blanche Agnes Shuter (17 Mar 1890 of Dartford, Kent—d. 28 Apr 1979 at Dartford), Mar 1912 at Dartford, Kent. Blanche's parents were Samuel Henry Edward Shuter (1847 of Farningham) and Mary Barber (1845 of Eynsford, Kent).

Arthur Leonard George Homewood (2 Apr 1913 Dartford--d. 22 Jan 1977 at Dartford) married Daisy Mole (12 May 1918—d. 16 Dec 1980 at Dartford) during the 1st Quarter of 1939 at Dartford, Kent. Burial or cremation for Arthur: 31 Jan 1977 at Gravesend, and for Daisy: 29 Dec 1980 at Gravesend, London

Stanley Edward George Homewood (29 Mar 1917 of Dartford--d. 29 Jan 1994). Death registered Feb 1994 at Gravesend, Kent. Married **Marjorie G. Perkins** (13 July 1916—d. Jun 1992 at Gravesend) in the 3rd Q of 1938 at Dartford. Marjorie's mother's name was Dolton.

Joyce Mary Homewood (30 June 1920 of Dartford—d. 26 Dec 1986 at Dartford). Married **Charles Kent** (1920-1970) 19 Jan 1942

Ivy Emily Rose Homewood (8 Aug 1923 of Dartford—d. 29 Jan 1994 at Dartford) m. **Frank W. G. Trueman** during the 2nd Q of 1943 at Dartford, Kent.

Harold Raymond Homewood (7 Aug 1928 of Dartford-- d. Nov 1980 Gravesend, Kent). Pos m. **Jean Gudgeon** 1953 at Dartford

Percy Ernest Homewood (1890-1890 at Dartford, Kent)

Frederick Homewood (1856 of Hadlow), m. Emma Goodban (or Goodband) (1856 of Stone, Kent—d. 25 Nov 1881 at Dartford, age 25) on 16 Jan 1876 at Stone-near-Dartford, Kent. Her parents were William Goodban (1826 of Sandwich, Kent) and Ann Stoneham (1828 of Stone, Kent) who were married 19 Jun 1847 at Northfleet, Kent. Emma's siblings: Eliza Ann (1849), William 1850, Frederick 1852, Henry John (1859- his wife & and children's ord. are avail), Sarah (1861), Mary (1866), and Ellen (1869). Ann Stoneham's parents were Richard Stoneham (1803 of Swanscombe, Kent) and Sarah Simmonds reserved by Lindsey(1804 of Stone, Kent). Ann's siblings: Henry (1826), Susan (1831), Richard (1834), and Frederick 1838).

Emma died at age 25 in Nov 1881 in Dartford, Kent, England. Frederick then married Sarah Dance (1864 of Dartford) on 24 Aug 1884 at Dartford (m. doc says Bexleyheath parish, Kent). Sarah Dance's parents were: James Dance (1836 of Hurst, Berkshire) and Elizabeth (1840 of Farningham, Kent). Frederick and Sarah had the following two children: Frederick James Homewood (1890 of Dartford, Kent--died as a 5 year old). His death was registered between Apr and June of 1895 in Dartford, Kent. The 1911 Census confirms that Frederick (1856) and Sarah had 2 live births and that one had died by 1911 (Frederick James Homewood).

Eliza Florence Homewood (1892 of Dartford, Kent—d. Jan 1926 at Dartford) m. Robert William Philpott (1889 of Dover, Kent) in Apr-Jun 1912 at Dartford, Kent. His parents: John Monckton Philpott (1864 of Dover) and Adelaide Cord (1866 of Dover) who were married Oct 1885 at Dover, Kent. Robert's siblings: Alfred William Philpott (1888 of Dover) see Appendix for his wife and children, Adelaide Elizabeth Philpott (1891 of Dover, Kent), John Philpott (1893 of Charlton near Dover, Kent), Lydia Elizabeth Philpott (1895 of Dover, Kent), and Rose Philpott SS (1903 of Dover, Kent).

Note: James Dance (1830 of Berkshire **info doesn't agree with prev. paragraph**) living with Frederick Homewood and Sarah Dance in 1911 as a boarder, age 81.

Thomas Homewood steam crane driver in 1901 Census and coal porter in 1911(1858 of Hadlow—Tunbridge Wells—d. Aug 1924 at Erith, Kent) m. Elizabeth Bendall (16 Aug 1856 of Mitcham, Surrey—d. Dec 1945 at Erith, Kent) in 1876. Elizabeth's parents are in FS as William Bendall (1829 of Ludgershall, Wiltshire) and Eliza Laws, (1838 of Westminster, Middlesex), m. 30 Apr 1854 at Croyden, Surrey.

The 1911 Census says that Elizabeth had 12 live births and that by 1911 two had passed away. William's father was Charles Bendall, a cordwainer, a maker of new shoes—from m. document. Eliza's father was John Laws, a gardener.

William Thomas Homewood crane driver in 1929 (Feb 1878 Dartford), m. Emily Alice Holloway (1880 of Erith, Kent) 27 Dec 1902 in Woolwich, Kent. Emily's parents: Robert Holloway, mariner (1838 of Poole, Dorsetshire, Eng.) and Selina Holloway (1838 of Parkstone, Poole, Dorsetshire) see Appendix for Emily's siblings

Ethel Selina Homewood (21 Feb 1904 of Erith, Kent—d. 27 May 1977 at Exeter, Devon) m. Frederick William Webber a house furnisher in 1929 at Erith, Kent (1 Aug 1902 of Exeter, Devon, Eng.—d. 4Q 1976 at Exeter, Devon) 27 Jul 1929 at Dartford, Kent. Frederick's father was Samuel Webber, a house furnisher.

Leslie William Robert Homewood a plumber (13 Nov 1905 of Erith, Kent) m. Alice Sheard (9 Dec 1906 of Ravensthorpe, Yorkshire) 21 Dec 1926 at Ravensthorpe, Dewsbury, Yorkshire, Eng. Her father, acc. to Non-Conformist m. records was James Sheard (1867 of Ravensthorpe, Yorkshire) a Stationary Shop Manager. 1911 Census shows mother as Sarah (1868 of Heckmondwike, Yorkshire)

Elizabeth Alice Homewood (24 Sep 1879 of Dartford—d. 1947 at Orpington, Kent), m. Alfred Edward Wilson, a house painter, (11 Oct 1876 of Lambeth, Surrey, London—d. 11 Dec 1945 at Farnborough, Kent) in 1899 at Bromley, Kent. Alfred's parents: Thomas Wilson, carman in 1881 at Southwark (1835 of Canterbury, Kent) and Caroline Baldwin (1850 of Gravesend, Kent).

Alfred Edward Wilson foreman builder in 1939 (1901 of Belvedere, Kent/1901 Census says 1900 of Dartford) 1901 Census says he was 10 mos. old which would establish his birth back in 1900. He married Elizabeth Roberts (8 Mar 1897 of) 4th Q 1923 in Bromley. Alfred enlisted when he was 15 and was later discharged due to misstating his age. Ancestry suggests they had 3 children:

George's parents: George Sivyer (3 Jan 1879 of Biddenden, Kent—d. Oct 1958 at Ashford, Kent) and Lillian May Noakes (23 Oct 1882 of Frittenden, Kent—d. Jul 1956 at Ashford, Kent). George's sister: Alice Lillian May Sivyer (1910 of Boughton Malherbe Parish, Hollingbourne, Kent)

Charles Frederick Wilson (6 Apr 1907 of Bexleyheath, Kent—d. 1947) m. Florence May Cullingham (1909 of Sidcup, Kent—d. 17 Mar 1997 at Poole, Dorset) 1929 at Bromley. Two individuals named Charles Frederick Wilson--both born in Apr 1907--have caused considerable confusion. The son of Alfred Edward Wilson and Elizabeth Alice Homewood, born 6 Apr 1907(1939 Register), married Florence May Cullingham. He died 19 Jun 1947 at St. Paul's Cray, Kent, England. The only d. doc I can find says registered 1948.

Walter W. Wilson (1915-1962) He is mentioned in the discharge papers of his brother, Alfred Edward Wilson—b.1900.

Lilian Wilson ()

Sarah Homewood (Aug 1881 of Dartford), m. Charles John Stuart (1879 of Deptford, Surrey) on 25 Dec 1902 at Dartford (Erith Parish). Charles' parents: Charles Henry Stuart (1855 of St. Georges) and Ann Mary pos Warren (1850 of Shadwell). Sarah died Jun 1957 at Dartford, Kent at age 69. **Pos. d. date for Charles: 21 Jul 1912 at Rainham, Essex.** Charles John Stuart's sibs: James Henry Stuart (1880), Edward Joseph Stuart(1883) and a 4th child as indicated by 1911 Census. Additional info listed on his siblings at the end of this document.

Charles Henry Thomas Stuart acetylene-electric welder in 1939 at Erith (29 Oct 1903 of Erith, Kent) m. Grace Dorothy Southgate (1 Jan 1901 of Woolwich, London) 2 Aug 1930 at Erith, Kent. Her father, mentioned on m. doc: Henry James Southgate (2 Jan 1873 of Rowhedge, Essex) was an engineer's stock keeper. Grace's mother: Emily Archer Spiers (1865 of Weybridge, Surrey). Charles was christened 20 Nov 1903 at Erith, Kent.

Elsi Stuart (3 Jul 1905 of Erith, Kent) m. Alfred Owen Wright an engineer in 1927 at Erith (1900 of England—d. 17 Nov 1943 Bexley Cemetery Register) 1 Aug 1927 at Erith, Kent. Alfred was the son of Alfred Owen Wright, (21 July 1876 of Bermondsey, London) and Frances Jones (1878 of Deptford, London). Alfred 1900's siblings: William Alexander 1902, Charlotte Frances 1904, John Victor 1906, and Kathleen Eliza 1911. All children were b. in Erith, Kent. Ancestry suggests 3 additional children: Violet May 1912, Sidney 1914, and Marie 1914.

Henry James Stuart electric welder in 1939 at Erith (30 Jan 1909 of Erith, Kent) m. Edith May Taylor (5 June 1911 of Kent--d. Feb 1984 at Bexley) July 1932 at Dartford, Kent.

Joan M. Stuart (15 May 1934)

[Thomas Homewood 1879 Dartford] **Not sure if he belongs here. Perhaps he is one of their 2 children that passed away by 1911.**

Ada Annie Homewood (Oct-Dec 1883 of Dartford) LJB5-RTP 16 yrs old in 1901 and 26 years old in 1911. Pos bapt 24 Feb 1886 at Greenhithe

Mary Homewood (christened 24 Feb 1886 at Kent, Eng.) pos. d. 1887

Bentley H. Homewood (1888 of Kent, England) see 1891 Census

Bertha H. Homewood (26 Apr 1888 of Greenhithe--regis district: Dartford) Her birth date is found in the 1939 Register where she is found as a single woman with her widowed mother, Elizabeth Homewood (16 Aug 1856)

Emily E. Homewood (1890/1891? of Dartford)

Harry Homewood (1893 of Erith, Kent) 1911 Census says "Hinrey") Pos sp: Annie Maria Amelia Clark, m.4 Sep 1915 at Northumberland, Heath, Kent

Jessie Winifred Homewood (1895 of Erith, Kent), pos sp: Ernest Albert Jennings (1892 of Erith) in 1919 at Dartford, m. 9 Jun 1919. Ernest's father was Charles Jennings, a wheelwright.

Florence Mable Homewood a shop assistant in 1924 at Erith (2 Nov 1898 of Erith, Kent) **Need birth regis.** Spouse: William Ernest Lawrance, a fish monger in 1924 at Erith and an explosives worker in 1939 (6 Oct 1901 of Belvedere, Kent--d. 1 Mar 1976 at Dartford) m. 21 Apr 1924 at Erith, Kent. She signs her m. doc. as Florence Mable Homewood. His father's name (on m. doc) was Thomas George Lawrance, a machinist (2 Apr 1872 of Belvedere, Kent—d. Aug 1952 at Dartford). His mother was Frances (Fanny-1911 Census) Hudson (1876 of Erith—d. Oct 1927 at Dartford). William had 6 siblings—see appendix.

Ethel May Homewood (1899 of Erith, Kent)

John Pucknell a brewer (1832 Tunbridge, Kent) and Emily Mitchell (ch. 2 Oct 1833 of Tonbridge **FS says 1834—TheWeald agrees**), m. Oct-Dec 1857 Tonbridge, Kent, Eng.

According to her christening record, Emily's parents were James Mitchell (1807 of Tonbridge) and Eliza Jennings (1806 of Tonbridge).

Harriet Pucknell (5 Mar 1860 of Tonbridge, Kent), m. Albert George Uden (1864 of Dover, Kent--14 Dec 1920) on 28 Jan 1885 at Newington, Surrey. Albert and his father, Thomas Uden (1833 of Lyminge, Kent), were house painters although at 16 he was a baker (1881 census). Albert's mother was Sarah Norris (1830 of Dover, Kent). His parents were married Apr-Jun 1854 in Dover, Kent. Pos d. for Albert: 1902 at Dover, Kent.

Edith Harriett Uden (1886 or 7 South Norwood, Surrey --acc. to 1911 Census) Norwood is a sub metropolitan tract in Lambeth and Croyden parishes. Married Henry William Cadman (1887 of Hougham, Kent) Apr-Jun 1914 at Dover, Kent, whose parents were William Albert Cadman (1857 of Ramsgate, Kent) and Jane Jones (1861 of Blean, Kent) m. 10 Oct 1836. Henry's siblings: Florrie F. Cadman (1885 of Kent), Hilda M. Cadman (1889 of Kent), and Edith S. Cadman (1891 of Kent)

Ronald William Cadman (1915 of Dover, Kent)

Emily Clara Uden (9 Sep 1888 of Peckham, London). Peckham is a district in SE London. Married William G. Bowles a drapery salesman in 1939 (10 Mar 1886 of Chatham, Kent) during the 3rd qtr of 1915 at Romsey, Hampshire, Eng.

Harold T. Bowles (6 Sep 1916)

Barbara M. Bowles (16 Oct 1920)

Frederick Albert Uden a baker's "roundsman" (1890 of Dartford, Kent—chr. 14 Dec 1895 at Buckland, Kent) m. Dorothy "Dollie" Barbara M. D. Setterfield (4 Aug 1890 of Whitstable, Kent) 1st qtr of 1915 at Dover, Kent. Her parents were Henry James Setterfield, a mariner, (1846 of Ramsgate, Kent) and Mary Ann Roberts (1856 of St. Albans, Hertfordshire, Eng.) m. 28 Dec 1873 at Ramsgate, Kent. Henry James Setterfield's father was Thomas Setterfield, a laborer. Mary Ann Robert's father was Mark Roberts (found on m. record).

Barbara M. Uden 5 Feb 1923

Mary Eliza Uden, called "May" (July 1892 of Dover, Kent) m. Edward Arthur Evans (Jan 1889 of Marylebone, Middlesex, London, Eng.) 22 Nov 1916 at Dover, Kent. Sergeant Edward Arthur Evans of the 6th Battalion Royal Fusiliers died on 29 Apr 1917 in France during WW1 while Mary was expecting their first child. Edward's parents were Alfred Frank Evans (1857 of Marylebone—d. Oct 1923 at Westham, Essex), a postal worker, the son of Arthur Linden(or Linder) Evans a post office official and Annie Elizabeth Lucas (1855 of Marylebone) dau of George Lucas. Edward's sibs: Alfred Linden Evans, 1885 of Marylebone; Annie Elizabeth Evans (1887 of Marylebone); Alice Evans (abt 1890 of Bedminster, Somerset); Reginald Evans (abt 1891 of Bedminster); May Louise Evans (abt 1893 of Bedminster, Somerset); Beatrice Evans (abt 1895 of Manor Park, Essex).

Josephine Elsie Elizabeth Evans b. 25 Oct 1917 in Dover, Kent

Notes: After the death of Edward Arthur Evans on 29 Apr 1917, Mary Eliza Uden Evans married Carlton Samuel Taylor, who was a boot maker's apprentice at age 16 (1895-1952) on 31 July 1920 at St. Giles, Camberwell, Eng. She died in Dec 1924 at Camberwell, London, Eng. Josephine was about 7.

The 1911 Census says that Harriet Pucknell had 9 live births with 7 being alive in 1911. Walter Norris Uden accounts for one of the children who had died by 1911.

Walter Norris Uden (17 Feb 1895 of Dover—d. 1896 at Dover, Kent). He was baptized 14 Dec 1895 at Buckland, Kent.

Henry Joseph Uden, a postman, a house decorator in 1939 (14 Mar 1897 of Dover, Kent) m. Annie Elizabeth Blades (30 Nov 1896 or 1899 **CAUTION—THERE ARE SEVERAL BY THE SAME NAME** Annie Elizabeth Blades) 7 Oct 1920 in Mitcham Parish. On the m. doc, he is listed as Joseph H. Uden. Annie's father was William Blades, a "sweep" listed as deceased at the time of his daughter's marriage.

Elizabeth Annie Uden (1901 Census) or Annie Elizabeth Uden 1911 Census (29 Aug 1899 of Dover, Kent). The family members present in each census assure that it is the same individual. She is referred to as Annie in her father's obituary and in a wedding article where she was a bridesmaid for her sister Mary Eliza Uden.

Elsie Florence Uden (10 Feb 1905 of Dover, Kent) m. William J. King () in the 3rd quarter of 1955 at Dover, Kent. The name "King" is written in the 1939 Register.

Mary Pucknell (22 Mar 1862 of Dover, Kent)

Emily Pucknell (1865 of Dover, Kent)

Albert Pucknell (5 Jul 1867 of Hadlow, Kent—d. 20 Feb 1942 at Newport, Monmouthshire, Wales) was a soldier when he m. Clara Hopkins (1864 of **Upton, Leicestershire?**, Eng.) on 2 Feb 1891 at St. Peter, Vauxhall, Lambeth, London. Albert and Clara had the four children listed below. Clara's father was Walter Hopkins acc. to m. document. However, Ancestry suggests that his name might have been William. Clara died on 9 Nov 1899 according to Albert's military record. **Where? Their youngest son was born 10 Apr 1899 in Alexandria, Egypt.**

Sergeant Albert Pucknell (34 yr old widower) then married Sarah Elizabeth White (27 Jul 1859 of Ship Pean, Somerset), on 27 May 1901 at Bristol, Gloucestershire. According to the 1911 Census, Sarah bore no children. Parish marriage records show Sarah as 41 in 1901. Sarah's father was Joseph White, a laborer. **Sarah's mother?** Her exact b. date came from 1939 Register—she was 80!

Arthur Walter Cave Pucknell (16 Feb 1892 of Dover, Kent-- d. 21 June 1958 at Monmouthshire, Wales) m. Lily Sophia Davies (13 Nov 1887 of Blaina, Monmouthshire, Wales—d. 3 July 1963 at Newport, Monmouthshire, Wales) (See British Army Pension Records) Apr 1919 at Newport, Monmouthshire, Wales. Her parents were George Davies (1860 of Llanrhidian, Wales) and Eliza _____ (1863 of Port Eynon, Wales). Her siblings were Edith Mary (1887), Richard H. (1889), Walter S. (1891), George (1895), Olive (1896), Bessie (1899), Gladys (1900), and William (1910). All of her siblings were born in Newport.

Sidney Pucknell (25 Feb 1894 Dover, Kent), d. 13 Oct 1917, Flanders, Artillery Wood Cemetery, 11.A.19 Killed in action in WW1.

Albert Mitchell Pucknell a gunner RFA (11 Feb 1897 of Alexandria, Egypt (Ash Shatibi, Al Iskandariyah, Egypt), d. Sep 1965 Cardiff, Glamorganshire, Wales) m. Ivy May Ham (14 Dec 1895) 30 Sep 1918 at Roath Parish, Cardiff County, Glamorganshire, Wales. Ivy's parents: Thomas James Ham, crane driver, and possible mother (signature as witness of dau's marriage) Rosie Evelyn Ham

Percival S. Pucknell (14 June 1921)

Albert Victor Pucknell (18 Dec 1922 of Cardiff, Glamorgan, Wales—d. 27 Jan 1975 at Cardiff, Glamorgan, Wales) m. **Gwyneth Mary Wells** (1925-1997)

Philip Victor Pucknell (10 April 1899 of Alexandria, Egypt-- d. 23 Sep 1960 in Cardiff, Glamorganshire, Wales) m. Doreen Harriett Lina Bailey (28 Mar 1900 of Newcastle, Staffordshire, Eng.--d. 1974 at Cardiff) 1924 at Cardiff, Glamorganshire, Wales. Doreen's parents: Bertram Manton Bailey (1872 of Worcester, Worcestershire—d. 30 Apr 1955 at Cardiff) and Dora Ethel Blyth (2 Oct 1873 of Barton, Lincolnshire, Eng.—d. 11 Dec 1944 at Cardiff)

Sidney Kenneth Pucknell (25 Jul 1929 of Cardiff, Glamorganshire, Wales-2004 at Cardiff)

Pamela E. Pucknell (10 July 1935)

Walter Henry Pucknell a butcher in 1911 at Ontario (Aug 1871 Tudley, Parish of Capel), see 1881 Census for birth place. His enlistment papers show Dover as birth place and 20 Aug 1871 as birth date. He married Florence Marion Turgis, (Dec 1871 of St. Helier, Jersey Channel Islands—chr. as Florence MaryAnn Turgis 14 Jan 1872 at Jersey, Channel Islands) on 30 Dec 1895. At 31 he went to Canada and served in the Canadian military. According to the 1881 Census, her parents were William Junr Turgis or William Turgis, Jr. (1846 of Channel Islands) and Mary Ann (Marianne) Foard (1843 of St. Peter Port, Guernsey, Channel Islands) who were m. 20 Aug 1871 at St. Saviour, Jersey, Channel Islands. See Appendix

Eliza Mitchell Pucknell (1873 of Dover, Kent—d. 20 Oct 1933 at Deal/Eastry, Kent) m. Harry Baker (24 Aug 1875 of Dover—d. 29 Sep 1921 at Deal, Kent) 23 Feb 1897 at Dover, Kent, Eng. Harry's parents were George Baker, a cordwainer (maker of new leather shoes) in 1863 and later a police constable, (1827 of Glastonbury, Somersetshire) and Louisa Greenwood Reed (1834 of Dover, Kent). Alternate spellings of Louisa's middle name include Greensward, Greenland, Greenwood, Green-sword, and Greenwood. Harry was a railway engine firelighter **When? Additional information about Harry's siblings can be found in the Appendix.**

Louisa Emily Baker (1898 of Dover, Kent—d. 30 Oct 1959 at Deal, Kent) m. Arthur Henry Ponting (1898 of Bristol, Gloucestershire, Eng.) 12 Dec 1921 at Eastry, Kent. Probate records say he died 5 Aug 1956 and tie him to Louisa, his widow. Pos. parents of Arthur (from christening record): Edward William Ponting (1870 of Bristol) and Matilda (1870 of Bristol)—possibly Emma Matilda Stevens. **Caution: others exist with name "Arthur Henry Ponting"**

Albert Harry Baker single, footman in 1939 going by "Harry" (29 Mar 1900 of Dover, Kent)

John George Baker (24 Feb 1902 of Dover, Kent—d. pos Apr 1965 at Folkestone, Kent), m. Hilda Gladys Wade (29 Apr 1903 of Lowestoft, Suffolk), 20 Sep 1921. Hilda was the daughter of Christopher Wade (1865 of Mutford, Lowestoft, Suffolk) and Eliza Ann Crickmore (1869 of Lowestoft, Suffolk) who were married Oct-Dec 1889 in Mutford, Suffolk.

Ernest Harry Baker (19 Jan 1923 of Sandgate, Kent--d. 24 June 1971 at Sheffield). In 1939, he was a nurseryman's ass't at age 16.

Violet Eliza Mitchell Baker (20 Dec 1924 Sandgate, Elham, Kent), died as a child in June 1925 in Dover, Kent

Harry Mitchell Baker (1904 of Deal, Kent). Pos d. at age 10 in Oct 1914 at Eastry, Kent

Percy Thomas Baker (15 May 1907 of Deal, Kent--d. May 1985 at Deal, Kent). According to 1939 Register "Percival T" occupation: Church verger. Married Bertha E. E. Parker (3 Jun 1905 of Deal, Kent) Sep 1929 at Eastry, Kent

Mary Pucknell LCXC-L2T (1834 of Tunbridge, Ken), and Joseph Fleet (1833 of Tonbridge), m.
Dec 1853--registered at Tonbridge, Kent.

Note: Mary Pucknell Fleet was a widow at 36 (by 1871 Census). Joseph Fleet died Oct-Dec 1869 registered in Tunbridge Wells, Kent, age 37. Mary died Oct-Dec 1905 in Tonbridge, age 72. Joseph's parents: Joseph Fleet (1804 of Horsted Keynes, Sussex) and Francis _____ (1805 of Tunbridge, Kent) who were married 16 Sep 1917 at Tonbridge, Kent.

Mary Ann Fleet (chr. 9 Mar 1855 at Dorking, Surrey) b. last qtr of 1854 according to the b. index. Single in 1901 Census.

James Fleet, a railway guard, (1856 Tonbridge, Kent—d. Jan 1902 at Reading, Berkshire) m. Emma Hogsflesh (1857 of Worplesdon, Surrey) in the 1st qtr of 1884 at Farnham, Surrey. Emma was christened 22 Mar 1857 at Wyke, Surrey. Her parents: James Hogsflesh (1811 of Worplesdon, Surrey) and Caroline Marshall (1815 of Ash, Surrey). Her brother, George Hogsflesh (1841 of Ash) and his family appear on the 1891 Census as next-door-neighbors to James and Emma Fleet.

Charles Joseph Fleet (1889 of Ash, Surrey) He was baptized 30 Sep 1891 at Ash, Surrey. He was a photographer at the age of 22. Charles married Catherine Mary Pilgrim (1 Sep 1887 of Slough, Buckinghamshire) on 22 Nov 1913 at Neepawa, Manitoba, Canada. He died 7 Nov 1918 in Saskatchewan, Canada at the age of 29 years and 8 months. Her parents were Thomas Henry Pilgrim (Jul 1864 of St. Johns Wood, Middlesex, Eng.—d. 21 Sep 1961 at Neepawa, Manitoba) and Mary Ann Tubey (Jun 1864 of Slough, Buckinghamshire—d. 26 Apr 1956 at Neepawa, Manitoba).

Lydia Frances Fleet (28 Aug 1891 of Ash, Surrey—d. 1972 at Coventry, Warwickshire) She was baptized 30 Sep 1891 at Ash, Surrey. 1939 Register shows her as single living with her mother, Emma. It lists her occupation as "aero magneto driller" and provides her full birth date.

Note: 1911 Census states that Emma Fleet had 3 children and one had died by 1911.

Harriet Frances Fleet (1859 Tonbridge, Kent) m. James Ashby (1859 of Underriver, Kent—1891 says Seal, Kent). James' parents were James Ashby (chr 7 Oct 1810 of Underriver, Kent) and Maria Hitchcock (1815 of Leigh, Kent)

James Ashby (1890 of Underriver, Kent) In 1911 Census he was listed as "horseman on farm" but his mil. service records say he was a policeman. He started in the Veterinary Services but transferred to the Royal Field Artillery with the rank of gunner. His mother, Harriet, is mentioned in his service records. A newspaper article in the 7 Sep 1917 issue of the Sevenoaks Chronicle mentions that his brothers were also in the service.

Anne Fleet (ch. 25 Jun 1865 of Tonbridge, Kent)

Emma Jane Fleet (b. Oct-Dec 1867, ch. 29 Mar 1868 Tonbridge, Kent) m. Frederick Bishop police constable(1863 of Mayfield, Sussex **his christening record shows 9 June 1861--resolve**) 1891 in Tunbridge Wells, Kent. Frederick Bishop had four sons by his first wife, Annie Balcombe (1863 of Steyning, Sussex)

His parents: Henry Bishop (1818 of Mayfield, Sussex) and Phoebe Apps (1817 of Mayfield, Sussex).

Frederick George Bishop (1883 of Ticehurst, Sussex—d. Sep 1905) His obituary says he was a gardener and had been subject to fits (epilepsy) for 7 years. It mentions his father who was a PC, police constable. The coroner's inquest determined he had died of epilepsy at the age of 22.

William Robert Bishop (4 July 1884 of Ticehurst, Sussex) m. Edith Florence May (9 Jan 1891 of Clapham, London—d. 1959) Dec 1918 at Godstone, SS Surrey. They lived in Conn., USA as naturalized citizens (the doc shows his mother as Annie Balcombe.) 1940 Census shows William (55) with wife Edith (49—b. abt 1891 in England). Naturalization record confirms his b. as 4 July 1884 at Ticehurst and shows his arrival date as 1 Dec 1925 at NY, NY with his wife Edith Florence. William had listed his occupation as gardener. At 58, he registered for the draft and listed his residence as Bethel, Fairfield, Connecticut working for Bridgeport Hydraulic Dam Company in Redding, Conn.

Edith's parents: Arthur William May (1864 of Inkpen, Berkshire—d. Dec 1950) and Elizabeth Druce (Oct 1865 of Notting Hill, Middlesex—d. Mar 1938 at Surrey, England). Death records indicate that they died in England and were buried in Lingfield, Surrey but it needs to be verified. I know of one trip they made: they returned from England on the ship Majestic out of Southampton. They sailed on 27 Sep 1933. Visas had been issued on 20 Jun 1933. They arrived 5 Aug 1933.

Note: Ancestry profile suggests, and it appears to be correct, that Edith was married to a Frank William Chapman who passed away three years after they were married (m. 13 Sep 1913 at Lingfield, Surrey). If a banns record were found I believe it would show that she was a widow, not a spinster when William Robert Bishop married her.

Notes: Annie Balcombe passed away Jan-Mar 1890 at Tonbridge, Kent. Frederick Bishop then married Emma Jane Fleet (1867 of Tonbridge, Kent) in 1891 at Tunbridge Wells, Kent. According to the 1911 Census, Emma had 8 live births, three of whom had died by 1911 (I only have 7 out of the eight.).

Lance Corporal in the 13th Middlesex Infantry. Wounded in the thigh and elbow on 22 June 1917 in France—discharged. Res. Chapel Cross Cottage in Heathfield, Sussex. Lilian's father: Jonathan Barton (1863 of Herstmonceux, Sussex) m. Mary Downer 2Q 1889 at Hasting, Sussex. Mary Barton, a laundress, lived next door and is most likely Lilian's widowed mother (b. 9 May 1865). Lilian had two brothers, Henry Bishop 1892 of Heathfield and Benjamin Bishop 1893 of Heathfield. Percy's younger brother, Frank J., an Ag. Laborer, was living with them in 1939.

Margery (Marjorie in 1939) Joan Hendley (19 Mar 1925 of Hailsham, Sussex) pos. spouse: Fairway

Cecil Jack Bishop (1906 of Capel, Kent) ("Cecil" acc to 1911 Census) Later lived at St. Dunstons Farm, Heathfield, Sussex. Pos sp: Ivy Ellen Wood (22 Feb 1905 of Oxted, Surrey) Dec 1926 at Godstone, Surrey. Her parents: Thomas John Wood, laborer, (about 1872 of Knockholt, Kent) and Harriet Rebecca Wells (Oct 1879 of Oxted, Surrey)...chr. 19 Mar 1905 at Oxted, Surrey.

Marriage index evidence suggests he was married to Ivy but there needs to be some corroborating evidence. 1939 Register suggests a "Nellie"

Census: Mary Fleet , 56 year old widow and servant with her inferred daughter, Beatrice Fleet a 15 year old servant.

1901 Census (Kent, Tonbridge, Dist. 05) shows Mary Fleet (W) 66; Mary Ann Fleet 46, S, Dau; and Beatrice E. Fleet 25, S, Dau. Middle initial stands for Eugenia.

1911 Census: Beatrice was single, age 35 and a general servant

Not sure of father...Joseph Fleet had died in 1869. "Others searching" page in Ancestry lists baptism as 16 Mar 1876 in Tonbridge and makes comment, "No father listed." I haven't found the actual christening record yet. She pos. m. Ernest A. Hicks (21 Dec 1871) in Apr 1912 at Tonbridge.

Jesse Pucknell ag. Laborer in 1881 at Tonbridge (1843 Tunbridge, Kent) Alt. spelling: Jessey (1851 Census) His spouse was Rosa Davidson Elphick (1844 of Hadlow) m. Oct 1864. Rosa's parents were William Elphick (1806 of Hadlow) and Jane Mosley (1804 of Tenterden, Kent/d. abt May 1875 at Royal Tunbridge Wells, Kent). (Davidson appears as Davison on m. index). At age 59, Jesse Pucknell married a widow named Sarah Ann Struckett (1843 of Hinxhill, Kent) m. 1902, Kent. She married her first husband, Henry James Struckett (19 Apr 1845 of Dover) on 13 Feb 1866 at Dover, Kent. He died in 1893. Her maiden name was Sarah Ann Post.

Her parents were George Post (abt 1817 of Willisborough, Kent) and Harriet Lenard (1811 of Lenham, Kent) Henry was a grocer's assistant in 1871 and a grocer in 1891. Emily's parents: James Richardson (1855 of Hildenborough, Kent) and Ellen Agnes Baker (1867 of Crockham Hill, Kent) who married on 22 Apr 1888 at Chevening, Kent. Emily's sibs: Ellen Agnes (1889 of Sevenoaks), Thomas James (1893 of Edenbridge, Kent), William George (1896 of Edenbridge, Kent) and Daisy Annie (1902 of Crockham Hill). Sibs: Florence (1890 of Ramsgate), William (1892 of Ramsgate), Percy (1897 of Ramsgate) and Albert (1901 of Ramsgate). 1891 Census says William Hadaway had a stepson, George Southgate (1882 of Woolwich, Kent), which indicates Maria Ann was married previously to a Southgate... Possibly Henry Southgate(1850 of Old Newton, Suffolk) who also had a son named Douglas Henry Southgate who was 4/12 of Woolwich, Kent in the 1881 Census. **Marriage doc exists for Henry Southgate, a coachman, and Mary Ann Simmons in July 1877 at Middlesex, Eng.**

Kingston, Surrey, 1890/chr 16 Dec 1890 at Wimbledon, Surrey) in 1929 at Thanet, Kent. Her parents: William Bennett (1846 of Milton, Oxfordshire, Eng.) and Amy Stickalls (1855? of Addington, Kent). Amy (Stickalls) Bennett, 73, was living in the same household as her dau and son-in-law in 1939. **I believe Doris Amy Bennett Crundwell's birth date given in the 1939 Register is incorrect. It is listed as 7 Mar 1903. All other documentation indicates that her birth was in 1890. Note: See if George served in the military.**

See her profile p. for her sibling info. **Caution: Ancestry supplies info on a Mary Ann Peerless that was born 1875 in Rotherfield, Sussex. Our Mary Ann was born in Hadlow—verified by 1911 Census.**

Minnie Bone (28 Jul 1896 of Tonbridge, Kent—d. 1st Q 1980 regis. at Tunbridge Wells, Kent). She was single at age 43.

John George Bone motor tractor driver in 1911 (1867 of Tonbridge, Kent—d. 1929 Tonbridge) m. Elizabeth Emily Brotherwood (1870 of Carshalton, Surrey) 7 Aug 1893 in Newington, Surrey. Her parents were George Brotherwood(1841 of Capel, Kent) and Emma Graham (1835 of Carshalton, Surrey). George Brotherwood's parents were Stephen Brotherwood and Charlotte Wheeler

Ethel Elizabeth Bone (1 Oct 1894 of Tonbridge—d. 2Q 1978 at Tonbridge).

Cecil John Bone (1895 of Tonbridge). He died 25 Oct 1915 at the age of 19 at Gallipoli. He was a young soldier who drowned in a tragic accident where his transport ship collided with another allied vessel.

Ivy May Bone (30 Apr 1897 of Tonbridge) m. Walter Henry William Pentecost house painter, (1896 of Southborough, Kent—d. Jun 1973 at Tonbridge, Kent). His parents: Walter Henry Pentecost bus driver in 1901 at Tonbridge (8 Aug 1870 of Wivelsfield, Sussex—says Horsham in 1901 census) and Elizabeth Rebecca Crossland (abt 1869 of Southborough, Kent—1901 census says Tunbridge Wells). His sibs: Frederick Spencer Pentecost (1898of Southborough) and Lizzie/Elizabeth Pentecost (1900 of Southborough)

His parents were Matthew Biddle (1838 of Hendon, Middlesex) and Sarah Ollington (1838 of Shadwell, Norfolk) who were m. 22 Apr 1863 at Stepney, London. Sarah's father was William Ollington.

Albert Edward Biddle, butcher, (24 May 1900 of Tonbridge—d. 1972 at Battle, Sussex), m. Bessie May Mepham (12 Feb 1901 of Wadhurst, Sussex) 1925 in Tonbridge. Her parents were Albert Mepham railway platelayer in 1911 at Tonbridge (1877 of Wadhurst) and Ellen Mary Groombridge (1882 of Wadhurst). They were m. in 1900-01. Bessie's sibs: Albert Edwin Mepham (1903), Ellen Frances Mepham (1906), Dorothy Edith Mepham (1911) all of Wadhurst except Dorothy who was of Tonbridge, Kent.

Mildred Annie Biddle (13 May 1902 of Tonbridge pos d: at age 85, 1987 at Tunbridge, Wells, Kent), m. Lionel Arthur Ashdown/Arthur Lionel Ashdown, bricklayer (11 Jan 1907 of Tonbridge—d. 8 Feb 1992 at Tonbridge) Apr 1933 at Tonbridge, Kent. His parents were Roland Ashdown (13 Oct 1875 of Tonbridge—d. 26 Dec 1958 at Tonbridge) and Emily Ruth Morley (7 Aug 1876 of Tonbridge, Kent—d. 1946 at Tonbridge) who married 1900 at Tonbridge. His sibs (all of Tonbridge): Roland Richard 1901, William Thomas 1903, and Dorothy Emily 1905.

Edith Mary Biddle (10 June 1904 of Tonbridge) m. Cecil Albert Lowthorpe, fish and poultry dealer's manager (b. registered 27 Jun 1903 at Hastings, Sussex—d. Jul 1968 at Thanet, Kent) third qtr 1930 at Tonbridge. Couple lived at Margate, Kent in 1939. Cecil's parents: Arthur Lowthorpe (1870 of Hessle, Yorkshire) and Harriet (1867 of Dallington, Sussex). Her parents were Alfred James Pethurst house painter (1855 of Tunbridge—d. Dec 1928 at Tonbridge) and Annie Sophia Card (1847 of Capel, Kent) who were m. 17 Feb 1874 at Marden or Maidstone, Kent). Eleanor's sibs: Beatrice (1875 of Tonbridge), Elizabeth M. (1877), George Henery (1879), Alfred James Caldas (27 Mar 1880—d. 1968 at Tonbridge), William Thomas (1887).

Annie Clara Bone (4 Nov 1909 of Tonbridge, Kent—d. 1996 at Camborne, Cornwall, Eng.) m. Ivo John W Swaisland (31 Mar 1912 of Eastborne, Sussex, Eng.—d. Apr 1995 at Camborne-Redruth, Cornwall, Eng.). His parents were John Swaisland SS (1889 of Kemsing, Kent) and Rose Williams (1886 of Tonbridge, Kent). His sister, Dorothy M. Swaisland E (19 May 1909), m. Alfred Crook E (1 Apr 1906 of Dalston, London) 3rd quarter of 1932 at Tonbridge.

Nellie May Bone (23 Feb 1911 of Tonbridge, Kent—d. 22 Oct 1981 at Fair Oak, Hampshire, Eng.) m. Henry G. Stratford (21 May 1911) Jul 1936 at Tonbridge, Kent)

Lilian Bone (9 Dec 1915 of Tonbridge) appears in 1939 Register with m. name of Bashford (William C. Bashford) m. in 1941

Sidney Charles Bone (9 Oct 1879 Tonbridge, Kent—d. 9 Oct 1971 at Battle, Sussex, Eng.) m. Louisa Noakes (13 Jan 1881 of Newhaven, Sussex) during 2nd qtr of 1907, regis at Newhaven, Sussex. Her parents: Edward Noakes (1857 of Brighton, Sussex) and Louisa Beal (26 Dec 1856 of Seaford, Sussex).

Roy Stuart Bone (1910 of Leytonstone, Essex-- d. Apr-Jun 1987 Lewes, Sussex)

Clara Maria Bone (1882 Tonbridge, Kent), m. Herbert C. Dolding (1881 of Tonbridge) in Apr-Jun 1916 at Tonbridge. The 1911 Census shows Clara's 68 year old widowed mother Fanny Barden (1843) living with Clara who was 28 and single. Herbert's parents were Henry Dolding (1856 of Tudeley, Kent,--d. prior to 1911) and Sarah Bennett (1857 of Tonbridge).

Note: 1911 Census shows Fanny's signature showing the preferred spelling of her married name as "Bone"—not with an "s" on the end as shown elsewhere.

George Henry Barden, a grocer warehouse man, (1874 of Wrotham, Kent—1901 Census says Tonbridge—d. 1945 at Tonbridge) m. Annie Eliza May (1876 of Tonbridge) Oct-Dec 1898 at Tunbridge Wells. **Pos parents** John and Harriet May

Horace Sidney Barden (Apr-Jun 1876 of Wrotham, Kent) (1881 and 1911 Censuses say Dunks Green, Kent) m. Sarah Ann Vanns (1872 of Goldengreen, Kent) 9 Apr 1904 at Hildenborough, Kent (see Army records). Horace was christened 25 May 1876 at Plaxtol, Kent. **Pos** d. Mar 1940 at age 68 in the registration district of Sevenoaks. Sarah's parents were James Vannes (1831 of Hadlow) and Susan Butcher (1830 of Hartfield, Sussex —d. 1895) At (80) the widower, James was living in the home in 1911.

Emily Madge Barden (26 Sep 1905 of Hildenborough) m. Albert Charles Drury (22 July 1901 of Hildenborough, Kent) in the 2nd quarter of 1928 at Tonbridge. His parents: Charles Drury (1881 of Wrotham) and Harriett (1870 of Billingshurst, Sussex).

Arthur Edward Barden (1878 of Wrotham, Kent) (1881 Census says Dunks Green, Kent) m. Florence Mary Payne (1878 of Hadlow) Oct-Dec 1909, Malling, Kent (**her parents?**)

Ernest Barden (Oct-Dec 1880 of Hildenborough, Kent, see 1881 Census), d. Apr-Jun 1882 Tunbridge Wells, Kent. Died as a child.

Constance Louisa Barden (1883 of Hildenborough Kent), m. James William Meppem, a woodreeve or woodman (1881 of Tonbridge) Oct-Dec 1910 Tonbridge, Kent . His parents: James William Meppem (1854 of Ewhurst, Sussex) and Mary Jane Crouch (1858 of Ewhurst) who were married 25 Dec 1870 at Hildenborough, Kent. Mary Jane Crouch's father was William according to her marriage document.

Vanns (1857 of Hildenborough), niece of Horace Sidney Barden (1876 of Wrotham, Kent). She was the sister of Sarah Ann Vanns. Ann's parents were both of Hadlow Parish and were married between Dec 1877 and Jan 1878 acc. to parish records.

Irene Hilda Mary Barden (Jul-Sep 1899 of Tonbridge—d. 1st qtr 1951) m. John Patrick O'Donnell (1891 of Mimico, Toronto, Ontario, Canada—d. 1956) 1918 at Tonbridge. John's pos. parents (see service record) Thomas and Catherine O'Donnell of Harold St., Mimico, Ontario, Canada. FamilySearch lists his parents as James O'Donnell and Mary Jennings.

Patti O'Donnell (b. Canada—d. 2018)

Enid Harriett Barden (11 Jul 1900 of Tonbridge—d. Jan 1993 at Chichester, Sussex) m. Sidney Norton, a boat builder (8 Oct 1899 of Greenwich, Kent—d. 22 Mar 1983 at Maidstone, Kent) 2nd qtr of 1926 at Tonbridge. Sidney's parents: Albert Norton (boat builder, 1863 of Tonbridge—d. 1952 at Tonbridge) and Ellen Louisa Robinson (1865 of Strood—d. 1937) sib: Ellen 1895 Greenwich, Kent. Sidney's brother, Albert Norton 1888 of Chatham Town, Kent)

Velda Enid Mary Norton (1927 of Tonbridge—d. 2019)

George Austin Barden wireless salesman (28 Nov 1901 of Tonbridge—d. 1972 at Hastings, Sussex). Inferred sp. From 1939 Register: Valda Flora Grant (b. 5 Jun 1906) and their inferred son **John A E Barden** (29 May 1934).

Marjorie Beatrice Barden (14 Jan 1903 of Tonbridge) m. George Victor Latter, police constable, (4 Apr 1902 of Tunbridge Wells) 1927 at Tonbridge

Edna May Barden (8 May 1905 of Tonbridge—d. 14 July 1980 at Uckfield, Sussex) m. Spencer R. Maddison (28 Apr 1904) Oct 1937 at Tonbridge. 1939 Register shows Edna's birth as 8 May 1906 which conflicts with the birth registration. Spencer's occupation in 1939 was a "salesman, wholesale warehouse, glove department." Some confusion exists about Spencer's birth year. **A notation in the 1939 Regis. changes his birth year from 1908 to 1904. A birth registration of a Spencer Russell Maddison exists for 1908.**

Ida Phyllis Barden (2 Oct 1906 of Tonbridge—d. Jul 1988 Tunbridge Wells, Kent)

William and Ellen Barden had three children in the 1881 Census, namely, George 1870, Emily 1873 and Alice 1876—all born in Tonbridge.

The 1881 Census shows John working as a porter in the Farmer household. Emily R. Farmer (1857) is a 23 yr old “book sewer”. I believe they married as evidenced by the 1891 Census (despite the misspelled surname--Barabin). 1911 Census states that they had no children (they were in their fifties). Her father was Samuel Farmer (11 Jul 1809 of Welshpool, Montgomeryshire, Wales—d. prior to 1871 Census). Emily's mother was Elizabeth Farmer (married name) 1815 of St. Justs, Cornwall, Eng., a widow in 1881.

The following notes pertain to William Barden (1814):

Sarah Holder married Charles John Saxby (b. 1820 of Woolwich, Kent) the third quarter of 1851 at Saint Lawrence, Winchester, Hampshire, England and had the following children:

George T. Saxby (1855 of Oxon, Oxfordshire) 1871 Census comment: “Idiot for nine years”; 1881, 1901 and 1911 Censuses show him as an inmate in a workhouse.

Naomi Kate Saxby (1858 of Tonbridge, Kent)

Sarah Saxby (1861 of Tunbridge Wells, Kent)

Charles passed away in the first quarter of 1862 in Tunbridge Wells, Kent. Sarah Holder Saxby married William Barden, a widower, in the third quarter of 1863. William Barden (1814 of Hadlow, Kent, England) had previously been married to Sarah Rabbit (1812 of Hadlow—d. in 1856 at Tonbridge, Kent). The above children were listed as William Barden's stepchildren in the 1871 Census. The same census shows that William Barden and Sarah Saxby Barden had had four children: (I believe they had a daughter named Emma that was born in 1863—the same year as their marriage. He was christened on 19 Feb 1899 and his parents' names are listed as Alfred and Emma Bent. His birth date is also on that document as 20 Dec 1898. Alfred's occupation was locomotive driver in Southall. Emma's pos. maiden name was Wallis. A marriage document exists in Ancestry of Alfred Bent marrying Emma Wallis in the 3rd Quarter of 1898 at Uxbridge, Middlesex, England. Identified by his birth date, Frederick died Apr 1971 at Hillington, Greater London. Frederick had a brother named George Henry Bent (1900 of Southall, Middlesex) as seen in the 1911 Census. According to his christening record, he was born 5 Mar 1900 and christened 3 Jun 1900 at Ealing, St. John, Southall. In Sep 1922 he married Winifred Wilks, daughter of Wilks, a deceased green grocer. At the time of the m. George was a railroad employee. The 1939 Register shows George as a Railway Guard and his b. as 5 Mar 1900. Appendix

Additional information on the siblings of Charles John Stuart

According to the 1911 Census for his parents, Charles was one of four children born to Charles Henry and Ann Mary Stuart. We know his two brothers, James Henry Stuart and Edward Joseph Stuart, but are searching for his other sibling.

James H. Stuart is listed in the 1881 census as a one year old child. He would have been 11 in the 1891 census but, for some reason, does not appear with the family. He is listed in 1901 as James H. (21) as a boiler maker laborer having been born at Deptford, Kent. The 1911 census lists him by his full name, James Henry Stuart (31) and states his occupation as “blacksmith striker” and his birth place as Deptford.

Edward Joseph Stuart (1883 of Greenwich) was christened on 21 Feb 1883 at Greenwich, London. His marriage document gives his residence as 179 High Street and states that his father was Charles Henry Stuart, an engineer. Edward married Mary Elizabeth Gillespie (1883 of Deptford, Kent) 2 April 1905 at Greenwich, Deptford, London (St. Nicolas Parish). Mary’s father was William Roger Gillespie, also an engineer. The witness’ name was Bertha Gillespie—not certain of her relationship to Mary. Their children, according to the 1911 census (with estimated birth years):
