

Will of Anna DUPLOCK, Spinster of Bexhill

Made: 21st July 1840 Proved: 26th June 1843 at London

I Anna DUPLOCK Spinster of Bexhill in the County of Sussex do make this my last Will and Testament I give and bequeath to my sister **Mary Waite Wife of William Waite** of Boreham Street in the parish of Wartling Sussex during the term of her natural life the interest of all the monies I may be in possession of at the time of my decease in the public funds or elsewhere and on her decease I give and bequeath all the monies I may possess of in the public funds or elsewhere at the time of my decease to my nephew and nieces **George Duplock Waite Elizabeth Anna Waite and Mary Ann Waite** or the survivors of them to be among them equally divided I give and bequeath to my niece **Elizabeth Anna Waite** two silver table spoons and silver fan handle tea spoons I give and bequeath the rest of my plate all my linen furniture clothes and other property to the said Nephew and Nieces to be equally divided among them and I hereby appoint and constitute to **William Gray** a Lieutenant in the Royal Navy and **Charlotte Day** Spinster both of Ramsgate Kent joint Executors of this my last Will and Testament to which I have set my hand and seal this 21st day of July 1840 Anna DUPLOCK (LS)

Appeared Personally **James Ockenden** Grocer of the parish of Bexhill in the County of Sussex and made Oath that he is one of the subscribed Witnesses to the last Will and Testament hereunto annexed of **Anna Duplock** late of Bexhill in the County of Sussex Spinster deceased bearing date the twenty first day of July one thousand eight hundred and forty and with reference to the execution of the said will he the deponent further saith that on the said twenty first day of July one thousand eight hundred and forty the said testatrix signed her name to the said Will and at the foot or and thereof in the presence of this deponent and of **Edward Barnard** his fellow subscribed witness both of whom were then present with the said Testatrix at the same time and thereupon this deponent and his said fellow witness subscribed their names as Witnesses to the said Will in the presence of the said testatrix and prior to the execution of the said Will as aforesaid the word July was interlined in the date as now appears and the said Will when so executed was as it now is contained in the two sides of the sheet on which the same is written
