

Davy Duplock, husbandman of East Grinstead 1833

PBT 1/1/80/60

Will made 18th April 1833, probate 28th February 1839

This is the last Will and Testament of me Davy Diplock of East Grinstead in the County of Sussex Husbandman First I will order and direct that all my just debts Funeral and Testamentary Expenses be fully paid by my Executrix and Executor hereafter named as soon as conveniently may be after my decease And I give and bequeath unto my **Son John Diplock** Five pounds to be paid him within six months after my decease by my Executrix and Executor hereafter named Also I give devise and bequeath unto my **Daughter Mary Diplock** and my **Grandson William Diplock** now living with me the natural Son of my **Daughter Dinah Barker** deceased All that my Copyhold Messuage or Tenement Buildings Garden Orchard Lands Hereditaments and Premises with the appurtenances situate lying and being on Ashurst Wood Common in the Parish of East Grinstead aforesaid To hold the said Copyhold Messuage or Tenement Buildings Garden Orchard Lands Hereditaments and Premises with the appurtenances unto my said **Daughter Mary Diplock** and my said **Grandson William Diplock** and their Heirs and Assigns for ever as Tenants in common and not as joint Tenants Also I give and bequeath all my ready money Securities for money and all other my personal Estate and Effects of what nature or kind soever and wheresoever the same may be unto my said **Daughter Mary Diplock** and my said **Grandson William Diplock** and their Executors Administrators and Assigns in equal shares and distributions And Lastly I do make constitute and appoint my said **Daughter Mary Diplock** and my said **Grandson William Diplock** Executors of this my last Will and Testament And I further revoke all former wills by me made and do declare this only to be and contain my last Will and Testament In Witness whereof I the said Davy Diplock the Testator have to this my last Will and Testament contained in Two sheets of paper to each sheet set my hand by my Mark and also to this second sheet affixed my Seal the Eighteenth day of April in the year of our Lord one thousand eight hundred and thirty three

Signed sealed published and declared by the said Davy Duplock the Testator in the presence of us who in his presence at his request and in the presence of each other have hereunto subscribed our hands as witnesses The same having been first read over to him the said Davy Diplock who perfectly understood the intent and meaning thereof
