This is the last Will and Testament of me Michael Hayward of Street End in the Parish of Heathfield in the County of Sussex (late Farmer) made this fourteenth day of April one thousand eight hundred and fifty three I give bequeath and devise to Samuel Hayward Senior and his son Samuel Hayward Junior (my nephew) Higgler of Punnetts Town in the Parish of Heathfield whom I appoint my Executors all and every of my Freehold Farm Messuages or Tenements, Cottages, Buildings, Lands and Hereditaments situated and called part of Morrissis Town, (or Fox Hole) Lands in Heathfield aforesaid, and all other my real estate to hold the same in trust, for the benefit of my Daughter Mary Hayward and her four Children, Ann Mary Maynard Hayward, Caroline Hayward, Emmila Hayward and Fanny Hayward, and that they my Executors shall as soon as convenient after my decease sell and dispose of my Freehold Farm, Messuages, Tenements, Cottages, Buildings, Lands and Hereditaments and pay from the proceeds of such sale all my just debts and funeral expenses with such expense as shall have occurred in the sale and transfer of such my property above stated, as well as all reasonable expenses and charges, that my executors above named may have incurred in fulfilling this my last request, and to pay the residue after all such expenses above named shall be paid – first to my Daughter Mary Hayward the sum of ten pounds, next to her Daughter Ann Mary Maynard Hayward ten pounds, to her Daughter Caroline Hayward ten pounds, to her Daughter Emmila Hayward ten pounds and her Daughter Fanny Hayward ten pounds, and also to my Grandson John Cook son of Fanny Cook who was Wife of my Son Michael Hayward and which said John Cook was borned at Penhurst in the County of Sussex, previous to their marriage the sum of ten pounds, and the remainder of the proceeds of such sale of this my Freehold Estate after all expenses are paid to be divided betwixt my **Daughter Mary Hayward** and her four children above named, share and share alike And I do hereby declare this only to be my last Will and Testament, In witness whereof I the Testator have to this my last Will and Testament in this sheet of paper set my hand and seal the day and year first above written
