

Richard Young, yeoman of Pembury 1813

PROB 11/1570/760

Will made 4th May 1813, probate 30th August 1815

This is the last Will and Testament of me Richard Young of the Parish of Pembury in the County of Kent Yeoman made this fourth day of May in the Year of our Lord One thousand eight hundred and thirteen First I give and bequeath unto my respected Friends **Richard Jones** of Frant in the County of Sussex Gentleman and **Thomas Woodhams** of the Parish of Pembury in the County of Kent Yeoman all my personal Estate and Effects whatsoever & wheresoever & of what nature kind or quality the same may be To hold to them the said **Richard Jones** and **Thomas Woodhams** & the Survivor of them his Executors and Administrators upon trust that they my said Trustees or the Survivor of them his Executors or Administrators do & shall as soon as conveniently may be after my decease collect & get in all Sum & Sums of money that may be due & owing to me from any person or persons whomsoever whether the same shall have been lent out on Security of Freehold property or otherwise and thereout pay satisfy & discharge all my Just debts Funeral and Testamentary Expenses & the Charges of proving this my Will and from & after the payment & satisfaction thereof I do hereby give & bequeath to my **Grandson Richard Young** of the Parish of Tunbridge in the County of Kent Laborer the Sum of Fifty pounds to my **Grandson David Young** of the same Parish Laborer the Sum of Fifty pounds To **Ann Comber** the Wife of **Richard Comber** of Walworth in the County of Surry Carpenter the Sum of One hundred pounds To **Hannah Massee** the Wife of **John Massee** of Chiselhurst in the County of Kent Gardener the Sum of Fifty pounds To my **Grandson Stephen Dorman** now residing in some part of London Laborer the Sum of Twenty five pounds To **Mary Young** the widow of **Matthias Young** of Merworth in the County of Kent the Sum of Ten pounds And to my **Granddaughter Ann Young** the daughter of the said **Matthias Young** deceased the Sum of Twenty pounds which said respective Legacies I do hereby direct shall be paid by my said Trustees or the Survivor of them his Executors or Administrators to the respective Legatees within the space of Eight Calendar months next after my decease but without Interest And as to all the rest residue & remainder of my Personal Estate and Effects or the money arising therefrom and also all my real Estate whatsoever & wheresoever I give devise and bequeath the same and every part thereof unto the use and behoof of **Martha Mason** the Wife of **William Mason** of Tonbridge in the County of Kent Laborer her heirs Executors Administrators and Assigns absolutely I do hereby nominate and appoint the said **Richard Jones** and **Thomas Woodhams** Executors of this my Will And lastly I do hereby revoke and

make void all other wills by me heretofore made and declare this only to be my last Will and Testament In witness whereof I the said Richard Young the Testator have to this my last Will and Testament contained in two sheets of paper set my hand and seal to the top of the first sheet where the same are fixed together and my hand at the bottom thereof and my hand & seal to this last sheet the day & year first before written

I Richard Young of the Parish of Tonbridge in the County of Kent being at this present [time] of sound mind the better to discharge my conscience do hereby will and bequeath to my **Granddaughter Sarah Callard** the Sum of twenty pounds to be paid at the same time and in like manner by my Executors **Richard Jones** Gentleman of Tonbridge Wells and **Thomas Woodhams** Yeoman of the Parish of Pembury as is directed in my Will bearing date the fourth day of May One thousand eight hundred and thirteen as the Legacies therein specified to be paid any thing therein mentioned to the contrary notwithstanding And I do hereby declare the above to be a Codicil to my last Will and Testament bearing date as above In witness whereof I hereunto set my hand this ninth day of November One thousand eight hundred and thirteen
